In this my Will the expression "my Trustees" shall include the Trustees for the time being hereof

I GIVE all my real and personal property whatsoever and wheresoever (including any property over which I may have a general power of appointment or disposition by Will) to my Trustees UPON TRUST to sell call in and convert the same into money with power to postpone such sale calling in and conversion for so long as they shall in their absolute discretion think fit without being liable for loss

MY Trustees shall out of the monies to arise from the sale calling in and conversion of or forming part of my Estate pay my debts funeral and testamentary expenses and legacies and all Inheritance Tax payable in respect of my Estate and shall invest the residue of such monies in any investments of a nature hereby authorised with power from time to time to vary investments for others of an authorised nature and shall stand possessed of such investments and of all parts of my Estate for the time being remaining unsold and any ready money (hereinafter called my Residuary Estate) upon the trusts hereinafter declared concerning the same

MONIES comprised in my Residuary Estate may be invested or applied in the purchase of or at interest upon the security of such stocks funds shares securities or other investments or property of whatsoever nature and wheresoever situated and whether producing income or not (including the purchase or improvement of landed property anywhere in the world for use as a residence) and whether involving liability or not or upon such personal credit with or without security as my Trustees may in their absolute discretion think fit to the intent that my Trustees shall have the same full and unrestricted powers of investing and varying investments in all respects as if they were absolutely and beneficially entitled thereto including to qualify for capital tax business asset relief

THE power of appropriation conferred by Section 41 of the Administration of Estates Act 1925 shall be exercisable by my Trustees without any of the consents made requisite by that Act

ANY Executor or Trustee of my Will being a person engaged in any profession or business shall be entitled to charge and be paid all usual professional or proper charges for business transacted time expended and acts done by him or any partner of his in connection with the Trusts hereof including acts which an Executor or Trustee not being in any profession or business could have done personally

I hope that disclosing this Will helps to get Corruption Remedies during my life time.

I give my Residuary Estate to the Residuary Beneficiaries in Equal Shares on the Corruption Remedy Conditions that 1 They make Full Disclosure of everything they have that enables Fully Informed Decisions for Case Management of the Corruption Remedy Claims + 2. They give Full Co-operation for Case Management of the Corruption Remedy Claims by the Executors + 3. They give Full Co-operation with Voluntary Remedies for any acts or omissions by them that caused or contributed to Corruption Damage, or denied or delayed Earlier Remedies + 4 They accept the Immunity Deals made by the Executors to get Full Co-operation.

The Residuary Beneficiaries are the four people I brought up as my children who provide DNA Blood Child Proof to the satisfaction of my Executors. In the event of any of them dying before me or before providing the DNA Proof the share shall pass to the children or remoter issue of that person through all degrees in equal shares conditional upon DNA Blood Issue Proof. DNA Proof Refusals get Share Forfeits + Share Increases for Providers against Refusers.

The Executor shall have the power to distribute up to half the Residuary Estate to the Residuary Beneficiaries who satisfy the Corruption Remedy Conditions and keep the remainder to service the Corruption Claim Costs.

If All DNA Proof is Issue Rebuttal Proof, then the Executors can grant a DNA Proof Waiver to my son Aman Sood. He is a Good Son and DNA Proof is not perfect and DNA Proof Burden Equality might keep Sibling Relations for him.
