Corruption Complaint + Protection Reasons

In 2004, Equity Lawyer Mr Edward Ellis got Criminal Conspiracy Proof against European leaders including Prime Minister Mr Blair. It enabled Queen Elizabeth to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. The Equity Lawyers provided Investigation Services for the Remedy Process. He recruited Citizens used their cases for Integrity Tests of the Authorities and got Proof Sets that met the Corruption Remedy Proof Standard. It is Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. Corruption Remedy Standard Process is Dismissal Executions against Top Judges by a United Parliament, Victim Identification, Case Remedies and an International Agreement for Remedy Enforcement against Fraud Profiteers. Unity Denial Frauds by Parliament created the need for a Special Process. It needed Fraud Proof got by the Citizen and Equity Lawyer that validated Fraud Findings against the Judiciary Alone by the Parliament Sessions Court, Exposure Publicity by Parliament, use of it to get an International Agreement for Remedy Enforcement against Fraud Profiteers, Damage Payments from Fraud Profiteers that enable Industrial Scale Corruption Remedies and Scandal Exposure that increases the MP Retirement Rate and enables a General Election to get a Power Transfer from a Corrupt Governing Majority to a New Governing Majority. From 2018 to 2023 Case Management Authorities from Citizen Mr David Barr enabled Equity Lawyer Mr Ellis to get a Complete Set of Corruption Proof against the State and Remedy Denial Proof against the Law Courts in Northern Ireland. In May 2023 he got completion of the Proof Set against English Judges that got the International Agreement for Remedy Enforcement.

The Northern Ireland Violent History + Corruption Remedy Certainty against Top State Officers and Law Court Judges are a Murder Victim Risk for Citizen Mr Barr. He fled from Northern Ireland via England to Spain. He has the Physical Disabilities of Lung Problems + Spine Problems + Digestion Problems. He has the Communication Disadvantage of Severe Dyslexia + Limited Communication Skills in English + None in Spanish. The High Living Costs of the Tourist Areas force him use Low Living Cost Areas with Very Few English Speakers. He needs Travel Costs. He does not have Printing + Scanning Facilities or the Communication Skills to get a print of this document to sign, scan and email. It forces reliance on the Equity Lawyer
