Framing Fraud Trial 2023 0058 Contempt Remedy Application of Citizen Mr Nkrumah for:

1. A Conflict Disqualification Finding for Citizen Mr Nkrumah against Investigator, Prosecutor, Cross Examination Appointee for the Reasons that:
 - 1.1. The Event Video Records are Contact Avoidance + Innocence Evidence for the Citizen against the State
 - 1.2. The Innocence Evidence Concealment is Fraud Conspiracy Proof against the Investigators and Prosecutors
 - 1.3. The Video Productions Orders got Order Breach Contempt Proof against the Investigators and Prosecutors
 - 1.4. The Order Breach Contempt Remedy Failure + Fraud Conspiracy Cross Examination Restraint + Cross Examination Agent Appointment is got Contempt Immunity Fraud Proof against the Crown Court
 - 1.5. The Cross Examination Plan Enquiries by Citizen Mr Nkrumah got Plan Disclosure Failures by the Cross Examination Agent and a Profession Unfitness Complaint by Citizen Mr Nkrumah that is a Conflict Disqualification against the Cross Examination Agent
2. A Case Dismissal Order + Contempt Investigation Order for the Citizen against the State
3. A Fraud Finding + Proof Burden Reversal Entitlement Finding + Fraud Presumption of everything subject to Rebuttal Proof Positive for Citizen Mr Nkrumah against the State
4. A Mandatory Case Transfer from the Crown Prosecutor to the Director of Public Prosecutions
5. An Investigation Resource Refence to the Cabinet
6. Special Notice for the Citizen against the State that:
 - 6.1. The Coronation Oath Enforcement Authority are managing a Corruption Remedy Process
 - 6.2. It has reached the Remedy Delivery Stage.
 - 6.3. It requires Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies, an International Agreement for Remedy Enforcement against Fraud Profiteers and Remedy Co-operation Test Cases of Sovereign States
 - 6.4. Test Cases got Remedy Co-operation Proof for Sovereign States that is evidenced by Damage Payments from Fraud Profiteers that financed the Post Office Scandal and Health Scandals
 - 6.5. The Test Cases are investigating the conditions needed to get Voluntary Remedies by Sovereign States
 - 6.6. The Frauds Conspiracy Proof for Citizen Mr Nkrumah against the UK Judiciary is Relevant Evidence for the Dismissal Executions against the Judiciary
 - 6.7. The Dismissal Executions against the UK Judiciary will be a Remedy Precedent for others
