- 2. Case Conflict Discovery Order for the Claimant against the Defendants that they do, acting by the Attorney General, within 7 days file and serve a Statement that discloses whether they admit deny or require proof the
 - 2.1. Coronation Oath Enforcement Authority has Corruption Remedy Jurisdictions that govern Parliament Session Powers
 - 2.2. The Parliament Session Powers enable the Coronation Oath Enforcement Authority to manage the Profession Authority responsibilities of Parliament
 - 2.3. Top Corruption Proof created the need for Fitness Investigations of All Authorities with Remedy Powers
 - 2.4. Remedy Delivery needs Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement for Remedy Enforcement against Fraud Profiteers.
 - 2.5. The Dismissal Executions need Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds.
 - 2.6. The Personal Responsibility Proof is Case Management Proof against Supervision Judges and Hearing Electronic Record Proof against the Participants
 - 2.7. The Remedy Process uses cases for Remedy Co-operation Tests of whoever has Remedy Powers
 - 2.8. The Colonial Governance Claim and Current Governance Claim enables Remedy Co-operation Tests of the Defendants, UK Law Courts and International Community
 - 2.9. The 2023 International Agreement for Remedy Enforcement against Fraud Profiteers vested Remedy Powers in the Agreement Signatories
 - 2.10. The People need Test Cases that discover what can be achieved by use of the International Agreement
 - 2.11. The Post Office Scandal and Health Scandals were Test Cases that got Remedy Enforcement against Fraud Profiteers that did not have Sovereign Status.
 - 2.12. The People need Test Cases to discover whether the International Agreement can be used to get Voluntary Remedies by Sovereign States
 - 2.13. The Tests Conditions need the Instability Risk of Remedy Denial that is greater than Remedy Delivery
 - 2.14. The World War II, Colonial Era End and Extreme Political Polarity used Short Term Remedies that created Long Term Grievances.
 - 2.15. The International Community recognises that:
 - 2.15.1. the Long-Term Grievance of the Palestinian People has made a major contribution to Political Instability in the Middle East
 - 2.15.2. the only Effective Remedy is that they have Sovereign Status
 - 2.15.3. Remedy Success needs Land Returns
 - 2.15.4. The Land Returns needs a Sovereign State to provide a Voluntary Remedy Precedent that gets Positive Recognition and encourages others to deliver Voluntary Remedies
 - 2.15.5. The 1974 Greek Coup resulted in Land Loss that have been Long Term Grievances for Cypriots.
 - 2.15.6. The populations that have endured oppression by unrepresentative minorities and severe war damage need use of Advanced Electronic Signature Technology for Identity Verification, that is Credibly Independent of the State and Big Business, so they can discover who is best qualified to govern.
 - 2.16. The UK can invite the Greek Cypriot State to consider the wisdom of servicing the Peace Negotiations by using 1974 Protective Possession Trust of the Say Family Farm to set a Voluntary Remedy Precedent for Land Return
 - 2.17. The UK can invite the EU to consider the wisdom of servicing the Peace Negotiations by using the Advanced Electronic Signature Technology to set a Joint Voluntary Remedy Precedent for Market Exclusion with an Admission + Apology + Damage Payment that enables the Technology Owners to offer Identification Verification Services to the Syrians and Palestinians
