Harassment Claim CM25F90597 Appeal against the Hearing Denial Frauds on 14th May and 19th June 2025

Appellant: Citizen Mr Akwasi Nkrumah v Respondent: Ms Laetticia Nkrumah

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

1. Care Failures and Child Prostitution by the Chronically Immature Mother caused the Nkrumah Children to appreciate the Care Standard provided by their Respectable Father. The Child Prostitution Conspirators used the Harassment Complaint 01KW635924 and Witness Intimidation Complaint 01 KW140125 and Harassment Claim CM25F90597 for Contact Denial Frauds against the children and father.
2. The Bribe Proof against the Family Court Judges is the No Action Period and then Court Room Hearing Denial Fraud + Remote Hearing Exclusion Frauds + In Absence Restraint Frauds on 14th May 2025 against the Respectable Father. The Remote Hearing Exclusion Fraud motivated the Court Building Visit to make Court Officer Access Demands + Hearing Inclusion Demands that got a Reception Video Proof of Eviction Frauds against Equity Lawyer Mr Ellis and the Respectable Father
3. Two things happened. One was a series of Unsolicited We Love You Messages from the children to the father. The other was a Confidence Collapse + Protection Fraud Service Call by Family Court Judges that got a Service Refusal by the Metropolitan Police and Pathetic Effort by Essex Police.
4. The Protection Fraud Service Failure got a Reluctant Hearing Notice Email + Electronic Records of Audio but No Video + Video but No Audio + use of the Video Audio Failure for Repeat Hearing Denial Frauds + Pending Hearing Restraint Renewal Frauds by the Family Court against the Respectable Father.
5. All of it is Relevant Evidence for the Dismissal Executions against the Judiciary by a United Parliament.
