Applicant: Citizen Father Mr Akwasi Nkrumah v Respondent: Mother Ms Laetticia Nkrumah

Emergency Application: Parental Custody of the three children Kenina + Asafo + Ali

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

1. Contempt Investigation Order + All 3 Children Parental Custody Order for the Father against the Mother

Reasons
6. On 26th and 27th June 2025, all three children made Care Complaints to the father against the mother. She had separated the children by placing Kenina with the Maternal Grand Mother and moving the boys to Harlow. They spend their time commuting instead of with Kenina and their friends at the Breakfast Club and Sports Club. On 26th June 2025, Kenina used the car journey from Sports Club to the house of the Maternal Grand Mother to make her Care Complaint. On 27th June 2025 at 07.34 the boys made a Care Complaint Telephone Call to the father.
7. A Justice Perversion Criminal Conspiracy got Parental Custody of the 3 children for the mother
8. The Protection Fraud Network made a Business Expansion Plan for Housing Frauds. It needed a Big Customer and a Business Priming Case that identified and rewarded Corrupt Officers and identified and penalised Honest Officers. Housing Association Merger Permits from Cabinet Officers got a Big Customer. Thousands of Tenancy Forgeries and a Business Management System that made Acknowledgment Failures the Standard Practice was the Fraud Commitment Proof from Housing Association Officers. Forgery Complaints got Whistle Blower Status for Tenant Mr Nkrumah. Protection Fraud Demands by Cabinet Officers and Housing Officers got a Service Call by Top Judges and Framing Frauds by the Metropolitan Police against Mr Nkrumah. A Profit Share Demand by Top Police got a Share Refusal by Top Judges and a Protection fraud Refusal by Top Police. Service Calls by Court Officers got Service Refusals by Competent Officers and Incompetent Efforts by Idiot Officers. Every case got Fraud Conspiracy Proof for Citizen Mr Nkrumah against the State and Law Courts. The Seal Ink on Original Documents and Electronic Records Inconsistency Proof for Corruption Investigations. Top Judges made an Investigation Sabotage Plan. It needed Original Document Theft and Electronic Device Theft. In 2020, they used the return journey from a court hearing and a Theft Agent for a Big Blue Bag Snatch Theft as Citizen Mr Nkrumah left Seven Sisters Railway Station. It got the Original Documents. In 2021, they used Science Teacher + Wholesale Drug Dealer + Money Launderer Mr Benjamin Koomson as Theft Agent for the Electronic Devices. He discovered Mr Nkrumah had 3 children with Maternal Relatives that were Chronically Immature. He used them to get and introduction to Citizen Mr Nkrumah. He got the Chronically Immature Mother to move home, and a Private Landlord to make Tenancy Misrepresentation Frauds that persuaded Citizen Mr Nkrumah to put his Case Records + Electronic Devices + Cash + Other Goods in the house for Immediate Theft by the Private Landlord. Drug Dealer Mr Koomson could not resist the Prostitution Opportunities. He started with the Chronically Immature Mother and jointly with her prostituted the 14-year-old Kenina. Under Aged Sex Questions by father motivated Rape Complaint Fraud Threats by the Chronically Immature Mother and the Blackmail Fraud Complaint dated 14th October 2024 of Citizen Mr Nkrumah that got Child Prostitution Protection Fraud Proof
