A Court Fraud Conspiracy got the Remote Hearing on 14th May 2025, the Hearing Exclusion Frauds and a Court Room Hearing Order by Deputy District Judge Ms Brookfield for Citizen Mr Nkrumah.

The Hearing Exclusion Fraud Appeal of Citizen Mr Nkrumah was filed. The Acknowledgment Email on 9th June 2025 was a Hearing Date Notice Email. It stated the Fraud Appeal would be dealt with at the hearing on 19th June 2025. It means the Trial Judge controlled the Trial Fraud Appeal

A Court Fraud Conspiracy denied the Court Room Hearing and got the Remote Hearing Listing for 19th June 2025

On 18th June 2025, the Claim Bundle Service Email from the Representatives Morgan Wiseman claimed to have had 1 Day Notice of the hearing on 19th June 2025. The Family Court Listing Web Page identified the Hearing Judge as Deputy District Judge Bollard.

On 19th June 2025 the Remote Hearing started with Claim Representative Ms Gurusahiba Bhatia saying something. Link Failures denied Citizen Mr Nkrumah the benefit of Audio and Video at the same time. The Judge gave him 'a chance to impress her'. Fraudulent Invalidity Representations by him got an Almost Immediate Link Failure. The Hearing Judge used the Court Room Hearing Direction made on 14th May 2025 for a Court Room Hearing Entitlement Admission, a No Remote Hearing Rights Admission and used the Link Failures for a Hearing Adjournment and Pending Adjournment Restraint Continuity. A Costs Question by the Judge got a '2 Hours' response from the Claim Lawyer and 'OK' from the Judges and no indication what that meant.

A Court Fraud Conspiracy denied Citizen Mr Nkrumah any Seal Proof of the Order dated 19th June 2025

On 26th and 27th June 2025 all three children made Care Complaint to the father against the mother. Meanwhile, the Protection Fraud Investigations discovered that ChatGPT omitted the Equity Governance Web Site content from the Search Returns for the name Benjamin Koomson, and later the name Laetticia Mukasa and then All Searchers except those that use the whole web address. Other Search Engines continue to provide the Equity Governance Web Site content.

30th June 2025 was Hearing Day 12. It did not get the Order Seal Proof. It got what purports to be a Remote Hearing Direction Order dated 30th June 2025 by an Unidentified Deputy District Judge that bears an Undated Stamp. It motivated Case Enquiries Telephone Calls by Citizen Mr Nkrumah discovered the Court Record does not identify the Hearing Judge on 19th June 2025. The Call Transaction ID 131826 will have the Audio Record.
