Forgery Complaints got Whistle Blower Status for Citizen Mr Akwasi Nkrumah. It motivated a Ruin Fraud Conspiracy against him. He and Laetitia Mukasa have 3 children. She is Chronically Immature and relied on him for Child Care Services. Drug Wholesaler Mr Benjamin Koomson managed Money Laundering for the Local Judges and Local Police. The Ruin Fraud Conspirators needed Original Documents Theft and Electronic Device Theft. They used Drug Wholesaler Mr Koomson as Electronic Device Theft Manager. He used the Chronically Immature Mother and a Private Landlord as Theft Agents.

The Remedy Process used a Rape Complaint Fraud that got Investigation 01YE1544123 to make Production Demands for Corruption Proof as Defence Evidence. It got Recorded Interview Denial Frauds. No one dare create an Audio Record of Production Demands that got Production Denial Fraud Proof against the Investigator or Demand Denial Fraud Proof against the Defender. It got Case References up the Command Chain to Metropolitan Police Commissioner Sir Mark Rowley, Court Records Seizure Power Requests by him, that got Request Refusals + Temper Tantrums by the Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer. He and the Media needed an Event Marker. They used a Microphone Displacement Apology + Stress Reason from Sir Mark Rowley to a Reporter that got TV News Coverage.

The Drug Wholesaler could not resist the temptation to prostitute the Chronically Immature Mother and use her to prostitute the 14-year-old daughter. Under Age Sex Questions by the Citizen Father motivated Rape Complaint Fraud Blackmail by the Chronically Immature Mother that got the Blackmail Complaint Statement dated 14<sup>th</sup> October 2024 by the Citizen Father and use of it for an Additional Evidence Notice in Rape Investigation 01YE1544123. It got Child Prostitution Protection Fraud Proof against the Chronically Immature Mother, Drug Wholesaler, Barking and Dagenham Council, School Authorities, Metropolitan Police, Essex Police, Crown Prosecution Service, Law Courts and Cabinet.

A Service Call by the Ruin Fraud Conspirators got the Harassment Complain Fraud 01KW635924 and Witness Intimidation Complaint Fraud 01KW140125 by the Chronically Immature Mother. Prosecution Refusals by the Crown Prosecution Service created the need for Harassment Claim CM25F90597 by the Chronically Immature Mother and Hearing Denial Frauds + Restraint Frauds by the Family Court.

A Surprise Visit on Saturday 5<sup>th</sup> July 2025 by the Chronically Immature Mother and 3 children to the Maternal Grandmother got a Children + Father Mutual Access Offer from the Chronically Immature Mother to the Paternal Grandmother conditional on No Involvement Evidence against the Chronically Immature Mother. It got Set Up Conditions for use of the Sports Day Attendance on 10<sup>th</sup> July 2025 for a Restraint Breach Complaint Fraud by the School Head. It got a Suspicious Behaviour Notice Call at 14.14 for 1 minute 15 seconds from the Citizen Father to Equity Lawyer Mr Ellis.

The Restraint Breach Arrest Fraud + Custody Fraud got a Custody Notice Call at 18.20 from Ilford Police Station got Voice Contact for the Citizen Father and Equity Lawyer and a Case Detail Prohibition from an Anonymous Police Officer.

A Case Enquiry Call at 22.34 from Derrick, the brother of the Citizen Father, got a Case Briefing from the Equity Lawyer.

On the morning of 11<sup>th</sup> July, the Equity Lawyer used Police Website to access the Telephone Numbers for Ilford Police Station. Test Calls got Connection + Immediate Termination. A Test Call for Chingford Station got the same result.

Visits by Citizen Mr Can Say to both Barkingside Magistrates Court and Ilford Station made known his interest in the case, and that a Defence Witness Statement would be emailed to the Police and Court, and got Know Nothing + Cannot Tell Anything Responses from All Officers.

Meanwhile, Equity Lawyer Mr Ellis printed, signed and scanned his Harassment Claim CM25F90597 Restraint Breach Framing Fraud Conspiracy Witness Statement for Citizen Mr Nkrumah v State

The intent is to use a Royal Commission Email to file and serve Witness Statement + Investigation Report and Additional Evidence Notices, and discover whether anyone informs the Investigation Officers, and if so, what response it gets from them.
