Circumstances

1. The Profession Unfitness Complaint dated 7th May 2025 of Citizen Mr Nkrumah against Counsel Mr Setters got Case Reference 2025 1251 from the Bar Standards Council. The Complaint Dismissal Email dated 8th July 2025 got a Junk Classification and did not come to the attention of Citizen Mr Nkrumah until Mr Setters told him at the 2023 0058 Trial on 18th July 2025.
2. The Complaint Dismissal gets
 - 2.1. A Complaint Appeal
 - 2.2. A Complaint Dismissal Fraud Judicial Review Claim to the Administrative Court
 - 2.3. Another Fraud Additional Evidence Notice for the Court of Appeal Trial Fraud Case 2024 001156
3. The Connected Case 2022 0043 got Secret Trial Conspiracy Proof against Snaresbrook Crown Court and a Trial Audio Record of a Crown Prosecution Service Officer explaining that Case Refusals by more than 100 Regulated Lawyers resulted in a Representation Failure for the State.
4. The 2023 0058 + Connected Cases CC 2022 0043 + 2023 1180 + CA 2024 001158 01KG635924 + 01KG140125 + FC CM25F905907 got Child Prostitution Protection Fraud Liability for State Officers at all ranks to Cabinet. It motivated Defence Service Applications by Union Members. It created the need for Labour Unions to make Negotiation Offers to finance Political Parties on condition that it was used to get Criminal Immunity for Union Members and Corruption Remedies for the People.
5. Parliament Session Grants required Remedy Delivery. It needs Dismissal Executions against the Judiciary before the 2025 Summer Recess, Victim Identification and Case Remedies. The Dismissal Failure was a Protection Fraud. It got a Remedy Denial Fraud Finding by the Parliament Sessions Court and use of Scandal Enquiry Judges for a Finding Pronouncement for Parliament with Mass Publicity
6. The Fraud Commitment Proof given by the Judiciary to get the Protection Fraud included the County Court Trust Fraud B01BO837 + M01RM078 Notice Denial Fraud Secret Hearing + Repeat Sale Order + Limited Restraint Order dated 9th June 2025 for Trust Son Mr Vishal Sood against Citizen Beneficiary Father Mr Sham Sood with a Day 2 Print and a Day 36 Disclosure Email to the Citizen Beneficiary Father.
7. The 2023 0058 Trial on 18th July 2025 discovered
 - 7.1. Case Withdrawals by Prosecution Witnesses for Fraud Liability Damage Limitation Reasons
 - 7.2. Case Refusals by Regulated Lawyers had created the need for the State to rely on Counsel Chambers controlled by the Ministry of Justice for Defence Cross Examiner Mr Setter and Trial Judge Mr Clark
 - 7.3. Credible Neutrality Breaches + Conflict Disqualification Denials by Defence Cross Examiner and Trial Judge
 - 7.4. Cross Examination Questions that are Trial Fraud Conspiracy Proof for Mr Nkrumah against the Defence Cross Examiner
 - 7.5. Evidence Exclusion + Witness Production Failures that are Trial Fraud Conspiracy Proof for Mr Nkrumah against Prosecutor Mr Shah and Trial Judge Mr Clark
