Application by Mr Akwasi Nkrumah for the court to state a case for the opinion of the High Court on an appeal on a question of law or jurisdiction.

Decision under appeal.

- 1. Criminal Conspiracy to manage a Protection Fraud Network that used Cabinet Officers and Top Judge to provide Protection Frauds for Crime Businesses managed by Top State Officers and Top Judges.
- 2. Criminal Conspiracy to provide Protection Frauds for:
 - 2.1. A Drug Crime Business managed by Top Police, Top Customs and Top Judges with Top Drug Sales getting Protection Frauds that included Child Prostitution
 - 2.2. A Child Trafficking Business managed by Top State Officers and Top Judges
 - 2.3. Land Frauds by Cabinet Officers and Top Judges against the State that used
- 3. Criminal Conspiracy to use Merger Decisions to get the London and Quadrant Housing Association as a Big Business to prosecute a Business Priming Case that identifies and rewarded Corrupt Professionals and identified and penalised Honest Professionals. Land Title Records Destruction and many thousand Forged Tenancies as Records Fraud Commitment Proof from Housing Officers to get Protection Frauds from Top Judges.
- 4. Criminal Conspiracy to use Forgery Complaints by Tenant Mr Nkrumah for Protection Fraud Demands by Cabinet Officers and Housing Officers, a Land Fraud Concealment Plan by Top Judges for a Ruin Frauds against Citizen Mr Nkrumah that used Framing Frauds by Investigators + Prosecutors + Defenders + Trial Adjudicators + Appeal Adjudicators. Service Calls by Top Judges that got Framing Frauds by Top Police against Citizen Mr Nkrumah. A Profit Share Demand by Top Police, a Profit Share Refusal by Cabinet Officers and Top Judges, a Pending Profit Share Service Refusal by Top Police, Service Calls by Court Officers, Service Refusals by Competent Police Officers, and Incompetent Efforts by Idiot Officers that created a Total Collapse Risk for the Protection Fraud Network.
- 5. Criminal Conspiracy for the Fraud Investigation Sabotage Plan by Cabinet Officers and Top Judges that needed Original Documents Theft + Electronic Devices Theft because the Seal Ink and Record Inconsistences were Forensic Test Material and Record Fraud Proof. Theft Management needed Target Locations. They did not have Target Locations because Citizen Mr Nkrumah was homeless, relied on friends for sofa surfing, and provided Care Services for the 3 Children because their mother, Laetticia Mukasa, was Chronically Immature and could not cope. In September 2020 a Hearing Event got Original Document Production from a Big Blue Bag by Citizen Mr Nkrumah, a Location Report from Court Officers, a Theft Order from Top Judges and use of the Return Journey and a Theft Agent for a Big Blue Bag Snatch Theft from Citizen Mr Nkrumah when he left Seven Sisters Railway Station.
- 6. Criminal Conspiracy to service the Ruin Frauds with the Drug Crime Framing Fraud in January 2021 by Metropolitan Police Officers, who failed to equip themselves with a Drug Supply for Evidence Planting, used a House Entry Fraud for a Search Fraud that failed to find drugs, used a Half-Eaten Shia Butter Pack for a White Substance Suspicions Fraud + Arrest Fraud + 2100155689 and 2100175116 Investigation Frauds + Pre-Charge Bail Conditions Frauds for a Family Sabotage Fraud against the 3 Children and Parents. The Bail Conditions Appeal on 1st February 2021 got a Resistance Decision by the Crown Prosecutor, an Appeal Witness Attendance by Equity Lawyer Mr Ellis, an Appeal Witness Attendance Report from Security Guards to the Crown Prosecutor, a Reception Visit by the Crown Prosecutor, and Appeal Witness Exclusion Order from the Crown Prosecutor to the Security Guards, retention of the Entry Queue Front Position by the Equity Lawyer, a Reception Video Record that was Witness Exclusion Fraud Proof for the Citizen against the State, a Witness Exclusion Fraud Video Proof Notice from the Equity Lawyer to the Security Guard, a Video Proof Report by Security Officers to the Crown Prosecutor, a Confidence Collapse + No Contest Decision by the Crown for the father but not the mother, Case Support from the father for the mother that got a Confidence Collapse and No Contest Decision by the Crown Prosecutor and Family Reunification that day for the children mother and father, outrage and Drug Crime Defamation Fraud Use Orders for Child Risk Pretence Frauds by Top Local Authority Officers.

Criminal Conspiracy to service the Ruin Fraud with the Public Gallery Assault Framing Fraud [Essex Magistrates] 42MR1372521 Preliminary Issues + [Hertfordshire Magistrates] 2100096661 Preliminary Issue + Crown Court Committal Witnesses + Investigators + Prosecutors + Defenders + Supervision and Preliminary Issue Judges + Crown Courts [St Albans] 2021 0297 + [Chelmsford] No Case Number + [Basildon] 2021 0540 + [Snaresbrook] 2023 1180 Supervision and Preliminary Issue Judges

Criminal Conspiracy to use the Drug Wholesaling + Money Laundering Services provided by Science Teacher Mr Benjamin Koomson for Local Judges and Local Police for a Trustworthy Person Finding and allocation of an Electronic Device Theft Contract. Friendship Pretences by the Science Teacher got Friend Introductions by the Chronically Immature Maternal Relatives to the Chronically Immature Mother and by her to Citizen Mr Nkrumah. Friendship Pretences by the Science Teacher got Shop Minding Services from Citizen Mr Nkrumah and Father Location Certainty

that enabled time spent on Bribery + Criminal Agent Recruiting of the Chronically Immature Mother by the Science Teacher. A House Move by her and Tenancy Prosie Frauds by a Private Landlord persuaded Citizen Mr Nkrumah to put his Case Records + Electronic Devices + Cash + Other Goods in the house for Immediate Theft. It was timed to deny him the Case Papers and Train Fare Cash needed to attend the Public Gallery 2021 0540 Plea Hearing on 1st November 2021 in Basildon Crown Court. It got an Audio Record of a Travel Warrant Refusal by the Plea Hearing Judge and use of the Return Journey and Basildon Railway Station for an Ambush Framing Fraud. Suspicious Behaviour by the Railway Staff motivated Contact Avoidance Efforts by Citizen Mr Nkrumah. It got Event Video Records that were Contact Avoidance Proof + Assault Innocence Proof + Personal Injury Fabrication Proof + Undamaged Good Proof + Criminal Damage Fabrication Proof. The Assault + Criminal Damage 2100279461 Preliminary Frauds + Trial Frauds got a Complete Set of Fraud Conspiracy Proof against Witnesses + Investigators + Prosecutors + Defenders + Preliminary Hearing Judges + Trial Judges. Confidence Collapses by some forced suppression of Old Case Records and creation of New Case Records. The 2100279461 Trial Frauds got the Fraud Appeal 2023 0058.

- 9. The Electronic Device Theft was a success. The Stolen Goods Disposal using a House Clearance Skip was a failure. A Stolen Goods Location Report from a Friend, a Stolen Goods Recovery Help Request by Citizen Mr Nkrumah got a Goods Recovery Meeting and use of it by the Metropolitan Police for a Stolen Goods Recovery Refusal + Arrest Fraud + Assault Framing Fraud 2022 0043. It got Secret Trial Fraud Conspiracy Proof against the Crown Court at Snaresbrook and an Audio Record on 27th March 2023 of a Crown Prosecution Service Officer explaining that Service Refusals by more than one hundred Prosecutors was the reason for a Prosecutor Appearance Failure. It got a Confidence Collapse and Public Gallery Case 2021 0540 Transfer by the Crown Court at Basildon to Snaresbrook where it got Case Reference 2023 1180. Preliminary Hearings in both cases added to the Fraud Proof and got Case Adjournments from May 2024 to sometime in 2026.
- 10. Criminal Conspiracy to service the Ruin Fraud with use of a Sports Training Whistle for Police Officer Impersonation Fraud 2200054477 that got Preliminary Hearing, a Witness Attendance at one by the Equity Lawyer, a Secret Hearing for the Prosecutor and Judge, Public Gallery Access Demands by the Equity Lawyer, Access Denial Frauds and Building Exclusion Fraud Call by the Court Usher and Romford Area Exclusion Fraud by the Metropolitan Police, Case Directions and then a Confidence Collapse and Case Withdrawal by the State
- 11. Criminal Conspiracy by the Science Teacher to prostitute the Immature Mother, and use her to prostitute the 14-Year-Old Girl. Under Age Sex Questions by the Citizen, Rape Complaint Fraud Threats by the Chronically Immature Mother, a Blackmail Complaint Statement dated 14th October 2024 by the Citizen, use of it as Additional Evidence for Crime Complaint 01YE154123 got Case References up the Command Chain and use of it by Metropolitan Police Commissioner Sir Mark Rowley to get Child Prostitution Protection Fraud Proof against the Cabinet. The Network became Totally Dependent on the Chronically Immature Mother for Framing Frauds against Mr Nkrumah. The 14-year-old welcomed Sexual Freedom but soon rejected Sexual Exploitation and Underage Care Service Exploitation. Care Complaints by the 3 Children against the Chronically Immature Mother created the need for a Restraint Fraud against Mr Nkrumah that are Paternal Contact + Paternal Care Denial Frauds against the 3 Children.
- 12. Harassment Complaint Fraud + Witness Intimidation Complaint Fraud got Investigations 01KW635924 + 01KW1540125 got Confidence Collapses + Inconsistent Record Fraud Proof + Charge Fraud Refusals. Harassment Claim CM25F90597 got Hearing Denial Fraud Proof + Restraint Fraud Proof + Inconsistent Records and use of them for Restraint Breach Framing Frauds 01KG122625 + 01KG123075. They were Set Up Conditions for an Arrest Fraud in the event of the 2023 0058 Trial Fraud failing to get a Custody Fraud against Citizen Mr Nkrumah
- 13. Criminal Conspiracy for the 2023 0058 Preliminary Frauds + Appeal Re-Trial Frauds on 17th + 18th + 21st July 2025 Witnesses + Investigators + Prosecutors + Defenders + Preliminary Hearing Judges + Appeal Re-Trial Judges Recorder Mr P. Clark + 2 Magistrates

3) Grounds of appeal. Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

The Parliament Session Grant required Remedy Delivery using Dismissal Executions by Parliament before the 2025 Summer Recess, Victim Identification and Case Remedies. The Remedy Process needed a Test Case Trial on 17th July 2025 to set Remedy Precedents in the event of Dismissal Executions and for a Case Collapse in the event of Dismissal Failures. The Ruin Fraud Conspiracy against Citizen Mr Nkrumah got a series of Case Collapses that were excellent for the purpose. The Case Collapse was Testimony Refusals by 6 out of 7 Event Witnesses and Investigation Witnesses Production Failures by the Prosecutor. The Event Video was Innocence Proof. It got a Criminal Damage Appeal Grant and an Assault Appeal Dismissal Fraud. The Citizen walking free from the Crown Court was a Total Collapse Risk for the Protection Fraud Network. The Cabinet ordered a Restraint Breach Arrest Fraud against Citizen Mr Nkrumah to avoid Total Collapse of the Protection Fraud Network. The Remand Custody Fraud + Sentence Breach Fraud + Restraint Breach Fraud are being used for Integrity Tests of the Prison Service and Law Courts
