- 1. Court Form Denial Frauds by the Prison Authorities denies a Fee Remission Forms + Claim Forms
- The Coronation Oath Enforcement Authority have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. In 2004, they discovered the Protection Fraud Network uses Cabinet Offices and Top Judge Offices to manage Endemic Corruption. They provide Protection Frauds for State Officers of all ranks and Law Court Judges of all ranks and the producers, distributers and money launderers who make Crime Profits. They started a Corruption Remedy Process that has continued ever since.
- 3. In 2023, the Remedy Process got Imprisonment Fraud Proof against the Judiciary. The G7 used it to negotiate an International Agreement for Remedy Enforcement against Fraud Profiteers. In December 2023, the G7 Summit got Agreement Signatures and Damage Payments that financed Dedicated Remedy Budgets, controlled by the Cabinet, that enabled exposure of the Post Office Scandal and Contaminated Blood Scandal.
- Meanwhile, the Imprisonment Fraud was used for Service Tests that Fraud Conspiracy Proof against the Prison, Ministry of Justice, Law Courts, Cabinet and Parliament. It identified Imprisonment Fraud Victims. It got Drug Dealing Proof and Intimidation Fraud Proof against Prison Officers. Two cases were particularly important.
  - 4.1. Prisoner A7944CP Mr Gary Johns was a Decent Father. He wanted 3 children to have Honest Lives. The Paternal Grand Father was born in 1966. He grew up in North East London. He used the Kray Twins as Role Models. It got 28 Years Imprisonment for Drug Dealing + Stabbing GBH x 4 and Stabbing Murder x 1 + Prison Escape + Open Prison Absconding and a Prison Drug Business Contacts for him. The 2019 Prison Release got Network Drug Supplies + Protection Frauds for him and use of his Corrupt Officer List for the Protection Fraud Network. He wanted to use his 3 Grandchildren. The Maternal Relatives wanted to use the 3 Grandchildren for Brothel Management and Drug Crimes. Restraint Frauds + Restraint Breach Framing Frauds by the State and Law Courts for the Paternal Grandfather and Maternal Relatives against the Decent Father denied him access to the 3 Children. Incompetent Management by them, Idiot Officers and Corrupt Defenders got Innocence Proof + Framing Fraud Conspiracy Proof for him that persuaded 2 Children to make Care Applications to the State. The Paternal Grandfather got use of 1 Child for Drug Dealing. The Decent Father knew the Text Message Code the 3<sup>rd</sup> Child used for Drug Dealing. The Decent Father allowed use of his Imprisonment Fraud for Integrity Tests of the Prison Authorities and Law Courts. Corrupt Officers managed Intimidation Frauds against him. Bad Behaviour Framing Fraud Complaint 3883592 was a Test Case. It got Confidence Collapses, Hearing Adjournments, Case References between Function Heads and Document Thefts from the Case File. The Parliament Sessions Court required that a Prison Inspector see copies of the Stolen Documents and attend the Final Hearing. A Case Dismissal for the Decent Father motivated Intimidation Frauds by Corrupt Officers that got a Drug Dependency for the Decent Father.
  - 4.2. Prisoner A5373CA Mr Jack Onslow was a Decent Man with an Attention Deficit Disability. He wanted a Stable Relationship and Whole Family living in one house. Similar Fact Frauds got the Imprisonment Fraud against him. He was a Model Prisoner and Prescribed Drugs Trustee. A Prison Officer wanted him as a Drug Mule. Contact Avoidance Efforts by him motivated Drug Crime Allegations by her that got a Trustee Dismissal + Wing Transfer from A to G by the Prison. A Dismissal Reasons Request + Re-engagement Request by him got a series of Angry Responses by her with Prisoner + Officers as Event Witnesses and Event Video Records from Wing CCTV. All of it got Drug Crime Protection Fraud Proof against the Prison.
- The Remedy Process is using the A6885DP Imprisonment Fraud for the 2025 Prison Service Tests
