It uses Imprisonment Fraud Proof against the Judiciary for a Judicial Unfitness Finding, Imprisonment Fraud Finding, Protection Fraud Finding and Enforcement Fraud Finding by the Parliament Sessions Court, Finding Pronouncements by Parliament and Mass Publicity for Demonstration Cases.

- 4. In 2023 Imprisonment Fraud Proof got the Findings Set and Mass Publicity for Demonstration Cases. They were the 17 Years Imprisonment Fraud, Police Station Video Concealment Protection Fraud and the Intimidation Frauds by Prisoner Officers against a Prisoner that got a Drug Dependency and Drug Habit Extortion Frauds against the Prisoner's Family. In December 2023 the G7 Summit got the International Agreement for Remedy Enforcement against Fraud Profiteers. Damage Payments from Fraud Profiteers got Dedicated Remedy Budgets for Victims, controlled by the Cabinet, that enabled exposure of the Post Office Scandal and Contaminated Blood Scandal. It got an increase in the MP Retirement Rate, an Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority led by Sir Keir Starmer
- 5. The 2024 Parliament Session Grant required 20,000 Imprisonment Fraud Releases. The Imprisonment Fraud Release Refusal and use of the Overcrowding Reason for 3,500 Guilty Prisoners a Session Grant Breach Finding + Remedy Denial Fraud Finding and Breach Penalty of Mass Publicity for Cabinet Bribery Questions in the week before the Political Party Conference. Exposure of the Church of England Scandal enabled use of US Presidential Elect Team, UK Opposition Leaders and Child Prostitution Scandal to get Blackmail Conditions that extorted Remedy Delivery Co-operation Commitments from the Cabinet. It got Preparation Co-operation but not Dismissal Executions against the Judiciary before the 2025 Summer Recess.
- 6. New Court Frauds were the Commitment Proof from the Judiciary to get the Dismissal Failure Protection Frauds.
- 7. The Parliament Session Court had a Remedy Delivery Support Plan and a Remedy Failure Contingency Plan. It used the New Protection Fraud Proof got by Mr Nkrumah to get a Forced Transfer of the Rotherham Protection Fraud Investigation from a South Yorkshire Police to the Serious Crimes Squad. They required Trial Listing of a Crown Court Test Case for Thursday 17th July 2025. They chose Assault + Criminal Damage Trial 2023 0058 because the Event Video Evidence was Contact Avoidance Proof + Assault Innocence Proof + Personal Injury Fabrication Fraud Proof + Undamaged Goods Proof + Criminal Damage Fabrication Fraud Proof for Mr Nkrumah against the Framing Fraud Conspirators. If 14 July got Dismissal Executions it would service the Support Plan with Remedy Precedents, and if not, it would service the Contingency Plan with a Case Collapse. Testimony Refusals by 6 out of 7 Event Witnesses and Investigator Production Failures by the Prosecutor that got Audio Records that are Fraud Proof against the Appeal Judges. The Cabinet needed to avoid the Case Collapse becoming a Total Collapse of the Protection Fraud Network. At the Trial End they used the CM25F90597 Restraint Fraud and Electronic Contact from his children for a Restraint Breach Framing Fraud 01KG1230725 Arrest Fraud + Custody Fraud against him. It got Case Management Sabotage Fraud Proof against the Prison Authorities and Imprisonment Fraud Blackmail Proof against the Judiciary. The Rotherham Investigation was transferred to the Serious Crimes Squad.
