## **REASONS:**

- 1. World Leaders have made a Corruption Remedy Agreement. It needs Advanced Electronic Signature Services. In the UK it needs LIBRARY BUDGET INCREASES to deliver them. Mass Resistance from Vested Interests is getting a Slow Remorseless Progress. For Remedy Management. It is in the best interests of everyone know what is happening.
- 2. State Librarians can help. They have three advantages.
  - 2.1. High Literacy and Communication Skills.
  - 2.2. Few, if any, have Joint Liability for Child Prostitution Protection Frauds. The Coronation Oath Enforcement Authority manage a Corruption Remedy Process. It used Parliament Enquiries to get Notoriety Knowledge that Drug Sales get Protection Frauds, that includes Child Prostitution, from Police Officers, Law Courts, Cabinets and Parliament. Willing Witnesses got priority for the Rotherham Scandal. The Remedy Process needed a Criminal Investigation into Old Protection Frauds and Compelling Proof of New Protection Frauds. The Remedy Process got a Criminal Investigation into the Rotherham Old Frauds. The Blackmail Statement dated 14th October 2024 of the Decent Father got Compelling Proof of New Child Prostitution Protection Frauds. It alleged that Science Teacher Mr Benjamin Koomson is a Drug Wholesaler who provides Money Laundering Services for Local Judges and Local Police. He prostituted the Chronically Immature Mother, Ms Laetticia Mukasa, and use her to prostitute the 14 -Year - Old Daughter. Under Age Sex Questions by the Decent Father, Mr Akwasi Nkrumah, motivated Blackmail by the Immature Mother that used Rape Complaint Fraud Threats to deter the Under Age Sex Questions. The Blackmail Statement as Additional Evidence in the Rape Framing Fraud Investigation 01YE1544123. It got Recorded Interview Refusals and Case References up the Command Chain. No one dare get an Audio Record of Production Demands for Corruption Proof as Defence Evidence that got Production Failures that were Fraud Proof against the Investigator, or Production Demand Failures that were Fraud Conspiracy Proof against the Investigator and Defender. The Commissioner Ranks used it to get Child Prostitution Protection Fraud Proof against Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer. Trail Day 1 got Testimony Refusals by 6 out of 7 Event Witnesses and Investigator Production Failures by the Prosecutor. The Cabinet needed to stop the Case Collapse becoming a Network Collapse. On Trial Day 2 they required Fraud Commitment Proof from the State before the Protection Fraud Supply. That day it got 01YE1544123 Charge Fraud sent by Postal Service against Mr Antonakis Katsiaounis and a Complaint Reference Number Notice from Enfield Council to his daughter, Mrs Androulla Theodorou, in response to a Legal Action Notice she had sent months earlier. On Trial Day 3, the Trial End got an Arrest Fraud against Mr Nkrumah, Custody Frauds and Imprisonment Frauds ever since. He is Prisoner A6885DP of Wing C 4.19, Pentonville Prison N7 8TT.
