Claim: Justice Process Contempt by Fraudulent Conspiracy by All Cabinet Officers to provide Protection

Frauds for Cabinet Officers and Top Judges:

1. to use Cabinet Power to provide Protection Frauds for:

- 1.1. The Crime Business managed by Cabinet Officers and Top Judges who manage:
  - 1.1.1. Protection Frauds for Crime Business run by State Officers and Law Court Judges
  - 1.1.2. Land Frauds for themselves against the State
- 2. to allow Crime Profiteers to have Cabinet Officer Status

Offerees Environment Secretary MP Mr Edward Miliband + Foreign Secretary + Tottenham MP Mr D. Lammy

Offer: Negotiations with Mr Miliband for Full Immunity in exchange for Full Disclosure because he

## Circumstances:

- 1. The Protection Fraud Network uses sets of Cabinet Officers and Top Judges to manage 2 Crime Businesses. One is Land Frauds for themselves against the State. The other provides Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. Examples:
  - 1.1. Top Police, Top Customs and Top Judges manage the Drug Crimes Business. The Drug Wholesalers provide Money Laundering Services for the Local Police and Local Judges. Top Drug Sales go with Protection Frauds that include Child Prostitution.
  - 1.2. State Officers and Law Court Judges managed a Crime Business that sold Business Frauds for Powerful Parties and Vulnerable Parties. Examples:
    - 1.2.1. Land Frauds for Big Owners against Small Businesses. It needed a Big Business to conduct Research Frauds to discover what was needed for Industrial Scale Fraud. Town Center Estate Sales by the New Towns Commissioner to Land Securities got the Big Business. The Corby Estate Managers noticed Business Successes got Land Value Increases for Restauranteur Mr Can Say. Dispossession Frauds by the Corby Managers failed because of Good Management by him. It got a Secret Competence Finding + Secret Research Test Case Finding + Secret Fraud Test Series Decision by Land Securities against him. Fraud Starts by them got Competent Management by him that discovered what they needed to know. Completion Failures that enabled a series of New Frauds by them until they had everything they needed, and then Fraud Completion. It got Fraud Conspiracy Proof for him against Contract Parties, His Bankers, His Professionals, Land Securities, the State and Law Courts. He kept it.
    - 1.2.2. Management Frauds for State Officers and Law Court Judges against Local Charities. An example is the Tottenham War Veterans Chairty. Management Frauds got Insolvency Conditions and then Evidence Frauds that got a Trusteeship Transfer to New Trustees to cope with the inevitable Business Collapse that enabled Asset Thefts that included the Community Centre. The New Trustees recruited Mr Can Say. Because he had Corruption Experience. The Holy Qubtic Church was a customer. Mr Akwasi Nkrumah was a congregant. He had Corruption Experience. Mr Say and Mr Nkrumah got Protection Fraud Proof against Local MP Mr Lammy.
- 2. Forged Tenancy Complaints by Mr Nkrumah motivated Protection Frauds by Housing Association Officers and Cabinet Officers, Service Calls by Top Judges got Framing Frauds and a Profit Share Demand by Top Police, a Share Refusal from the Network and then a Pending Share Service Refusal by Top Police. It got a Ruin Fraud Lull. The Tottenham War Veteran Chairity Fraud Complaints by Mr Nkrumah against Mr Lammy, who was then an Opposition MP, got revival the Ruin Frauds against Mr Nkrumah. Electronic Device Theft used Drug Wholesaler Mr Koomson as manager and the Chronically Immature Mother of the Nkrumah Children as agent. Child Prostitution Protection Frauds for them used Imprisonment Frauds against Mr Nkrumah.
