Remedy Process Co-operation Request from Equity Lawyer to Librarians

3rd September 2025

- 1. Ask for Immunity Negotiation Progress Reports from Chief Officers, Union Officers and Party Officers. Reasons:
 - 1.1. The Coronation Oath Enforcement Authority have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. In 2004, they got Kidnap Extradition Fraud + Imprisonment Fraud Proof against the UK and Netherlands. They started a Corruption Remedy Process. It used Research Investigations to discover the structure and strength of Protection Fraud Networks that manage Endemic Corruption in the UK and who among the World Leaders could be relied on for Remedy Co-operation. Queen Elizabeth and Prince Charles used the Commonwealth Conference and UK + Netherlands Case to ask Political Prisoner Questions and got 40,000 Releases. The longest was a 35 Year Imprisonment Fraud by India against a Pakistani.
 - 1.2. In December 2023, the G7 Summit got Recovery Plan. It needed Dedicated Budgets for Corruption Remedies controlled by the Cabinet. The International Agreement for Remedy Enforcement against Fraud Profiteers got the Dedicated Budgets for the Post Office Scandal and Contaminated Blood Scandal. Remedy Delivery risked a Network Collapse. Costs Frauds for Corrupt Lawyers prevent a Network Collapse.
 - 1.3. In January 2025 the US Presidential Team, UK Opposition Leaders and Child Prostitution Scandal got Blackmail Conditions that extorted Remedy Delivery Commitments from the Cabinet. It needed Dismissal Executions on 14th July 2025 against the Judiciary by Parliament, Victim Identification and Case Remedies. The Parliament Session Court required a Trial Listing on 17th July 2025 of a Framing Fraud against Mr Nkrumah. A Dismissal Success would get use of it for a Corruption Finding + Remedy Precedents + Mass Publicity. A Dismissal Failure would get use of it for a Case Collapse. The Cabinet needed to stop the Case Collapse getting a Network Collapse. They used an Arrest Fraud to stop him leaving the Crown Court a free man, and then a Restraint Fraud + Breach Framing Fraud + Custody Fraud. Mr Nkrumah is Prisoner A6885DP in Wing C 4.19 Pentonville Prison N7 8TT. Oppression Fraud Failures and Corruption Investigation Successes got Confidence Collapses up the Command Chain to the Cabinet. Mass Publicity for the Building Frauds against the Unite Union were a Fraud Issue Notice to Conference Delegates. On 8th August 2025 the Forced Transfer of the Rotherham Protection Fraud Investigation from South Yorkshire Police to the Serious Crimes Squad and Immunity Deal Proposals added to the Confidence Collapses. Cabinet Officers want to get out. No Credible Replacement is willing to take accept Joint Liability for Child Prostitution Protection Frauds. The Conference Season started with Mass Publicity for the Cabinet Reshuffle Publicity for No Top Changes, and then the Stamp Duty Evasion Fraud of the Deputy Prime Minister.
 - 1.4. The Remedy Process needs Immunity Deals to get Effective Remedies, avoid Unnecessary Casualties and assess the Immunity Blunder Risk. The most efficient way to do so is to use the Conference Season. The Immunity Deals cannot be limited to Trade Union Members. They must be for everyone
 - 1.5. The process needs to be
 - 1.5.1. Principle Agreements for Detail Negotiations
 - 1.5.2. Detail Agreements that define what are Powerless Parties and Powerful Parties, require Full Disclosure by Powerless Parties and then Full Disclosure + Progressively More from Powerful Parties.
 - 1.6. Let the Romford Scandal be a Discussion Case. A Corruption Concealment Plan by Top Judges needed Evidence Theft against the Decent Father, Mr Nkrumah, who is Political Prisoner A6885DP. It got Theft Contract for Science Teacher Mr Benjamin Koomson because he is a Drug Wholesaler. Money Laundering Services by him for Local Police and Local Judges would get Protection Frauds by them if anything went wrong. He used the Chronically Immature Mother, Ms Laeticia Mukasa, as Theft Agent, prostitute her, and then used her to prostitute the 14-Year-Old Daughter. She soon tired of making Pimp Profits for them, wanted her Decent Father to accept her Respectable Boyfriend and provide Care Services for all 3 children. Top Judges needed Separation Frauds against the Children and Father. The Restraint Frauds + Breach Framing Frauds were fraud Commitment Proof from the Mother, Drug Wholesaler, State and Law Courts needed to get Protection Frauds from the Cabinet.
- 2. Prepare to deliver Advanced Electronic Services:
 - 2.1. Open Discussions about the Immunity Deals will ensure everyone knows.
 - 2.2. The Post Office Masters and Royal Mail Post Workers can provide the Hub Community for a Verified Identities Community. It will staff a Credibly Neutral Agency to control Case Records. Librarian will have Bigger Budgets to provide Interface Services for Citizen and State. The Recovery Plan of World Leaders needs Research Management by the UK. It is a Career Opportunity. Make the best of it. Tell everyone.
