The Immunity Deal Documents are on one page. They are designed to stimulate the interest of busy professionals. The USA, UK, EU and many other states have Bankruptcy Conditions. They need the Recovery Plan. It took years to get the Remedy Belief needed for the Recovery Plan. It needs the UK to complete the Corruption Remedy Process and do Recovery Testing. Anyone who gets Recovery Skills in the UK will have Career Opportunities in many other states. Librarians have the advantage of Core Skills and No Scandals.

The Remedy Process needs to achieve Service Continuity and Total Collapse of the Protection Fraud Network. It needs to make the best of Good Officers and avoid Unnecessary Casualties. It needs to acknowledge Good Officers, identify Salvageable Officers and remove Bad Officers from the bottom to the top.

The Immunity Negotiation Offers to Secretaries of State x 2 dated 1st September 2025 are Demonstration Cases. Between 2010 and 2015 the Corruption Remedy Process got Remedy Cooperation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Edward Miliband. They investigated who in their Political Parties was part of the Protection Fraud Network. The 2024 General Election got the office of Energy Secretary for Mr Miliband. The Remedy Process got Child Prostitution Protection Fraud Proof against the Home Secretary and Prime Minister and a Joint Liability Presumption against Cabinet Officers that is subject to Rebuttal Proof Positive. The Immunity Negotiation Offer to Mr Miliband acknowledges the likelihood there is Rebuttal Proof Positive, and gives an opportunity to present it. The Damage Mitigation Negotiation Offer to Foreign Secretary Mr Lammy evidences that he must account for the Tottenham War Veterans Charity Fraud Liability as well as the Cabinet Joint Liability.

The Remedy Process Co-operation Request dated 3rd September 2025 explains more about the Recovery Plan. Endemic Corruption uses Record Frauds and Case Priority Frauds. Corruption Remedies needs the Forced Transfer of Records Control and Case Priority Control from the State to the Citizen. It needs use of Advanced Electronic Signatures to get a Verified Identities Community, and use of it to staff a Records Management Agency and Case Priority Agency.

Honest Politicians cannot do everything. The Human Rights Declaration omitted Case Priority Rights for the Victim and Citizen. The omission was used to change the Case Priority Powers into a Remedy Powers Monopoly, alias Dictator Powers. Honest Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed the Protection Fraud Network to provide Support Services and manage Co-ordinated Corruption. The Protection Fraud Network used Crime Proceeds to finance Policy Research that enabled Network Politicians to present as having the Professional Expertise. They used Crime Proceeds to make Campaign Contributions. Concealment Frauds prevent the Honest Politicians finding out in time to stop Network Politicians getting Top Office.

The Recovery Plan needs Remedy Belief. It needs people to know how society got into trouble and how it will get out of it.
