Diocese Debate Research Explanation to Bishop and Canon

Corruption Remedies 10th September 2025

Your Grace and Reverend Canon John

The Succession Research for the Church of England started years ago. It did not have a Research Plan. It had the common understanding of millions of people for decades that the church needed a Succession Plan. Most asked what was needed to get Viable Support for Old Services. It was the wrong question. The right one is what New Services will get Viable Support. In the summer of 2025, there was progress. Elderly Local Residents revealed they discovered Social Club Management Skills were lost on the death of Club Members who were born before 1945, and the ill health of One Club Manager born after 1945. They blame themselves. They realise the Consumerist Movement used them to do Social Damage. It was the habit of being Café Customers instead of Club Members that they developed between 50 and 60 years ago. Everyone in the conversations regrets it, but do not know what to do about it. The Elderly Locals are a Similar Demographic to the Broomfield Congregation. The only difference is Club Management Skills. Other events revealed the limit of the Club Management Skills. The proposal that the Church Facilities be expanded for a Nursery School to provide Viable Livings for Parish Clergy met with resistance. The objection was to the practice not the principle. They had management Skills for Club Continuity but not Project Management. Some had Project Management Skills as Sole Managers, but not as Committee Member Managers.

The Diocese Debate is an Excellent Idea. It needs Publicity Management. The Succession Research is Support Evidence for Debate Research. It needs Parish Clergy to ask the Debate Volunteers to conduct the Debate Research and share the Research Result. The important thing is to get Success Conditions before making a Detailed Plan. Churches Together manage Hustings Host Services in General Elections. The Diocese Debate is an opportunity for them to do Market Research for Public Debate Services. The Debate Issues are excellent for the purpose. They engage the individual, and both church and community at every level of organization from the local to international. The timing is excellent. Fundamental Flaws in the World War II Peace Settlement did National Damage that includes State Bankruptcies, and conditions that are an International War Risk. Everyone knows they need a Recovery Plan. Many have lost confidence in the Mass Media.

The Church, Local Residents and World Community have lost confidence in something, and want it back. The Diocese Debate was a Confidence Recovery Lead by the Bishop. It needed a Rapid Positive Response. The Debate Contribution dated 8th September 2025 was intended to serve as such.

On 8th September 2025, poor internet access created the need to use Chelmsford Library for Email Service of the Debate Contribution. It discovered a librarian was very interested to know about the Peace Plan, and the fact the Library Service has No Scandal qualifies it to manage Advanced Electronic Signature Services. It is Confidence Recovery Evidence. Not long ago, none of the State Officers dare have that conversation.

On 9th September 2025, a Telephone Call from Mr Akwasi Nkrumah, who has worshipped at Broomfield three times in 2025, is Prisoner A6855DP in Pentonville Prison, reported a Confidence Recovery by some of the Prison Officers. An Arrest Fraud on 21st July 2025, and an Imprisonment Fraud on 23rd July 2025, enabled him to manage Integrity Tests of the Prison Authorities. Applications, complaints and enquiries got No Responses, or Response Documents with No Reference Numbers, or Bad Behaviour Charge Threats to deter the application, complaints and enquiries. He discovered a surprising number of prisoners with Identity Errors or False Identities. Record Frauds appear to be Standard Practice. It is Service Records with No Actual Service. Test Post and Test Emails that gave Integrity Test Notices to the Prison Authorities got Delivery Denial. Test Telephone Calls from Mr Nkrumah to friends gave Oral Notice that the Delivery Denial was Fraud Proof against the Prison Authorities. It got Rapid Delivery of some, and then the rest. The Independent Monitoring Board used the Email a Prisoner Service with No Reference and No Reply Sheet because no on dare face him. Many Offices know that he is an Imprisonment Fraud Victim because of Corruption Whistle Blowing against Cabinet Members. Many Officers know that Imprisonment Frauds motivated the Scandal Management that got the Forced Resignation and Cabinet Reshuffle on 5th September 2025. The Signed for Post sent that day got Immediate Delivery by Prison Authorities to Mr Nkrumah on 9th September 2025. It was the first Immediate Delivery. It evidences a Confidence Change.
