

The Root Remedy for the 3 Debate Issues is Case Priority Rights for the Victim and Citizen with Common Law Processing that uses Reliable Objectivity to service of the Justice Priority of the People. Most people have Common Sense Instincts that rely on Objective Reasoning. It needs Reliable Objectivity. The Church of England supported development of the Reliable Objectivity by everyone. Equity Governance using the Common Law enables church and state to work in harmony. Dictator Governance substitutes the Obedience Priority of the State for the Justice Priority of the People. It creates conflict between church and state. The 20th century Dictator Governance Plan used the Consumerist Movement and Remorseless Propaganda for Subjective Reasoning against Objective Reasoning. It did Environmental Damage and the Personal Stress Damage to those with a Generous Personality and Common Sense. The Diocese Debate is a recognition that everyone must help undo the damage. The Diocese Debate can help to revive the discipline of applying Objective Reasoning to the All Decisions and revive the confidence of many in their Common Sense.

1. Church and Community.

1.1. Debate Contributors can explain to friends and neighbors there is a Diocese Debate, it needs Debate Research, ask what they think about the issues, receive what is said, make a Relevant Disclosure, and then ask whether they have anything else to say. The Relevant Disclosure is rumors of a Peace Plan by World Leaders. The Support Evidence is:

1.1.1. The USA and Japan helped the UK to get the Damage Payments from the Fujitsu and

Pharmaceutical Industry that financed the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal, and

1.1.2. Wacom, a world brand, markets goods with Advanced Electronic Signature Services that are not yet available.

1.2. The Peace Plan Leaders need help deciding how to neutralize Hostile Interests. The fact there have been Polling Failures creates the need for anything that confirms or counters the Polling Results. The Bishop of Chelmsford used Parish Clergy to announce the Diocese Debate. They were surprised when a Debate Contributor suggested:

1.2.1. Use of the Diocese Debate to confirm or counter Peace Plan Polling Results.

1.2.2. Use of the Debate Contributors as Research Assistants

1.2.3. Expansion of the Contributor Class from Church Attenders to Parish Residents

1.3. The process might discover other things the community needs that the church can provide. Debate Research has already discovered that the Successful Elderly Congregations of the Church of England have Social Club Management Skills. Many in the community know they have lost Social Club Management Skills, want them, and do not know how to recover them. Many in the Church Congregations do not realise that Social Club Management Skills is what has kept them together, and it is something others need.

2. Assisted Dying Debate needs:

1. Acceptance that rights exist only as long as they are reasonable by the objective standard

2. Objective Reasoning must take the environment into account

3. Objective Reasoning supports use of Environmental Damage done by Human Overcrowding to validate a Rights Presumption for the Environment against the Individual and a Death Rights Presumption for the Individual against the State subject to Rebuttal Proof Positive.

4. The Key Issue is the Proof Burden for each Rebuttal Component. Examples:

4.1. Good Health is Rebuttal Proof

4.2. Bad Health gets an Increased Rebuttal Proof Burden that is proportionate to:

4.2.1. The Environmental Damage done by Bad Health Treatment

4.2.2. The Environmental Guilt of the Individual

3. War. Peace Plan Polls got overwhelming support for Palestinian Sovereign against the Powerful Interests of Israel + Others. Church Congregations and Local Residents need to know the Diocese Debate is an opportunity for them to help get Sovereign Status for Palestinians, and thereby service the Peace Plan.
