The Signed for Post Test on 5th September 2025 got Immediate Delivery by the Prison Authority to Prison Cell.

The 2025 Conference Season started with Reshuffle Publicity for No Reshuffle and Stamp Duty Evasion Scandal Management. The Immunity Offers dated Sunday 1st September 2025, explained that Energy Secretary Mr Miliband had a Salvageable Reputation because of Remedy Co-operation when he was Opposition Leader, and Foreign Secretary Mr Lammy had an Unsalvageable Reputation because of his involvement in the Social Centre Dispossession Fraud against Tottenham War Veterans Charity. He was the Local MP. Citizen Mr Nkrumah, Prisoner A6885DP, was one of the Qubtic Church Congregation who attended services in the Assembly Hall who got After Event Protection Frauds against the Local MP. Investigation is needed to discover whether Theft Target Spotter Frauds by him drew the Charity Social Centre to the attention of the Protection Fraud Network. The Immunity Offer was attached to the Royal Commission Email dated Wednesday 3rd September 2025 that put it in the Public Domain and got Notice Proof from the Cabinet and Parliament. Scandal Management got the Forced Resignation and Cabinet Reshuffle on Friday 5th September 2025, and the Justice Secretary Office for Tottenham MP Mr David Lammy. The Immunity Offer was one of the 9 documents enclosed with the Remedy Process Update dated 5th September 2025 from Equity Lawyer Mr Ellis to Citizen Mr Nkrumah that was sent by Signed for Post, arrived on 9th September 2025 and got Immediate Delivery to the Prison Cell. It was the first time that any of the Integrity Test Material got Immediate Delivery. Investigation is needed to discover what influence, if any, the Scandal Management had on the Immediate Delivery.

- 1. whether this document and enclosures get Immediate Delivery from Prison Authority to Prison Cell,
