Remedy Co-operation Test Responsibility Finding for the People against Media Managers and Citizens Remedy Co-operation Tests by Citizens got Legal Aid Denial Fraud Proof for Mr Katsiaounis against the State and Case Management Sabotage Fraud Proof for both Citizens Mr Katsiaounis and Mr Nkrumah against Regulated Professionals and Bias Fraud Proof for them against the Law Courts.

Remedy Co-operation by the Media Managers needed use of the 2025 Conference Season for a Corruption Exposure Campaign that, so far, got the Forced Resignation from the Deputy Prime Minister and the Forced Dismissal of the UK Ambassador to the USA.

- 1. No Jurisdiction Plea Acknowledgement + Pending Full Disclosure Liability Plea Adjournment + Within 7 Days Full Disclosure Order + Order Breach Contempt Penalty Warning for Citizen Mr Katsiaounis against the State
- 2. Unqualified Representation Order + Validation Investigation Order + Contempt Investigation Order for Citizen Mr Katsiaounis against the State for the Stated Reason that
 - 2.1. The Absolute Priority in all cases is a Validation Investigation to discover whether any Justice Office Qualification Breach or Fair Process Breach by the State or Law Courts invalidates the Prosecution Decision, Committal Order, Crown Court Trial Title and is a Justice Process Contempt of the Law Courts, and if so, who is responsible.
 - 2.2. The Legal Aid Application failed to get Legal Aid with or without a Contribution Condition
 - 2.3. The Representation Request Tests by Citizens Mr Katsiaounis and Mr Nkrumah got No Substantive Response from any of the Qualified Professional Requestees
 - 2.4. Case Management Fraud Claim Notices and Service by the Citizen on the Investigator and Defender, Tuckers, got No Acknowledgments, No Defence Notice and Defender Status Pretence Frauds by both of them. On 15th August 2025, Highbury Magistrates Court held the Committal Hearing. After the hearing, an Anonymous Woman appeared claiming to have instructions from Tuckers. An Identity Request by Citizen Mr Katsiaounis got an Identity Refusal, who laughed and left.
