Framing Frauds 01KG1226225 + 01KG1230725 - Case History + Hearing Report

**Standard Protection Frauds.** The Protection Fraud Market Protocol requires Fraud Commitment Proof from the Receiver before the Protection Fraud Supply.

**Original Crime Exposure**. A Criminal Conspiracy for Land Frauds against the State by the Cabinet and Top Judges required Judiciary. Evidence Destruction Frauds + Evidence Creation Frauds including many thousand Forged Tenancies was the Fraud Commitment Proof provided by the London and Quadrant Housing Association to get Protection Frauds from the Judiciary.

Original Crime Exposure Special Protection Frauds. Forgery Complaints got Corruption Whistle Blower Status for Citizen Tenant Mr Nkrumah. It motivated Protection Fraud Demands by Housing Officers and Cabinet Officers, Ruin Fraud Service Calls by Judges and Framing Fraud Services by Top Police. A Profit Share Demand by Top Police got a Profit Share Refusal by Cabinet Officers and the Judiciary, and Pending Profit Share Service Refusal by Top Police. Service Calls by Court Officers got Service Refusals by Competent Police Officers and Incompetent Efforts by Idiot Officers, each of which got Framing Fraud Conspiracy Proof for Citizen Mr Nkrumah against All Guilty Parties. The Original Crime Exposure Special Protection Concealment Frauds. A Concealment Plan by the Judiciary needed Documents Theft and Electronic Device Thefts. Drug Wholesaler Mr Koomson provided Money Laundering Services for Local Judges and Local Police in the area where the 3 Nkrumah Children lived. Judges gave him the Device Theft Contract. Responsible Father, Citizen Mr Nkrumah, provided Care Services for them because the Chronically Immature Mother, Ms Laetitia Mukasa, could not cope. The Drug Wholesaler used the Immature Mother and a Private Landlord as Theft Agents. Everything that could go wrong for the Fraud Conspirators did go wrong. The Device Theft was a success. The Device Disposal was a failure. The Private Landlord put the Stolen Devices in a House Clearance Skip. A Stolen Device Location Report from a Friend and Stolen Goods Recovery Help Request from Citizen Mr Nkrumah got a Goods Recovery Meeting with the Metropolitan Police, and use of it for a Goods Recovery Refusal + Fraud Arrest. It added to the Fraud Conspiracy Proof. The Drug Wholesaler prostituted the Immature Mother and used her to prostitute the 14 years old girl, who soon tired of making Pimp Profits for them. She wanted the Respectable Father to accept her Respectable Boy friend and provide Care Services for her and her two younger brothers.

The Original Crimes Exposure + Special Protection Frauds + Child Prostitution Protection Frauds. The Fraud Conspirators needed to separate the 3 Nkrumah Children from the Respectable Father and provide Child Prostitution Protection Fraud for the Immature Mother and Drug Wholesaler. A Rape Framing Fraud Conspiracy needed the Immature Mother to use Child Care Events. She needed Total Supervision that could not be provided in the Child Care Events. She gave herself away at every stage of the process. Under Age Sex Questions by the Responsible Father got Rape Complaint Fraud Blackmail by the Immature Mother, the Blackmail Complaint Statement dated 14<sup>th</sup> October 2024 by the Responsible Father and use of it as Investigation 01YE1544123 Additional Evidence by Citizen Mr Katsiaounis. It got Case References up the Command Chain. Commissioner Rank Police got Child Prostitution Protection Fraud Proof against Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer. Harassment Complaint Fraud 01KW635924 + Witness Protection Complaint Fraud 01KW104125 by the Immature Mother got Arrest Frauds + Investigation Frauds by the Metropolitan Police and Service Refusals by the State Prosecutors.

All Corruption Protection Frauds. The US Presidential Elect and UK Opposition Leaders used the Child Prostitution Scandal to get Blackmail Conditions that extorted Remedy Delivery Commitment from the Cabinet. It was Detailed Preparations and then Dismissal Executions against the Judiciary by Parliament on 14<sup>th</sup> July 2025, a Trial Listing of Framing Fraud 2023 0058 on 17<sup>th</sup> July 2025, and use of it for Corruption Exposure + Remedy Precedents + Mass Publicity. The Cabinet had No Remedy Intent. They procured the Harassment CM2590597 Restraint Frauds by the Immature Mother and Family Court as Set Up Conditions for Restraint Breach Framing Frauds against Citizen Mr Nkrumah. The Dismissal Failure Contingency Plan used the Framing Fraud Trial for a Case Collapse. The Cabinet needed to stop a Total Collapse of the Protection Fraud Network. They used the Trial End for a Restraint Breach Framing Fraud Arrest + Case Management Frauds by All Responsible Individuals + Remand Custody Frauds.

**Bail Applications** got Process Denial Fraud Proof for the Citizen against the Defender, S G Law, Prosecutor and Judges **Service Failures** by the Defenders got Termination Notices by the Citizen and a Secret Case Management Frauds by the Defender, Prosecutor and Judges that included a Secret Case Release Hearing for the Defender.

**Incomplete Disclosure** by the Prosecutor gave a Hearing Date Only and Hearing Denials by the Prison Authority. A 48 Hour Repeat Bail Application Notice Email got Notice Denial Frauds + Document Rejections by Judge Green and then use of the Case Release Hearing for Bail Application Processing + Bail Hearing Adjournment to 8<sup>th</sup> October 2025.
