Ruin Fraud Conspiracy Motives

- First Motive: Cabinet Corruption Concealment that used Ruin Frauds against Mr Nkrumah
- Second Motive: All Prior Frauds + Ruin Fraud Conspiracy Concealment that used Evidence Thefts.
- Third Motive: All Prior Frauds + Child Prostitution Protection Frauds for the Evidence Theft Manager, Drug Wholesaler Mr Koomson, and Evidence Theft Agent, Chronically Immature Mother of the 3 Nkrumah Children, Ms Laticia Mukasa who prostituted the 14 years old daughter. She soon tired of making Pimp Profits. She wanted her father to accept her Respectable Boy Friend and provide Care Services for her and her two brothers. The Rape Framing Fraud failed because it relied on the Chronically Immature Mother. She relied on the Responsible Father for Child Care. She needed supervision that the Fraud Conspirators could not provide for the Child Care Events. She tried to get Electronic Records to support a Rape Framing Fraud. The question 'are you making electronic records' or something similar, got the immediate response 'not enough yet'. Under Age Sexual Activity Questions by the Responsible Father got Rape Framing Fraud Blackmail Threats by the Immature Mother, that got the Blackmail Complaint Statement dated 14th October 2024 by the Responsible Father. It was used for an Additional Evidence in Rape Framing Fraud Investigation 01YE1544123. It forced Case References up the Command Chain that enabled Commissioner Rank Police to get Child Prostitution Protection Fraud Proof against Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer.
- Fourth Motive: All Prior Frauds + Rape Framing Fraud Concealment. The Harassment Framing Fraud Complaint + Witness Intimidation Framing Fraud Complaint got Service Refusals by State Prosecutors.
- Fifth Motive: All Prior Frauds Concealment managed by the Cabinet. The US Presidential Elect Team, UK Opposition Leaders and Child Prostitution Scandal got Blackmail Conditions that extorted Remedy Delivery Commitments from the Cabinet. It needed Dismissal Executions against the Judiciary by Parliament on 14th July 2025, Victim Identification and Case Remedies. It needed the Crown Court Trial Listing of a Framing Fraud 2023 0058 on 17th July 2025 for Corruption Findings + Remedy Precedents + Mass Publicity. The Dismissal Failure got use of it for a Case Collapse. Trial Day 1 got Testimony Refusals by 6 out of 7 Event Witnesses and an Investigator Production Failure by the Prosecutor. Mr Nkrumah leaving the court building a free man risked a Total Collapse of the Protection Fraud Network. A Service Call by the Judiciary got Fraud Commitment Conditions for a Trial End Arrest Fraud + Custody Fraud by the Cabinet. On Trial Day 2 the 01YE1544123 Postal Charge by State Prosecutors and a Complaint Reference Notice from Enfield Council was Fraud Commitment from the State. On Trial Day 3 the Appeal Dismissal was Fraud Commitment Proof from the Judiciary. It got the Trial End Arrest Fraud + Custody Frauds.

Update

On 17th September 2025, the Rape + Sexual Assault 01YE1544123 Plea Hearing in Wood Green Crown Court 3 got Audio Records that are Personal Responsibility Proof against Prosecutor Mr Rosser and Judge Mr Dodd for Trial Fraud Blackmail. The Defence Document dated 12th September 2025 was acknowledge by the Prosecutor and Judge. It made a No Jurisdiction Plea + imposed an Evidence Production Condition for a Liability Plea + applied for a Validation Investigation + Contempt Investigation + Enquiry Orders. The 'barely comprehensible' comment was an Ignore It Instruction by the Judge to the Prosecutor. The No Jurisdiction Plea Refusal + Evidence Production Refusal + Investigation Refusals + Enquiry Refusals + State Approved Defender Appointment Demands + 28 Day Adjournment to 15th October 2025 were Trial Fraud Conspiracy Proof. The 01YE1544123 Next Hearing Notice dated 17th September 2025 for the Adjourned Plea Hearing is 7th December 2026. It is not for 28 days. It is for 446 days.

On 18th September 2025, the Imprisonment Fraud Release Claim got a Claim Acknowledgement + Documents request Email from the High Court Kings Bench Office to the Administration Court Office. It gets a Remedy Co-operation Presumption that Court Officers will service Integrity Tests of the Judiciary.
