- 2. Treason Standard Contempt by use of Cabinet Powers and Parliament Powers for service the Justice Process Contempt
- 3. Aggravated Treason Standard Contempt by use of the Treason Standard Contempt to provide Protection Frauds for Childhood Exploitation using Child Thefts + Child Trafficking + Child Prostitution in the UK, and abroad.

Brief Explanation with Full Particular Rights Reserved for the Claimant

The Land Frauds + Ruin Frauds + Domestic Frauds + World Peace Plan

- 1. Tenancy Forgery Complaints by Citizen Mr Nkrumah were a Land Frauds Exposure Risk for Cabinet Officers and the Judiciary. Ruin Fraud Service Calls by the Judiciary against Mr Nkrumah got Faming Fraud Services by Top Police. A Profit Share Demand by Top Police, Share Refusal by Cabinet Officers and the Judiciary got a Pending Profit Share Service Refusal by Top Police. Service Calls by Service Refusals by Competent Officers and Incompetent Services by Idiot Officers. The Seal Ink on Original Documents and Record Inconsistencies were Forensic Test Material for Fraud Investigations. The Network classified it as a Nuisance Case.
- 2. In January 2020, Mr Nkrumah discovered the Coronation Oath Enforcement Authority. He gave use of his cases to the Corruption Remedy Process they manage. The Case Papers evidenced it. The Network classified it as a Dangerous Case that needed Special Management. The Cabinet Officers and Judiciary made an Investigation Sabotage Plan. It needed Original Documents Theft and Electronic Devices Theft. They needed Theft Target Locations. Mr Nkrumah was homeless. He relied on friends for Sofa Services, and provided Care Services for the 3 Nkrumah Children, because the Chronically Immature Mother cannot cope.
- 3. In September 2020, a Hearing Event got production of Original Documents by Mr Nkrumah from a Big Blue Bag, a Theft Target Location Report from Court Officers, a Theft Order from the Judiciary and use of the Return Journey and a Theft Agent for a Big Blue Bag Snatch Theft outside Seven Sisters Railway Station.
- 4. The Electronic Devices Theft needed a Theft Manager could rely on Protection Frauds if anything went wrong. The Protection Fraud Network uses Police Officers to manage a Drug Distribution Business. Drug Wholesalers manage Local Supplies and provide Money Laundering Services for Local Police and Local Judges. Science Teacher Mr Benjamin Koomson was the Drug Wholesaler where the 3 Nkrumah Children lived. The Theft Conspirators gave him the Theft Contract. He used the Chronically Immature Mother and a Private Landlord as Theft Agents.
- 5. In November 2021, a Home Move by her and Tenancy Promise Frauds by the Private Landlord persuaded Mr Nkrumah to put his Case Records + Electronic Devices + Cash + Other Goods in the house for Immediate Theft. It got a Theft Success and a Disposal Failure. The Stolen Goods Dump in a House Clearance Skip got a Stolen Goods Location Report from a friend, a Good Recovery Help Request from Mr Nkrumah, a Skip Site Meeting, and use of it for a Stolen Goods Recovery Refusal + Assault Framing Fraud Arrest by the Metropolitan Police and Additional Framing Frauds. Everything that could go wrong for the Fraud Conspirators did go wrong. The Framing Frauds added to the Innocence Proof for Mr Nkrumah and the Guilt Proof against the Framing Fraud Conspirators. The Drug Wholesaler prostituted the Immature Mother. The Fraud Proof Sets got by Mr Nkrumah and others enabled the Coronation Oath Enforcement Authority to get a Viable Number of World Leaders to make a World Peace Plan.
- 6. December 2023 Week 2 got the G7 Summit and signatures to the World Peace Plan. It needed Sovereign States to achieve Total Destruction of the Protection Fraud Networks who managed Endemic Corruption, and thereby recover control of State Budgets. The UK was the Test Case used to discover how best to do it. UK Cabinet Members were UK Network Agents. The Schedule explains the World Peace Agreement.
- 7. December 2023 Week 3 got Panic Reactions by the Protection Fraud Network. They needed Sabotage Frauds to prevent Remedy Co-operation by Victim Groups. A Business Expansion Plan had used Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States. It needed a Business Priming Case to identify and reward Corrupt Professionals and identify and penalize Honest Professionals. The Business Priming Cases was against Mrs Androulla Theodorou and the 6 Theodorou Children. It got 6 Care Budgets. 3 out of 4 Cypriot Grand Parents got use of Cyprus for Expatriation Frauds against 4 of the Theodorou Children. It got Money Laundering Services from a Sovereign State for Cabinet The Provider knows that use as evidence of anything, that is known to be false, or not believed to be true, incurs Perjury Liability. Officers and Top Judges. The Cyprus Constitution has a Blood Relative Limit on the Child Placement Powers of the Law Courts. A Corrupt Deal got Fraud Co-operation from the Criminal Father and Paternal Grand Parents for State, in exchange for Divorce Property Frauds by the Law Courts for the Criminal Father against the Normal Mother, and Child Care Profits for Paternal Relatives. The Expatriation Fraud Conspiracy Proof included an Expatriation Condition that required Case Supervision by the Cypriot Courts, an Expatriation Agreement between Enfield Council and Cypriot State Officers that denied it, that was Condition Breach Contempt Fraud Conspiracy Proof against Council Officers, and Contempt Immunity Fraud Proof against the UK Law Cours. Case Management got Fraud Proof Set for the Normal Mother against the Criminal Father, State and Law Court, on average once a month for 10 years from 2014 to 2024. The Network needed Sabotage Frauds to stop Remedy Cooperation by the 6 Children, Normal Mother and Maternal Grandfather. All of the children had suffered Corruption Damage. Child Victims sometimes become Adult Abusers. Sex Predation gets Sex Predators. Court Fraud Predations get Court Fraud Predators. The Eldest Daughter had suffered Special Damage. It substituted Spinal Scoliosis Care by a World Leading London Hospital for that of Limassol Hospital. Training Sessions for Local Doctors were Torture Sessions for her. She understood the Court Fraud Predation against her and decided to become a Court Fraud Predator. She was a University Law Student.

- December 2023 Week 3 got Career Bribery and a Rape Framing Fraud and Complaint Fraud by the Eldest Daughter against the Maternal Grandfather, who was 83, and Investigation 01YE1544123. Everything that could go wrong for the Protection Fraud Network and Framing Fraud Conspirators did go wrong. The Bail Conditions denied him access to the Fraud Proof Sets got by his daughter. Production Demands by the Maternal Grandfather for Corruption Proof as Defence Evidence got Evidence Production Denial Frauds + Recorded Interview Denial Frauds + Case References up the Command Chain. They got Fraud Conspiracy Proof against the Investigators and Defenders. Fraud Remedy Claims got Protection Fraud Proof against them and the Law Courts. Evidence Offers by Citizens got 01YE1544123 Additional Evidence Notices by the Maternal Grandfather. The Evidence Offer from Mrs Theodorou, who was the mother of the Complainant and daughter of the Accused, was used for an Additional Evidence Notice. It got Case References up the Command Chain by the Investigator but No Response from him to Mrs Theodorou or the Maternal Grandfather. Bail Breach Allegations did get Email Contact between the Investigator and Mrs Theodorou, but the Evidence Offer did not. An Evidence Offer by Citizen Mr Nkrumah and an Additional Evidence Notice from the Maternal Grandfather got No Response to them from the Investigator. It enabled and forced Commissioner Rank Police to make Case References that got Protection Fraud Proof against the Cabinet. All of it created conditions for a New Child Prostitution Case and Additional Evidence Notices to service the Corruption Remedy Process and World Peace Plan.
- 9. The G7 Summit got the International Agreement for Remedy Enforcement against Fraud Profiteers. It got Damage Payments that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. The Scandal Exposure got an increase in the MP Retirement Rate, and Incredible Choice and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority, Premier Office for Sir Keir Starmer and Improved Cabinet Control for the Network.
- 10. Three Top Offices were held by Top Network Agents. They were Foreign Secretary Mr David Lammy, Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer.
 - 10.1. Tottenham MP Mr Lammy had identified the Tottenham War Veterans Social Centre as a Theft Target and was one of Land Theft Conspirators against the War Veterans Charity.
 - 10.2. Pontefract, Castleford and Knottingley MP Ms Copper was one of the Protection Fraud Managers for the Pharmaceutical Industry. They bought Market Frauds for Drug Treatment against Other Treatment. One was Protection Authority Governance Frauds against Homeopathic Medical Practitioners. In 2000, Corruption Complaints in more than 200 constituencies against the Osteopath Profess Authority got a Corruption Debate. An Investigation Commitment by Health Minister Ms Yvette Cooper got a Pending Investigation Adjournment. A Corrupt Deal got Parliament Protection Frauds for the Pharmaceutical Industry and Fraud Profits for Prime Minister Mr Blair and all of the other Protection Fraud Minders ever since. The Mid Bedfordshire MP helped get the Corruption Debate. A Mid Bedfordshire Constituent, Dr Spivack, was custodian of the Proof Set that got it. The Pharmaceutical Industry needed to neutralize the both MP and Constituent. They bought Career Sabotage Frauds against the MP and Career Benefit Frauds that got the seat for MP Ms Nadine Dorries. She was one of the Top Protection Fraud Minders of the Pharmaceutical Industry in the UK Parliament.
 - 10.3. Holborn and St Pancras MP Sir Keir Starmer has been a Career Network Agent. MP Mr Peter Mandelson was a Network Agent and a Cabinet Officer. In 2008, they had Keir Starmer appointed Director of Public The Provider knows that use as evidence of anything, that is known to be false, or not believed to be true, incurs Perjury Liability. Prosecutions. In 2024, the Network needed a Trusted Agent to be the UK Ambassador to the USA. They chose Lord Peter Mandelson. Protection Frauds by Keir Starmer included thousands of Imprisonment Frauds against both Guilty Victims and Innocent Victims. The Imprisonment Frauds continue against some in 2025.

- 11. The 2024 Parliament Session Grant required Remedy Delivery starting with 20,000 Imprisonment Fraud Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification, Case Remedies and Total Destruction of the Protection Fraud Network. The Cabinet Network Agents dare not service Remedy Delivery. 3,500 Guilty Prisoner Releases for the Overcrowding Reason instead of the Imprisonment Fraud Releases was Remedy Denial Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against the Prime Minister who days earlier had won a Landslide Election Majority. The Corruption Publicity was Bribery Questions of the Cabinet in the week before the Party Conference.
- 12. Meanwhile, the Drug Wholesaler and the Immature Mother knew they had Protection Frauds. They ignored the Remedy Process Notices of the Peace Plan and Dismissal Decision against the Prime Minister. After the 2024 General Election they made a Child Prostitution Plan for the 14 Years Old Girl. Investigation is needed to discover whether the Landslide Majority gave them the confidence to do so. They could not possibly have got the timing worse. The Child Prostitution Evidence helped with management of the World Peace Plan.
- 13. Good Management needed a Rape Framing Fraud to end Paternal Care before the start of Child Prostitution. The Paternal Care, that was far superior to Maternal Care, got a good relationship for the children and father. Bad Management got Behaviour Changes by the Girl and Immature Mother. It raised Reasonable Suspicions of Under Age Sex and a Rape Framing Fraud. The question by the Decent Father 'are you making electronic records' got the immediate response from the Immature Mother 'not enough yet'. The Rape Framing Fraud had failed. Under Aged Sex Questions by the Decent Father got a Blackmail Response from the Immature Mother. It used Rape Framing Fraud Threats to deter Under Age Sex Questions. The Blackmail Complaint Statement dated 14th October 2024 by the Decent Father, and use of it as Additional Evidence by the Accused, Mr Antonakis Katsioaunis, for Rape Framing Fraud Investigation 01YE1544123 got Case References up the Command Chain. It enabled Commissioner Rank Police to get Child Prostitution Protection Fraud Proof against Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer. The Drug Wholesaler and Immature Mother tried to get Protection Frauds from Local Network Agents. Complaint Frauds by the Immature Mother got Harassment Investigation 01KW635924 and Set Up Conditions for Witness Intimidation Investigations 01KW104125 that got Service Refusals by the Crown Prosecution Service. Soon afterwards, the Cabinet realized the need for a Risk Control against a Remedy Process Case Collapse on 17th July 2025. It needed New Framing Fraud against Citizen Mr Nkrumah. They got the Harassment Claim Fraud CM25F90597 + Restraint Hearing Denial Frauds by the Immature Mother and Family Court.
- 14. The World Peace Plan Test Case enabled special management of the Dismissal Decision against the Prime Minister. The New Child Prostitution Protection Fraud Proof was a Blackmail Tool. A Remedy Delivery Commitment by the UK Opposition Leaders enabled Blackmail that got and either Forced Remedy Delivery from the UK Cabinet, and Total Destruction of the Protection Fraud Network, or Corruption Proof that got a Parliament Session Refusal and Forced General Election with Corruption Publicity that got a Power Loss by them. Either way, the World Leaders needed to be involved. A Personal Relationship with US Presidential Elect Mr Trump enabled a UK Opposition Leader service the process. The New Child Prostitution Protection Fraud Proof was a Blackmail Tool.
- 15. In January 2025, the US Presidential Elect Team, UK Opposition and Child Prostitution Scandal got Blackmail Conditions and Remedy Delivery Commitments from the UK Cabinet.
- 16. The Remedy Delivery Set Up Conditions were:
 - 16.1. A Protection Fraud Investigation into Old Child Prostitution Cases,
 - 16.2. Identification of a New Child Prostitution Case,
 - 16.3. Use of 14th July 2025 for Dismissal Executions against the Judiciary by Parliament with Mass Publicity
 - 16.4. Use of 17th July 2025 for the Crown Court Trial of a Framing Fraud Case that had Protection Fraud Motive Proof against Cabinet Officers and the Judiciary, and Case Evidence that was Innocence Proof for the Victim and Framing Fraud Conspiracy Proof against the Witnesses, Complainant, Investigators, Prosecutors, Defenders and Adjudicators. Use of the Framing Fraud Case:
 - 16.4.1. In the event of Dismissal Executions, for Corruption Findings + Remedy Precents + Mass Publicity 16.4.2. In the event of a Dismissal Failure, for a Case Collapse. The
 - 16.5. A Forced Transfer of the Protection Fraud Investigation into Old Child Prositution Cases from Own Force Investigators to Credibly Neutral Investigators with Mass Publicity
 - 16.6. A Protection Fraud Investigation of the New Child Prositution Case by Credibly Neutral Investigators The Provider knows that use as evidence of anything, that is known to be false, or not believed to be true, incurs Perjury Liability. Page 3 of 4

- 17. The Blackmail got Preparation Co-operation that was Delivery Pretence Fraud by the UK Cabinet.
- 18. The Framing Fraud 2023 0058 had Event Video Records that were Innocence Proof for Citizen Mr Nkrumah and Video Compilations, Case Records that were Fraud Conspiracy Proof against Witnesses, Complainant, Investigators, Prosecutors, Defenders and Adjudicators. It got the Trial Listing for Remedy Delivery.
- 19. The Network Cabinet Officers realized the Dismissal Failure Contingency Plan needed a Counter Plan. They needed a Custody Fraud to stop Citizen Mr Nkrumah leaving the court building a free man after a Case Collapse. They wanted a Custody Fraud before the Framing Fraud Trial. They procured the Harassment Claim Fraud CM25F90597 + Restraint Application Frauds + Hearing Denial Frauds + Without Hearing Restraint Frauds by the Immature Mother and the Family Court. It prepared for a Restraint Breach Framing Frauds that was supposed to get a Custody Fraud. On Saturday 5th July 2025, the Immature Mother took the children to visit the Paternal Grandmother and said the Children and Decent Father could have contact provided she was not involved in the arrangements. The Boys relied on it to ask the Decent Father to attend Sports Day. He could not refuse. On 10th July 2025 the Sports Day Attendance got a Restraint Breach Complaint by the Head Master, Investigation 01KG1226225 and an Arrest Fraud. The Recorded Interview discovered a Forged Restraint Order. It did not stop the Charge Fraud. On 12th July 2025, the Custody Remand Hearing got exposure of Restraint Order Failures and a Release Decision. The Framing Fraud Conspiracy had failed to get anything that could be used for an Arrest Fraud. The Children sent Electronic Messages to the Decent Father. The New Framing Fraud Managers had nothing else. They used the Received Messages for Sent Message Order Breach Pretence Frauds + Investigation 01KG1230725.
- 20. The Dismissal Failure got the Case Collapse on Trial Day 1. It was a Testimony Refusal by 6 out of 7 Event Witnesses and an Investigator Production Refusal by the Prosecutor. A Case Collapsed risked a Network Collapse. A Service Call from the Judiciary got conditions that required Commitment Proof from the State and Judiciary before the Protection Frauds by the Cabinet. Trial Day 2 got Commitment Proof from the State. It was the 01YE1544123 Postal Charge by the Crown Prosecution Service against the Maternal Grandfather, and a Complaint Reference Notice from Enfield Council to Mrs Theodorou in response to a Fraud Complaint made months earlier. Trial Day 3 got an Appeal Dismissal Fraud as Commitment Proof from the Judiciary. It enabled the Magistrates Court to proceed with the Assault Framing Fraud Sentence Breach 2500034056 Case. The Trial End was immediately followed by the 01KG1230725 Detention Fraud and then an Arrest Fraud by the Framing Fraud 2023 0058 Arrest Officer. It serviced the Counter Plan against the Dismissal Failure Contingency Plan. The Framing Fraud Conspiracy included a Goods Accounting Denial Fraud + Goods Theft on 23rd July 2025 by the Custody Officer against Citizen Mr Nkrumah. He was not given any chance to get a Theft Complaints Record in the Transfer Process from the Station Custody to the Transport Custody. The Remand Hearing got a Reamdn Custody Fraud. The Prison Admission Process discovered the Goods Theft.
- 21. The Fraud Conspirators had Sentence Breach Case 2500034056 + Restraint Breach 01KG1226225 + 01KG1230725 Cases. They got Enthusiastic Court Frauds by the Investigators, Prosecutors and Defenders SG Law, against Citizen Mr Nkrumah.
- 22. The Dismissal Failure + New Framing Frauds + Custody Frauds got Remedy Denial Fraud Findings by the Crown and Parliament Sessions Court against the Cabinet and a Repeat Dismissal Decision against the Prime Minister.
- 23. 8th August 2025 got Audio Records that are Imprisonment Fraud Blackmail Proof against Judge Mr Greene and the Forced Transfer of the Rotherham Child Prositution Protection Fraud Investigation from South Yorkshire Police to the Serious Crime Squad. September 2025 started with Corruption Publicity that got the Forced Resignation from the Deputy Leader and the Forced Dismissal of the UK Ambassador to the USA, and Forced Preparations by the Governing Majority for a Leadership Contest against the Prime Minister. The choice is very simple. They will manage the Dismissal Execution against him and Remedy Delivery or face a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof that includes Child Prostitution Protection Fraud Proof. 17th August 2025 got 01YE1544123 Audio Records that are Trial Fraud Blackmail Proof against Judge Mr Dodd. They are Totally Inconsistent with the 446 Day Adjournment Notice issued that day. The Restraint Fraud Disclosure Order got Incomplete Disclosure Fraud Contempt and Secret Fraud Conspiracy Proof against the Defender, Prosecutor and Court, and a Secret Hearing Notice for 24th August 2025. It got an Audio Record of a Bail Application Judge Greene, and a Confidence Collapse and Release Effort Claims and a Bail Assessment Request to Pentonville Prison by him. The World Peace Plan used the Imprisonment Decision against Former French Leader Mr Sarkozy for an Imprisonment Precedent. The Restraint Breach Adjourned Bail Hearing is on 8th October 2025.
