This is an application by the Defendant - Citizen Prisoner A6885DP Mr Akwasi Nkrumah for the Magistrates Courts and Crown Courts to state a case for the opinion of the High Court on an appeal on a question of law or jurisdiction.

1. Decision under appeal in each of the cases

The Validation Investigation Denial Fraud + Corruption Case Priority Denial Fraud + Contempt Investigation Denial Fraud that would have discovered the Tenancy Forgery Complaint by Citizen Mr Nkrumah was a Corruption Exposure Risk. It motivated Protection Fraud Demands by Housing Officers and Cabinet Officers, Service Calls by the Judiciary that got Framing Fraud Services + Profit Share Demands by Top Police. Share Refusals by Cabinet Officers got a Pending Profit Share Service Refusal from Top Police. Everything that could go wrong for the Fraud Conspirators did go wrong. Service Calls by Court Officers got Service Refusals by Competent Officers and Incompetent Efforts by Idiot Officers. The Seal Ink on Original Documents and Electronic Records were Forensic Test Material for Fraud Investigations. The Cabinet Officers and Judiciary gave the case Nuisance Classification that needed Standard Management. In January 2020, the Citizen discovered the Coronation Oath Enforcement Authority. He gave use of his cases for the Corruption Remedy Process they manage. The Case Papers were Remedy Process Cases Notices. The Cabinet Officers and Judiciary gave the case a Dangerous Classification that needed Special Management. They made an Investigation Sabotage Plan. It needed Original Documents Theft and Electronic Devices Theft. It got Theft Successes. The Electronic Device Theft used a Drug Wholesaler as Theft Manager. He used the Chronically Immature Mother of the 3 Nkrumah Children and a Private Landlord as Theft Agents. It got a Theft Success. A Stolen Devices Dump in a House Clearance Skip was a Stolen Goods Disposal Failure. It created the need for another Framing Fraud Series. The Drug Wholesaler prostituted the Immature Mother, and used her to prostitute the 14 Years Old Girl. It created the need for another Framing Fraud Series. All of the Fraud Remedy Claims + Appeals added to the Fraud Conspiracy Proof. The Coronation Oath Enforcement Authority used Early Fraud Proof to get a World Peace Plan at the G7 Summit in December 2023. It needed Total Destruction of the Protection Fraud Networks that manage Endemic Corruption. The UK was the Test Case. It used the Late Fraud Proof to get Remedy Denial Fraud Findings against the Cabinet and Dismissal Decisions against Prime Minister Sir Keir Starmer.
