Upon reading the Claim Form + Emergency Application + Draft Orders that make Corruption Allegations: Tenancy Forged Tenancy Complaints by Mr Nkrumah was a Land Fraud Corruption Exposure Risk. It motivated Protection Fraud Demands by Housing Association Officers, Top Judges and Cabinet Officers that got Framing Fraud Services from Top Police. A Profit Share Demand by Top Police got a Profit Share Refusal and a Pending Profit Share Protection Fraud Service Refusal by Top Police. Incompetent Protection Fraud Efforts by Incompetent Police created the need to use a Drug Wholesaler for Evidence Thefts. The Drug Wholesaler used the Chronically Immature Mother of the Claimants 3 children as Theft Agent and then prostituted her. In 2023, the Coronation Oath Enforcement Authority used the Corruption Proof to get World Leaders to make a Peace Plan. It needed Sovereign States to achieve Total Destruction of the Protection Fraud Networks who manage Endemic Corruption, recover control of State Budgets and manage Corruption Remedies. The Peace Plan needed a Test Case to discover best management of the Control Recovery Process. The UK is the Test Case. An International Agreement for Remedy Enforcement against Fraud Profiteers got Damage Payments that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. The Scandal Exposure got an increase in the MP Retirement Rate, Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority and the Premier Office for Sir Keir Starmer, who is a Top Network Agent. He gave Network Agents many offices. The three most important were MP Ms Yvette Cooper as Home Secretary, MP Mr David Lammy as Foreign Secretary and Lord Mandelson as UK Ambassador to the USA. The 2024 Parliament Session Grant required Remedy Delivery using 20,000 Imprisonment Fraud Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. It got Remedy Failures were Protection fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against the Prime Minister. The Landslide Majority got days earlier created the need for special management. The Dismissal Process Publicity was Cabinet Bribery Questions in the week before the Annual Conference of their Political Party. The Drug Wholesaler used the Immature Mother to prostitute the 14 years Old Daughter of the Claimant. Under Age Sex Questions by him got Rape Complaint Fraud Blackmail by the Immature Mother. The Blackmail Complaint Statement dated 14th October 2024, and use of it as Additional Evidence by Citizen Mr Katsiaounis in Rape Framing Fraud Investigation 01YE1544123, got Case References up the Command Chain. Commissioner Rank Polices used it to get Child Prostitution Protection Fraud Proof against the Home Secretary and Prime Minister. The 14 years Old Girl soon tired of making Prostitution Profits for the Drug Wholesaler and Immature Mother, needed the Claimant's help to give evidence against them. She wanted him to accept her Respectable Boyfriend and resume the provision of Care Services for her and her two younger brothers. The Child Prostitution Protection Fraud Proof against the Cabinet was Relevant Evidence for the Dismissal Process against the Prime Minister. In early 2025, the US Presidential Elect Team, UK Opposition Leaders and Child Prostitution Scandal got Blackmail Conditions that extorted Remedy Delivery Pretence Frauds from the Cabinet. They were All Necessary Preparations and then Remedy Delivery. It needed on 14th July 2025, Dismissal Executions against the Judiciary by Parliament and on 17th July 2025 a Crown Court Listing of a Framing Fraud Trial for a Corruption Findings + Remedy Precedents + Mass Publicity. The Framing Fraud 2023 0058 against the Claimant was chosen because the Event Videos were Innocence Proof for him. The Case Records were Fraud Conspiracy Proof against everyone else. The Blackmail got Remedy Delivery Preparations and Remedy Sabotage Frauds by the Cabinet. The Sabotage Frauds included use of Harassment CM25F90597 Restraint Frauds by the Immature Mother and Family Court that prepared for Restraint Breach Framing Fraud with intent to get a Remand Custody Fraud before the 2025 0058 Trial. They got the Set Up Conditions but not the Remand Custody. The Coronation Oath Enforcement Authority had a Dismissal Failure Contingency Plan. It included preparations that would get Total Collapse of the 2023 0058 State Case. Trial Day 1 got Testimony Refusals by 6 out of 7 Event Witnesses and an Investigator Production Refusal by the Prosecutor. It motivated Protection Fraud Demands by the Judiciary. The 01YE1544123 Rape Charge Fraud and 2023 0058 Appeal Dismissal Fraud were Commitment Proof from the State and Judiciary that got use the Protection fraud from the Cabinet. It was use of the Restraint Breach Framing Frauds for the Arrest Fraud + Detention Fraud + Charge Fraud + Remand Custody Fraud. The Dismissal Process against the Prime Minister used September 2025 Corruption Publicity to get the Forced Resignation of the Deputy Prime Minister, Forced Cabinet Reshuffle, Forced Dismissal of the UK Ambassador to the USA and Forced Leadership Contest Preparations. Upon the High Court 2023 + 2024 Cases and Court of Appeal cases in 2023 and 2024 001156 being Relevant Evidence
