Applications of the Citizen for:

- 1. Conflicted Interest Finding + Remedy Only Jurisdiction Limit Finding + Validation Investigation Order + Contempt Investigation Order + Unconditional Bail for Citizen Mr Nkrumah against the State for the REASONS:
 - 1.1. The 2023 World Peace Plan need the Sovereign States to manage Total Destruction of Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, deliver Corruption Remedies and manage World War III Defences. It needed a Test Case to discover beast management if it. The UK is the Test Case. It got Enthusiastic Commitment Proof from some of the Signatory States. Others needed Remedy Process Proof from the UK to give Plan Commitment Proof. Corruption Remedies needed a Custodial Imprisonment Precedent against Corrupt Judges and Corrupt Leaders of the Plan Signatory States.
 - 1.2. The Parliament Session Court used the Framing Frauds against Citizen Mr Nkrumah to service Remedy Delivery. It needed Dismissal Executions on 14th July 2025 against the Judiciary by Parliament, and use of Framing Fraud 2023 0058 Trial on 17th July 2025 for a Corruption Finding + Remedy Precedents + Mass Publicity. Remedy Failures by the Cabinet got Dismissal Decisions against Prime Minister Sir Keir Starmer. The Restraint Breach Framing Fraud + Remand Imprisonment Fraud against Citizen Mr Nkrumah were an Aggravating Factor.
 - 1.3. All Cases got Fraud Proof for Citizen Mr Nkrumah against the State and Law Courts. On 8th August 2024, the Restraint Breach Framing Fraud Plea Hearing got Audio Records that are Trial Fraud Proof against Judge Mr Greene. Case Sabotage Frauds by Defender SG Law got a Dismissal Decision by Citizen Mr Nkrumah, and Contempt Remedy Application Process Denial Frauds and with Trial Fraud Blackmail using Remand Imprisonment Threats to support Appointment Demands for a State Defender with a Legal Aid Order.
 - 1.4. On 8th August 2025, the Remedy Process got a Forced Transfer of the Rotherham Child Prositution Protection Fraud Investigation from South Yorkshire Police to the Serious Crimes Squad. State Officers who had Personal Liability for Child Prostitution Protection Frauds needed serviced realized they needed Immunity Deals. They needed Big Scale Negotiations managed by Trade Unions and Political Parties.

On 15th August 2025, a Connected Case, the Rape Framing Fraud 01YE1544123 got a Committal Hearing that added to the Trial Fraud Conspiracy Proof for Citizen Mr Katsiaounis against Dismissed Defenders, Prosecutors and Judges. They were Validity Investigation Denial Frauds by the State and Magistrates Court and a Defender Status Pretence Fraud by the Tucker Solicitors. Representative. An Identification Request by the Citizen got an Identification Refusal + Laughter by the Tuckers Representative. A Service Request got a Legal Aid Application by Defenders Duncan Lewis. A Representation Request by Citizen Mr Nkrumah on Case Management Instructions Conditions got a Service Refusal by Duncan Lewis against both of them. Service Request with Case Instructions got Service Denial Fraud Proof against State Approved Defenders.
 - 1.6. The September 2025 Corruption Publicity serviced a Dismissal Decision by the Parliament Sessions Court against Prime Minister Sir Keir Starmer. It got a Forced Resignation from the Deputy Prime Minister, the Forced Dismissal of the UK Ambassador to the USA, and Leadership Contest Preparations by the Governing Majority. The choice for them is to manage Dismissal Executions against the Prime Minister and Judiciary or face a Dismissal Execution against them by the Electorate.
 - 1.7. On 17th September 2025, Rape Framing Fraud 01YE1544123 got Audio Records that added to the Fraud Conspiracy Proof for Citizen Mr Katsiaounis against the Prosecutor Mr Rosser and Judge Mr. Dodd. The Court Interpreter had a Greek Dialect that Greek Cypriots could not easily understand.
