For the REASON from the Magistrates Court gets the Invalidity Counternotice + Fraud Complaint dated 20th October 2025 from Citizen Mr Katsiaounis

for the STATED REASONS and Without Prejudice to Other Invalidity Reasons that:

1. In Week 2 of December 2023, the G7 Summit got a Peace Agreement. It required Signatory States to stop Endemic Corruption, recovery control of State Budgets and fund World War III Defences. The Remedy Management Agreement got Test Case Status for the UK, and test Manager Status for the Coronation Oath Enforcement Authority. The International Agreement for Remedy Enforcement against Fraud Profiteers got Damage Payments that funded the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal
2. In Week 3 of December 2023, the Protection Fraud Network made a Remedy Sabotage Defence Plan and Damage Mitigation Plan. They used Sabotage Frauds against Victim Unification in Key Cases. Business Expansion Plans needed a Priming Case to identify and reward Corrupt Professionals and identify and penalize Honest Professionals. One of the Business Expansion Plan was for Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States. The Business Priming Case was by the Criminal Father, Mr Theodorou and Enfield Council against the Victim Mother, Mrs Androulla Theodorou and the 6 Theodorou Children. A Corrupt Deal got Fraud Co-operation from the Criminal Father and Criminal Paternal Grandparents for Enfield Council in exchange for Child Care Profit Frauds for Paternal Blood Relatives + Divorce Property Frauds for the Criminal Father against the Victim Mother. The Cypriot Constitution imposed a Blood Relative Limit on the Child Placement Powers of the Cypriot Courts. The Expatriation Agreement between the Cypriot State Officers and Enfield Council included the Wish List of Enfield Council that included Case Supervision by the Cypriot Law Courts and No Obligation Condition for the Cypriot State. The Final Care Order included Expatriation Permits for 4 of the 6 Children that were conditional on Care Supervision by the Cypriot Law Courts. The Expatriation Agreement, Final Care Order and Actual Expatriations are Contempt Fraud Conspiracy Proof against Enfield Council and Guilty Individuals, and Contempt Immunity Fraud Proof against the UK Law Courts and Guilty Individuals. It was a Key Case. They needed a Sabotage Fraud against Victim Unification.
3. Influence Frauds got the Rape Complaint Fraud from the 19-Year-Old Maternal Granddaughter, Miss Sophia Theodorou against the 83-Year-Old Maternal Grandfather, Mr Antonakis Katsiaounis. Investigation 01YE1544123 Investigation Production Demands by him got Fraud Conspiracy Proof against the Complainant, Investigators, Defenders, Prosecutors, Law Courts and Cabinet. The Blackmail + Child Prostitution Complaint dated 14th October 2025 of Citizen Mr Nkrumah supported the Production Demands by Citizen Mr Katsiaounis for the Child Prostitution Protection Fraud Proof. It enabled Commissioner Rank Police to get Child Prostitution Protection Fraud Proof against Home Secretary Ms Cooper and Prime Minister Sir Keir Starmer.
4. In early January 2025, the Coronation Oath Enforcement Authority, USA Presidential Elect Team, and UK Opposition Leaders used the Child Prostitution Scandal to extort Remedy Delivery Commitments from the Cabinet. They required Dismissal Executions against the Judiciary on 14th July 2025, and other things including the Trial Listing on 17th July 2025 of Framing Fraud 2023 0058 to use, in the event of Dismissal Executions, for a Corruption Finding + Remedy Precedent + Mass Publicity, in the event of a Dismissal Failure, a Case Collapse + Network Collapse. Trial Day 1 got the Case Collapse. Trial Day 2 got the 01YE1544123 Charge Fraud as some of the Commitment Proof from the State. Trial Day 3 got an Imprisonment Fraud against Mr Nkrumah as Protection Fraud Proof from the Cabinet to stop his leaving the court building a free man getting a Network Collapse. The Magistrates Court used the 01YE1544123 Charge Fraud for a Title Pretence Fraud + Crown Court Committal Fraud on 15th August 2025. The Crown Court used it for the Plea Hearing Fraud on 17th September 2025. The Coronation Oath Enforcement Authority got the Audio Records, removed the Case File from the Crown Court View and issued a Next Hearing Notice for Day 446. The September 2025 Corruption Publicity got a Confidence Collapse and the Imprisonment Fraud Release on 8th October. The Crown Court used Forgery + Perjury + Contempt to get the Repeat Committal Fraud. The Appearance Refusal forces the Crown Court Judges to choose between Fraud Admissions + Just Remedies or a Bench Warrant Fraud that will get another Audio Record that is Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds.
