- 4. Evidence Audit for the Citizen against the State (All Evidence Seizures + Return Failures)
- 5. Old Case Re-openings + New Criminal Investigations for the Citizen against the State (Evidence Theft + Goods Theft + Criminal Damage + Ruin Fraud Conspiracies starting with Case Reopening an Intimidation Framing Fraud when he was 12 years old and including the Copyright Theft Framing Fraud that was motivated by his Sports Enhancement Drug Refusals)
- 6. Production Demands for the Citizen against the State of Corruption Proof as Defence Evidence
  Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective
  Corruption Allegations
- 1. A complex series of events created the need for Ruin Frauds against Citizen Mr Nkrumah to provide Protection Frauds for Crime Profiteers, State Officers, Law Court Judges and Cabinet Officers including Foreign Secretary Mr Lammy, Home Secretary Ms Cooper and Prime Minister Sir Keir Starmer.
- 2. There were two sets of Crime Profiteers. They were Local Crime Profiteers and the National Profiteers.
- 3. The Local Profiteers were the Chronically Immature Mother of the 3 Nkrumah Children and Ilford Drug Wholesaler Mr Benjamin Koomson. He provided Money Laundering Services for the Local Police and Local Judges who provided Local Protection Frauds. He got an Evidence Theft Contract from the National Crime Profiteers, used the Chronically Immature Mother as Theft Agent, prostituted her, and in 2024, used her to prostitute the 14-Year-Old Daughter, and got Child Prostitution Protection Frauds from Local Police, Local Councils and Local Courts that had Child Protection Responsibilities.
- The National Crime Profiteers are the Protection Fraud Network. They use Corrupt Cabinet Officers and Corrupt Top Judges to manage a Protection Fraud Business and a Land Frauds Business. The Protection Fraud Business gets Fee Profits from the sale of Protection Frauds to Crime Businesses managed by State Officers and Law Court Judges. They were not satisfied with the Fee Profits. They wanted Management Profits. They created a Crime Business to manage Land Frauds. The First Business Expansion Plan was for Big Landowners against Small Businesses. The 2<sup>nd</sup> Business Expansion Plan was for the Network against the State and the People. Over the centuries, Citizens had created Housing Charity Trusts. Very often, Title Documents provided that a Trust Failure got a Title Reversion to the Donor Family. In time, the Charity Trustees appointed the Local Authority as the Trust Manager. The Charity Trustees died out, but the Donor Families did not. Everyone, except the Local Authority and Local Government Department, forgot about the Charity Trusts and Title Reversions. The Land Fraud Plan required the Housing Stock Transfers from Local Authorities to Housing Associations, destruction of the Charity Trust Proof, forgery of Replacement Title Proof, forced purchases of the Charity Trust Assets by the Housing Associations and Sale Price Payments to the Network Managers. The Business Expansion Plan used Research Cases to discover what was needed to manage Industrial Scale Frauds. It needed a Business Management System that serviced the Evidence Destruction used Acknowledgement Failures to service the New Evidence Exclusion Frauds needed to get Protection Frauds. It needed a Big Business to manage a Priming Case that identified and rewarded Corrupt Professionals and identifies and penalised Honest Professionals.
- 5. 3 Mergers got the London and Quadrant Housing Association and a Big Business for the Priming Case. Tenancy Forgery Complaints by Citizen Mr Nkrumah motivated Protection Fraud Demands by the Guilty Individuals that got Ruin Frauds against the Citizen. As Profit Share Demand by Top Police got a Share Refusal and Pending Profit Share Service Refusal by Top Police. Incompetent Efforts by Idiot Police created the need for Evidence Thefts. Drug Wholesaler Mr Koomson was the Theft Manager. He used the Chronically Immature Mother as Theft Agent, prostituted her, and used her to prostitute the 14-Year-Old-Girl and got Local Protection Frauds.
- 6. The Coronation Oath Enforcement Authority used the Ruin Fraud Cases for Top Level Corruption Investigations. In early 2025 they used the Child Prostitution Scandal to get Extortion Conditions that got Remedy Co-operation Commitments from the Cabinet. Remedy Failures got Corruption Findings against the Cabinet and a Dismissal Decision against the Prime Minister. The September 2025 Corruption Exposure serviced it.
