NHS Patient 6328556020 Mr Edward Ellis – Kidney Transplant Brief Update

22nd October 2025

On 15th October 2025, the Patient had Telephone Notice of Kidney Transplant Fitness Approval conditional upon an Extra Abdominal Blood Supply Scan by the Royal London Hospital. Notice Day 7 had got No Appointment Contact.

The Crown and Parliament Sessions Court need the Brief Update for two reasons. The first is that the Previous Transplant Assessment Denial Frauds + Slow Poison Record Denial Frauds + Extra Abdominal Scan Requirement + Royal London Hospital Scan Management + Appointment Communications Delay raises Reasonable Suspicions of a Transplant Denial Delay pending the Dismissal Process against Prime Minister Sir Keir Starmer. The second is a Slow Poison 2nd Crisis Recovery managed by the Patient. Previous Documents explained the Slow Poison 1st Crisis Recovery. The Transplant Fitness Conditional Approval enables this 1st Explanation of the 2nd Crisis Recovery.

The World War II Peace Settlement had a Fundamental Flaw. The Human Rights Declaration omits Case Priority Rights for the Victim and Citizen. The omission vested Case Priority Powers in the State. The Declaration Signatories gave and got Mutual Approval of Case Priority Powers. All of them used Case Priority Powers to develop Dictator Powers. The Politicians lost control of Dictator Powers to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Frauds Networks to provide Support Services and manage Co-ordinated Corruption. They manage Endemic Corruption in Western Democracies. Many of the Politicians thought State Bankruptcy was the only thing that would stop it. The UK is unique. The Coronation Oath Enforcement Authority has Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. It enabled the UK to make a Corruption Remedy Plan, get Viable Support from World Leaders, and make a World War III Peace Plan. In 2004, the preparations for the European Referenda got Election Fraud Proof against European Leaders. The Election

Fraud Concealment Plan got a Criminal Conspiracy Proof Set against them. The Coronation Oath Enforcement Authority used it to start a Corruption Remedy Process. Every stage of the process got Viable Support from World Leaders including a World War III Peace Plan. It needs Sovereign States to stop Endemic Corruption, recover control of State Budgets and manage World War III Defenses. In December 2023, the G7 Summit got the Peace Plan.

The Patient provided Investigation Services for every stage of the Remedy Process and Peace Plan. The Network made a Defense Plan against the Remedy Process. It used Health Frauds against the Patient.

In 2018, a Protection Fraud Conspiracy used a series of Transplant Assessment Denial Frauds when the Blood Pressure Fitness was a healthy 120/80. In December 2019, Prime Minister Mr. Johnson issued a 1st Poison Kill Order against the Patient. It used Slow Poison. Prior Notice of the Slow Poison Symptoms and the Remedy Action enabled the Patient to survive the 1st Crisis Week in February 2020.

In April 2020 the Patient had End Stage Kidney Failure. Dialysis Treatment enabled him to recover 120/80 Blood Pressure. It gradually declined to a less healthy 90/60. The Patient thought he had achieved a Full Recovery from the Slow Poison. He thought of the Slow Poison Symptoms as Kidney Failure Symptoms. Symptom Notices by the Patient got Record Refusals by Doctors.

In June 2022, the Dismissal Process against Prime Minister Mr. Johnson got a Leadership Contest. The Patient made an Immunity Rights Record for the Renal Team and prepared Integrity Tests for the Leadership Contest Month 2. The Network needed Sabotage Frauds against the Integrity Tests. They used a 2nd Poison Kill Order by Prime Minister Mr. Johnson. It used Destabilizing Chemicals, that flushed out of the system while a Biological Infectious developed and provided a Diagnosis Finding by Doctors. The Patient was lucky. The Saturday Dialysis Treatment Session got Illness Symptoms and a Case Reference by the Renal Team and an Emergency Bed Reservation.

In 2023, the Transplant Assessment Denial Fraud used GP Service Denial Frauds. The GP Practice made Identity Proof a Service Conditions. November 2023, Informal Contact got an Oral Admission by a Doctor that a Poison Symptom Record would get an Imprisonment Fraud against him.

In 2024, a Passport Application got Process Denial Fraud Proof against the Passport Office. It was an Identity Witness Rejection of the Renal Ward Manager who supervised the Dialysis Treatment of the Patient for more than 4 years. Replacement Identity Witness Consent from the Local Vicar discovered an Identity Witness Details ENTRY BLOCK on the Passport Application System, and use of it for a Timed-Out Application Dismissal.

Days later, the 2024 Parliament Sessions Grant Conditions included a Transplant Assessment.

The Slow Poison 2nd Crisis Self Help Remedy was Poison Releases through Skin Sites. It was a Chronic Sore Risk. A Release Termination Decision in April 2025 by the Patient got Different Processing by the body and Hydroscopic Solid Dumps in the Scrotum. The Self-Help Remedy was Scrotum Cuts + Water Flushing that got rid of it and a Dramatic Improvement in Skin Condition. The Patient kept quiet until he had the Fitness Conditional Approval conditional on the Extra Scan. The Premier Dismissal Process + Poison Damage Self Remedy are Safe Conditions for a Poison Damage Assessment by the Transplant Team
