Reasons

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. In 2004 they used Top Level Corruption Proof to start a Corruption Remedy Process. It has continued ever since. Every stage of it got Viable Support from World Leaders. They agreed that the World War II Peace Settlement had a Fundamental Flaw. The Human Rights Declaration omitted Case Priority Rights for the Victim and Citizen. The omission vested Case Priority Powers in the State. The Declaration Signatories gave and got Mutual Approval of the Constitutional Imbalance and used it to develop Dictator Powers for the State. The Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Frauds Networks to provide Support Services and manage Endemic Corruption. In December 2023 the G7 Summit got a Peace Agreement. It needed Sovereign States to achieve Total Destruction of Protection Fraud Networks, stop Endemic Corruption, recover control of State Budgets and resource World War II Defences. The UK is the Corruption Remedy Test Case. The Coronation Oath Enforcement Authority is the Test Case Manager. The International Agreement for Remedy Enforcement against Fraud Profiteers got the Damage Payments that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority and Premier Office for the Top Network Agent, Sir Keir Starmer, and Cabinet Office for other Network Agents. The 2024 Parliament Session Grant required Remedy Delivery starting with 20,000 Political Prisoner Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. Victim Prisoner Release Failures got a Remedy Denial Fraud Finding against the Cabinet and Dismissal Decision against the Prime Minister. In January 2025 the US Presidential Elect Team and UK Opposition Leaders used the Child Prostitution Scandal to extort Remedy Delivery Commitment Pretence Frauds from the Cabinet. The Delivery Failure Contingency Plan used the Trial Listing on 17th July 2025 of Framing Fraud 2023 0058 for a Case Collapse that risked a Network Collapse. The Cabinet used the Restraint Breach Arrest Fraud + Imprisonment Fraud to avoid a Network Collapse. The Failure Contingency Plan got a Corruption Finding against the Cabinet and Dismissal Decision against the Prime Minister, Forced Transfer of the Rotherham Protection Fraud Investigation from South Yorkshire Police to the National Crime Agency, and then the September 2025 Corruption Publicity + Family Court Scandal + Grooming Enquiry Scandal to service Dismissal Process against the Prime Minister. Meanwhile, Hearing Audio Records got Imprisonment Fraud Commitment Proof against Identifiable Individuals before the Corruption Publicity got a Confidence Collapse in the Imprisonment Fraud and a Rapid Release of Citizen Mr Nkrumah. The Application is a Remedy Test the Crown Court after the Imprisonment Release + Court Corruption Scandal + Grooming Enquiry Scandal + Sentence Breach Framing Fraud Case Withdrawal + Caerphilly By Election Defeat.
