 Davey for the Stated Reasons that:
 - 1.1. The Coronation Oath Enforcement Authority used the Ruin Fraud Series against Citizen Mr Nkrumah to service a Corruption Remedy Process. It used Corruption Investigations of the Authorities. Top Judges made an Investigation Sabotage Fraud Plan. It needed Co-ordinated Management of Evidence Thefts + Discredit Frauds against Citizen Mr Nkrumah. Everything that could go wrong for the Ruin Fraud Conspirators did go wrong. They used the Drug Wholesaler Mr Bejamin Koomson as Electronic Device Theft Manager. He used the Chronically Immature Mother of the 3 Nkrumah Children and a Private Landlord as Theft Agents. A Home Move by her and Tenancy Promises Frauds by the Private Landlord persuaded Citizen Mr Nkrumah to put all his Electronic Devices in the house and a Theft Success. The Basildon Railway Station Assault Framing Frauds was the Discredit Fraud. The Event Videos were Innocence Proof for Citizen Mr Nkrumah and Guilt Proof against the Framing Fraud Conspirators. British Rail Police held the Video Records. Essex Police were the Case Investigators. Days later the Crown and Parliament Sessions Court decided to use it for Remedy Delivery. The Stolen Device Dump in the House Clearance Skip was a Disposal Failure by the Private Landlord. A Stolen Goods Location Notice from a Helpful Friend got a Stolen Goods Recovery Help Request got a Stolen Goods Recovery Meeting at the House Skip Site and use of it for a Goods Recovery Denial Fraud + Assault Framing Fraud by the Metropolitan Police against Citizen Mr Nkrumah. Days later the Crown and Parliament Sessions Court decided to use it for Remedy Delivery. Drug Wholesaler Mr Koomson prostituted the Chronically Immature Mother.
 - 1.2. In 2023 the Coronation Oath Enforcement Authority got Corruption Proof against the UK Judiciary. They used it to persuade a Viable Number of World Leaders to make a Peace Plan. It needed Sovereign States to achieve Total Destruction of the Protection Fraud Networks that manage Endemic Corruption, recovery control of State Budgets and service World War III Defences. In December 2023, the G7 Summit got Agreement Signatures. The Remedy Test Agreement got Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority.
 - 1.3. In 2024, Drug Wholesaler Mr Koomson used the Chronically Immature Mother to prostitute the 14 Years Old Daughter, Miss Kenina Nkrumah. Underage Sex Questions by Citizen Mr Nkrumah got Rape Complaint Fraud Blackmail from the Chronically Immature Mother. The Blackmail Complaint Statement dated 14th October 2024 by Citizen Mr Nkrumah and use of it as Investigation 01YE1544123 Additional Evidence by Citizen Mr Katsiaounis got Child Prostitution Protection Fraud Proof against All Relevant Authorities. Commissioner Rank Police got it against the Cabinet. Days later the Crown and Parliament Sessions Court decided to use it for Remedy Delivery.
 - 1.4. In January 2025 the Coronation Oath Enforcement Authority used the USA Presidential Elect Team, UK Opposition Leaders and Child Prostitution Protection Fraud Scandal to extort Remedy Delivery Commitments from the Cabinet. The requirements included Corruption Investigations of the Family Court, preparations for the Child Prostitution Protection Fraud Enquiry, also known as the Grooming Enquiry, on 14th July 2025, Dismissal Executions against the Judiciary by Parliament and on 17th July 2025 a Trial Listing of Framing Fraud 2023 0058. It would be used in the event of a Dismissal Success for Corruption Findings + Remedy Precedents + Mass Publicity, and in the event of a Dismissal Failure for a Case Collapse that would trigger Total Collapse of the Protection Fraud Network.
 - 1.5. The Protection Fraud Network controlled the UK Cabinet. They had no intention of managing Remedy Delivery. They gambled on avoiding a Network Collapse. They required Fraud Commitment Proof from the State, Profession Authorities and Law Courts as a condition for Protection Frauds by the Cabinet.
 - 1.6. In February 2025 of Peter Mandelson, was appointed UK Ambassador to the USA. He was one of the Cabinet Officers who made a Career Deal with Keir Starmer. In 2008, it got the office of Director of Public

Prosecutions for Keir Starmer in exchange for Paedophile Protection Frauds + Other Frauds by him for the Protection Fraud Network. A Corrupt Deal by Peter Mandelson, and others, traded a Paedophile Minimal Sentence Fraud by USA Authorities for a Fraud Service Contract with Paedophile Mr Jeffery Epstein. It got Entrapment Services + Framing Fraud Services against Blackmail Targets by Mr Epstein for the Protection Fraud Network. It included Video Records on Plane Flights + Bedrooms + Anywhere Else. The Plane Videos got Brief Publicity but not the rest. Peter Mandelson was the Service Contract Manager.

- 1.7. The Protection Fraud Network and Cabinet needed NEW Child Prostitution Protection Fraud Proof against the Judiciary. Drug Wholesaler Mr Koomson used the Chronically Immature Mother, Ms Laetticia Mukasa to prostitute the 14 Years Old Daughter, Kenina Nkrumah. It was excellent for the purpose. It does not matter what the Supervision Judge and Case Judges knew at the time. The Harassment Claim CM2590597 got the New Child Prostitution Protection Fraud Proof against the Judiciary.
- 1.8. On 17th July 2025, the Framing Fraud 2023 0058 Trial Day 1 got a Case Collapse that a Collapse Risk for the Protection Fraud Network. It motivated Repeat Protection Fraud Service Calls by the State and Judiciary and Repeat Commitment Proof Requirements by the Cabinet. Trial Day 2 got Commitment Fraud Proof from the State. The Rape Framing Fraud 01YE1544123 Prosecution Fraud against Citizen Mr Katsiaounis, who is 85 years old, and the Fraud Complaint Reference Notice from Enfield Council to his daughter Mrs Androulla Theodorou. Trial Day 3 got Commitment Proof from the Judiciary. It was the 2023 0058 Appeal Dismissal Fraud. It got the Protection Fraud from the Cabinet. It was the Restraint Breach Arrest Fraud + Custody Fraud that stopped Citizen Mr Nkrumah leaving the Court Building. The Restraint Breach Remand Imprisonment Frauds got Audio Records that were Fraud Commitment Proof against the Judiciary.
- 1.9. The Dismissal Failure and Imprisonment Frauds got Repeat Protection Fraud Findings against the Cabinet and Repeat Default Dismissal Penalties against Prime Minister Sir Keir Starmer.
- 1.10. The September 2025 Corruption Publicity serviced the Dismissal Decisions against the Prime Minister. It got the Forced Resignation from the Deputy Prime Minister and Forced Dismissal of the UK Ambassador to the USA. It got a Confidence Collapse in the Rape Prosecution Fraud against Citizen Mr Katsiaounis and the Imprisonment Frauds against Citizen Mr Nkrumah
- 1.11. The Protection Fraud Network countered by reviving the Prince Andrew Scandal. It was too little and too late. The Remedy Process used the Family Court Corruption Scandal and the Grooming Enquiry Scandal. Thursday 23rd October 2025 got the Caerphilly By Election Defeat for the Cabinet and the Sentence Breach Trial Frauds started and then got the Surprise Case Withdrawal by Independent Counsel. On Wednesday 19th October 2025, the Probation Officer claimed to have 3 Inconsistent Trial Result Records one of which was a Conviction Record Fraud. It is Power Struggle Fraud Proof against the Law Courts.

 - 5.1. Details the Personal Identification and Professional Governance of everyone known to have serviced the claim in any capacity and what they did
 - 5.2. Details the work done and the charges and who paid how much and when
 - 5.3. Details when they first knew about a Conflict Disqualification from involvement in the case, and what each of them or anyone else did about it
 - 5.4. Details when they first knew about the Coronation Oath Enforcement Authority, Corruption Remedy Process, and World Peace Agreement,
