Contrary to section 1 of the Sexual Offences Act 2003.

On 20/12/2023 at Edmonton in the Borough of Enfield, being a person aged 16 or over, namely 83, intentionally penetrated the vagina of another person with a part of your body, namely penis and fingers that penetration being sexual and that person, aged 18 or over, was your granddaughter when you knew or could reasonably be expected to have known that she was related to you in that way

Contrary to section 64 of the Sexual Offences Act 2003.

On 20/12/2023 at Edmonton in the Borough of Enfield with intent sexually penetrated the vagina of a woman aged 16 or over with a part of your body, namely fingers when she did not consent and you did not reasonably believe that she was consenting Contrary to section 2 of the Sexual Offences Act 2003.

Between 18/12/2023 and 21/12/2023 at in the Borough of Enfield intentionally touched a woman aged 16 or over and that touching was sexual when she did not consent and you did not reasonably believe that she was consenting Contrary to section 3 of the Sexual Offences Act 2003.

On 20/12/2023 at No Fixed Abode in the Borough of Enfield with intent sexually penetrated the vagina of a woman aged 16 or over with a thing, namely your finger when she did not consent and you did not reasonably believe that she was consenting Contrary to section 2 of the Sexual Offences Act 2003.

On 20/12/2023 at LONDON in the Borough of Westminster intentionally touched a woman aged 16 or over and that touching was sexual when she did not consent and you did not reasonably believe that she was consenting Contrary to section 3 of the Sexual Offences Act 2003.
