The Crown and Parliament Sessions Court get the Discovery Benefits, if any. Remedy Proposal Copyright validates License Fee Waiver Offers that enable discovery what is done with Remedy Ideas.

The World War II Peace Settlement had a Fundamental Flaw. The Human Rights Declaration omitted Case Priority Rights for the Victim and Citizen. The omission vested Case Priority Rights in the State. The Declaration Signatories gave and got Mutual Recognition for Case Priority Powers, used them to develop Dictator Powers, and used them to sell Crime Protection Frauds. They managed Ruin Frauds against anyone who was an Exposure Risk or Remedy Risk. The result was Masked Dictator States and Blatant Dictator States. It made inevitable Civil Wars between the People and Dictators and World War III for Top Dictator Status.

Citizens made an Equity Governance Recovery Plan for the UK and Peace Plan for the World. Queen Elizabeth agreed with it. She and Citizens prepare to service it. The Ridicule Risk from the Ignorant and the Sabotage Risk from the Guilty were Operation Limits for the Remedy Plan Managers. In 2004, they used Top Level Corruption Proof and started a Corruption Remedy Process. Queen Elizabeth and Prince Charles presented Political Prisoner Proof at the next Commonwealth Conference and got Remedy Co-operation from World Leaders. It started with 40,000 Political Prisoner Releases and progressed to other things.

Russia and China made a World War III Plan. Arms Producer Investments got access to Sale Records that revealed Arms Reserves. Cyber Attack Investments got Arms Production Sabotage Capabilities. The Ukraine Invasion was to get a Blitzkrieg Success that forced Ammunition Reserve Exhaustion with Cyber Attacks preventing Arms Replacement and Forced Peace Terms. The Blitzkrieg Failure created the need for a Middle East War. The Mass Murder + 250 Hostages Seizure by Hammas was a War Provocation. It got + War Damage + War Victims + Plan Failure.

In 2023, the Remedy Process persuaded World Leaders to make a Peace Plan. It needed Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets and resource World War III Defenses. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. The Internation Agreement for Remedy Enforcement against Fraud Profiteers got Damage Payments that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. The Scandal Exposure got an increase in the MP Retirement Rate, and Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get Landslide Governing Majority led by Network Business Manager Sir Keir Starmer. The 2024 Parliament Session Grant required Remedy Delivery. It needed 20,000 Imprisonment Fraud Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. Delivery Failures got Remedy Failure Fraud Findings against the UK Cabinet and the Default Dismissal Penalty against Prime Minister Sir Keir Starmer. Crown Protection got Mass Publicity for Bribery Questions of the Cabinet in the week before their Annual Party Conference. The Church of England Scandal was that Crime Complaints by Victims and Bishops got Sex Crime Protection Fraud Proof against the State and Sir Keir Starmer when he was Director of Public Prosecutions.

Meanwhile, the 2024 USA Elections got an America First Commitment and Epstein File Exposure Commitment from Presidential Candidate Mr. Trump. He knew about the Peace Plan and Sex Scandal. It is unlikely he knew the Epstein Scandal was a Sex Scandal + Protection Fraud Scandal + Blackmail Scandal with Blackmail Customers who were Election Campaign Contributors and Blackmail Business Managers in the UK Cabinet. In January 2025, President Elect Mr. Trump assisted the UK Opposition Leaders use the Child Prostitution Scandal to extort the 2025 Remedy Promise Frauds from the UK Cabinet. Their priority was Epstein File Concealment with Peter Mandelson the Concealment Manager and the office of UK Ambassador to the USA a Concealment Tool. The 2025 Remedy Failures got Repeat Fraud Findings against the Cabinet and Repeat Default Dismissal Penalty against Prime Minister Sir Keir Starmer.
