

The 2023 World Peace Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority.

It is Well Established Convention that the Equity Lawyer takes the Criticism Risks for the Coronation Oath Enforcement Authority. It is a Risk Control against Adverse Criticism of the Crown and Parliament Sessions Court.

1. In December 2010 the G7 Summit got the Secret Signal that USA President Mr Trump and UK Prime Minister Mr Cameron had signed the Corruption Remedy Agreement. Efficient Management of the next stage of the Remedy Process needed the Secret Signal.
2. The First Presidency of Mr Trump got the Tax Haven Estate Documents Disclosure.
3. In December 2023, Citizen Mr David Cameron, a Former UK Prime Minister, acted as Negotiation Agent for King Charles. It got the World Peace Agreement. It is that Sovereign States destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority.
4. In January 2025, President Elect Mr Trump assisted the UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. It earned Enormous Respect from UK Citizens for the USA President Elect.

It discovered more than half were Network Agents or Network Puppets. Leadership Contest Deals got Cabinet Office for Network Agents in exchange for Support Votes. Peter Mandelson was the Top Network Agent. The UK Protection Fraud Network had a Costs Control Policy. Cabinet Officer + Top Agent Mr Mandelson managed Business Expansion Plans. One was to convert the Costs Control Policy into a Revenue Earner. The Paedophile Conviction of Mr Epstein was a Business Expansion Opportunity. It got a Minimum Sentence Protection Fraud for Mr Epstein in exchange for Blackmail Services for the Protection Fraud Network. Top Financiers provided Target Over Target Manager Lists and got Blackmail Service Deals with Peter Mandelson. Friendship Evidence enabled Introduction Offers by him to get Introduction Acceptances by Blackmail Targets, Invitations from Mr Epstein, Invitation Acceptance by Blackmail Targets and Hosting Events that got the Blackmail Evidence and Huge Profits that Blackmail Customers used to finance Election Campaigns.

Scandal Exposure gets a Network Connection Presumption for the People against Ministerial Office Holders that is subject to Rebuttal Proof Positive and the Rebuttal Failure Penalty of Obsolete Status. It creates the need for All Political Party Leaders in the UK and USA to manage Purging Operation against Network Agents. Purging Failures will get Network Connection Presumption against the Political Party Leaders.
