Dear Sir/Madam,

I understand that Worcester City Council has applied, or intends to apply, for a council tax liability order in my name. I write under my right to seek information prior to any summons or hearing.

1. Legal Authority

Liability orders are granted under Regulation 34 of the Council Tax (Administration and Enforcement) Regulations 1992. Once made, a liability order must be drawn up, signed, dated, and kept with the court's record. The recognised evidence of such an order is the signed court list held by the magistrates' court.

2. Clarification Sought

Before any hearing or summons proceeds, I require confirmation of the following:

- Whether any liability order already exists in my name in favour of Worcester City Council, and if so, the date it was made;
- Whether my name and details appear on the signed court list for any previous liability order applications brought by Worcester City Council;
- Confirmation that the court will provide a copy or certified extract of the relevant signed court list should the council allege that an order exists.

3. Purpose

This request is made to establish the accuracy of Worcester City Council's claim before any summons is issued and to ensure that no application proceeds without valid authority.

4. Request for Response

Please provide confirmation of the above within 14 days. Should no record exist, I ask that this be clearly stated, as any further claim by Worcester City Council would then be unsupported by law.

Dear Mollie

Thank you for placing the file on hold until Monday 26th January 2026. I confirm receipt of your letter and 'liability orders'.

Please note that I am actively reviewing my legal position, including serious concerns regarding procedural errors, lack of judicial oversight, and failure to serve correct paperwork. These matters go to the validity of the liability orders themselves.

To clarify, I am not insolvent. Any suggestion of insolvency proceedings will be vigorously opposed and may amount to harassment or an abuse of process given the disputed nature of the claim.

Disputed Liability and Enforcement Threat

Dear Mollie

Having reviewed your position, I must reiterate that I dispute the validity and enforceability of the alleged liability orders on both legal and procedural grounds. Your reliance on *R (Kofa) v Oldham MBC [2023]* is noted, but respectfully, it does not establish what you imply.

Kofa does not remove the requirement that the order was lawfully obtained, duly recorded, and issued following due process. In my case, all of these requirements remain in question.

- I have written confirmation from Worcester Magistrates' Court that no record of the liability orders exists.
- I personally attended the hearing where no adjudication took place and no opportunity was given to challenge the claim, present evidence, or cross-examine denying basic judicial fairness under Article 6 ECHR.
- The documents you provided are not consistent with what constitutes an order under the Magistrates' Courts Act 1980 and the Magistrates' Courts Rules 1981.

Bankruptcy is a serious and irreversible step, only available in cases where a debt is undisputed, liquidated and lawfully due. This matter is clearly under dispute. As held in *Re a Debtor (No 2021 of 1981)* [1981] 1 WLR 313, where a debt is disputed on substantial grounds, bankruptcy proceedings should not be used as a debt collection tool.

Additionally, *R v Brentford Justices ex parte Catlin* [1975] QB 455 remains binding authority that mass-produced or administratively rubber-stamped orders without proper judicial oversight are unlawful.

Accordingly, I request confirmation on the following:

1. That the orders were issued by a Justice of the Peace who was physically present and presided over a hearing;
2. That each order was formally entered into the court register;
3. That all provisions of the Council Tax (Administration and Enforcement) Regulations 1992 were lawfully complied with;
4. That enforcement action is being taken only after establishing legal certainty, not mere assumption of validity.

In the absence of these confirmations, I consider the threatened enforcement especially through bankruptcy to be premature, unlawful, and potentially abusive.

Please confirm that no further action will be taken while this dispute remains unresolved. I reserve the right to initiate a formal complaint and seek remedy should this matter proceed unlawfully.
