

Request for the Email Label Lawyers Wilkit Chapman Rollit Representative for the Email Address <mollie.denford@wcrlaw.co.uk>. It will eliminate the need for Manual Amendment of the Email Label in the early stages of the Case Log Research.

Request for the Bankruptcy Instructions Support Case Evidence provided by Worcester City Council for comparison with the Forgery Evidence provided by the Law Courts

Notice that the Case Log Update includes the email on 2026 02 02 at 17 18 from Equity Lawyer Mr Ellis + Responses from the State and Citizen. The Word is so that Bankruptcy Lawyers, Worcester City Council, Attorney General and Cabinet can make additions or corrections and then change the Document Label to show it is a Revised Document.

Notice that the Email Address 'Civilappeals.registry@hmcts.gsi.gov.uk' was in the Contacts of the Equity Lawyer, used to work but this time got Address Not Found. It was the Sole Response from the Law Courts. Royal Commission Emails from the Equity Lawyer get Notice Proof for the Coronation Oath Enforcement Authority against the Interested Parties, State, Law Courts, Cabinet and Parliament. He copies and pastes the Email Address List. It includes Court of Appeal <civilappeals.registry@justice.gov.uk> which gets Automatic Responses.

Notice that the Mandelson Scandal will get a Cabinet Collapse. In 2006, Corruption Proof got a Dismissal Process against Prime Minister Mr Blair. He signed a 10 Months Retirement Notice to avoid a Parliament Session Refusal and Corruption Publicity against him. The Notice Period enabled a Corruption Investigation. It discovered more than half the Governing Majority were Agents or Puppets of the Protection Fraud Network. Leadership Contest Deals traded Support Votes that got Cabinet Office for Network Agents. Network Agent Mr Peter Mandelson used Cabinet Office for Business Expansion Plans. The Paedophile Conviction of Mr Epstein was a Business Opportunity. Minimum Sentence Protection Frauds for Mr Epstein got Blackmail Services for the Protection Fraud Network. Network Agent Mr Mandelson was a Business Manager. He procured the Career Deal that got the office of Director of Public Prosecutions for Keir Starmer in exchange for Protection Fraud Services. One was the Disclosure Fraud by Cabinet Officer Mr Mandelson that got the Inadequate Evidence Case Closure Protection Fraud by Keir Starmer.

Notice that the UK Protection Fraud Network uses Court Buildings for Council Tax Trial Pretence Frauds and Liability Order Forgeries for Oppression Frauds against Citizens. No Case Record Confirmations from Worcester Law Courts was Liability Order Forgery Proof for Citizen Ms Davies against Worcester City Council. Forgery Proof Notices from her got an Unrecorded Enforcement Stop Order from Prime Minister Sir Keir Starmer to Worcester City Council. A Staff Change got a New Case Manager and Bankruptcy Enforcement Instructions to Regulated Lawyers. In 2025, the Ruin Frauds against Citizen Mr Nkrumah got Confidence Collapses by the State, Family Court and Criminal Courts. In 2026, it is very convenient to have the Bankruptcy Enforcement Fraud for a Confidence Test of Regulated Lawyers, Worcester City Council, the State and Law Courts.

Notice that the Ruin Frauds against Citizen Mr Nkrumah got Case Collapse Proof against the Protection Fraud Network. The September 2025 Corruption Publicity got a Confidence Collapse by the State and Judiciary. It is evidenced by the No Usable Evidence Notice from the State, the Remand Imprisonment Fraud Bail Release and by Child Care Help Request by the Chronically Immature Mother.

Notice that the Murder Conspiracy against Equity Lawyer Mr Ellis got Case Collapse Proof against the Protection Fraud Network. It is the Transplant List Blood Test Request dated 29th January 2026 from Royal London Hospital. On 24th November 2025 a Cancer Test Request by the Equity Lawyer got a Cancer Test Refusal + Mental Health Case Reference Fraud by the GP. The Poison Murder failed because the Low Blood Pressure Total Collapse was onto a Broomfield Hospital Dialysis Treatment Bed and got Immediate Recovery Services from the Renal Nurses. The Mental Health Fraud failed because 50 doctors and nurses in the Renal Team know they have Witness Status in a Murder Case and the NHS Patient 6328556020 Medical Records are Murder Conspiracy Proof + Murder Concealment Fraud Proof + Murder Survival Proof.

Notice that the End Stage Low Blood Pressure did Body Damage. Murder Survival got a Recovery Process. Dialysis Treatment gets Blood Quality Improvements and Body Repair Priority Decisions by the Subconscious that uses Chemically Induced Forced Sleep against the Conscious. A Gradual Recovery has enabled the Equity Lawyer to resume service of the Corruption Remedy Process.
