REASONS:

1. The Gas Charge Fraud Remedy Claim J00CM673 in the County Court + Contempt Claims 2022 002595 and 003098 in the High Court + Fraud Appeal 2023 000569 and other cases were used to get Endemic Corruption Proof against the Judiciary. The Crown needed it to negotiate the World War III Peace Plan. It is a Plan Agreement + Management Agreement + Remedy Agreement + Delivery Agreement. The Plan Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, and resource World War III Defenses and a Just World Order. The Management Agreement gets Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority. The Remedy Agreement gets Fraud Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement gets Delivery Commitments, some of which are conditional on Plan Successes.
2. In 2023, the Coronation Oath Enforcement Authority got completion of Endemic Corruption Proof against the Judiciary. King Charles used it to negotiate the World War III Peace Plan. Citizen Mr. David Cameron was the Negotiation Agent. The question Who Controls Your State by him got Power Boasts from G7 Democratic Leaders. He disclosed the UK has a Renegade UK Judiciary that uses Court Powers as a Private Business Tool, dumps Liability Costs on the Cabinet and makes Just Governance impossible. It got Same Problem Admissions + Peace Plan Agreement from the G7 Democratic Leaders and then Other Democratic Leaders.
3. The Peace Plan Agreement got International Support for Remedy Action by King Charles against the Protection Fraud Network that controlled the UK Cabinet. Damage Payments from Fraud Profiteers got Remedy Budgets for the Post Office Scandal + Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, and Impossible Choice and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority led by Top Network Agent Sir Keir Starmer and Other Network Agents. The 2024 Parliament Session Grant serviced a Dismissal Process against them It required 20,000 Political Prisoner Releases + Remedy Delivery. Grant Conditions Breaches got Remedy Denial Fraud Findings against the Cabinet and the Default Penalty of a Dismissal Process against the Prime Minister. King Charles persuaded US President Elect Mr. Trump to assist the UK Opposition Leader using the Child Prostitution Scandal in January 2025 to extort Remedy Delivery Commitments from the UK Cabinet that would get Corruption Proof against them. They needed Epstein File Concealment. They appointed Peter Mandelson the Concealment Manager and made him UK Ambassador to the USA. Remedy Delivery Failures by the UK Cabinet got the September 2025 Corruption Publicity against the UK Cabinet, Forced Dismissal of Lord Mandelson. Epstein File Forced Exposure got the Mandelson Scandal and Dismissal Process against the Starmer Cabinet.
4. The Gas Charge Fraud Damages Jury Trial will get a Remedy Precedent for the People against Big Business.
