- 2.20. The Indian Protection Frauds needed Death Inquest Delays in the Mother's Lifetime and then Probate Estate Representation Frauds and a Death Inquest Application Withdrawal Fraud and Body Remains Destruction Consent Fraud?
- 2.21. The Baby Mother's Will appointed Equity Lawyer Mr Ellis the Executor?
- 2.22. The Executor Appointment made the Equity Lawyer the Key Witness of the Probate Estate Representation Denial Frauds against him and Representation Fraud for Anyone Else?
- 2.23. Restraint Frauds against the Equity Lawyer were Representation Denial Fraud Proof against the Law Courts?
- 2.24. The Administration Records of the Equity Lawyer include a Mortgage Purchase Offer by the Baby Mother's Nephew that got No Response and Mortgage Possession Claim Fraud by Bank of Scotland?
- 2.25. The Mortgage Possession Claim Fraud used Estate Representation Denial Frauds against the Equity Lawyer and a Representative Appointment Fraud for the Mother Sister who did not have Case Management Capacity?

- 2.28. In 2023, King Charles used the Endemic Corruption Proof to negotiate the World War III Peace Plan Agreements. Citizen Mr David Cameron was the Negotiation Agent. The questions 'who controls your State' got Power Boats by Democratic Leaders. The disclosure that the UK has a Renegade Judiciary that uses Court Powers as a Private Business Tool and dumps the Liability Costs on the Cabinet got Same Problem Admissions + Peace Plan Agreement from Most Democratic Leaders?
- 2.29. The Peace Plan is a Plan Agreement + Management Agreement + Remedy Agreement + Delivery Agreement. The Plan Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, and resource World War III Defences and a Just World Order. The Management Agreement gets Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority. The Remedy Agreement gets Fraud Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement gets Delivery Commitments, some of which are conditional on Plan Successes?
- 2.30. Citizen Mr Cameron was given a peerage and the office of Secretary of State for Foreign Affairs. He and Prime Minister Mr Sunak got Agreements Signatures at the G8 Summit in December 2023?
- 2.31. The Peace Plan would require Effective Accountability for the Baby Murder Protection Frauds provided by the UK State and Indian States?
- 2.32. The Indian States is not a Peace Plan Signatory?
- 2.33. On the evidence available the need to avoid Effective Accountability for the Baby Murder Protection Frauds explains the decision of the Indian Leaders to side with China, North Korea and Russia against the Democratic States in World War III?
- 2.34. Remedy Delivery will inform everyone about Endemic Corruption and the Remedy Process managed by the Coronation Oath Enforcement Authority?
