

Notices that:

1. The Protection Fraud Network managed Endemic Corruption for so long that it has created the need for a Network Connections Purging Operation by All Political Parties
2. High State Office, Judicial Office, Ministerial Office, Network Policy Support and Big Election Funding Procurement get a Network Connections Presumption that is subject to Rebuttal Proof Positive.
3. A Network Connections Rebuttal Proof Failure gets Obsolete Status?

Purging Enquiry: Do you have Rebuttal Proof against a Network Connections Presumption?

Farm Frauds + State Murder against Charles Sydney Ellis Enquiries:

1. Do you admit, deny or require proof that:
  - 1.1. The Mandelson Scandal creates the need for Corruption Remedies that get Mass Publicity that explains the Constitutional Imbalances that got power for Network Agent Mr Mandelson when in office, out of it. It needs a Corruption Investigation into the Business Expansion Plan that used Court Powers to sell Land Frauds for a Big Owner against the Shropshire Farmer, Citizen Mr Charles Sydney Ellis, and the Land Fraud Concealment Plan that used Cabinet Powers for the Cancer Treatment Denial Kill Decision on 12<sup>th</sup> June 2009 against the Shropshire Farmer and the involvement of Network Agent Mr Mandelson in procuring the Kill Decision?
  - 1.2. The World War II Peace Settlement had a Fundamental Fraud. It omitted Case Priority Rights for the Victim and Citizen. The omission vested Case Priority Powers in the State. The Declaration Signatories gave and got Mutual Approval of Case Priority Powers for the State. All Signatories used them to develop Dictator Powers. The Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. The Protection Fraud Networks used Cabinet Offices and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. The Networks sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits for Fraud Services by Corrupt Parliamentarians. Corrupt Partnerships of Fraud Profiteers and Network Politicians traded Election Campaign Funding in exchange for Cabinet Office for Network Agents. The Election Funding Trades enabled the Protection Fraud Networks to get control of the Governing Majority and Opposition Minority?
  - 1.3. The 1992 General Election got what was a Surprise Defeat for the Labour Party. Young Labour Leaders realised their only hope of power was Leadership Frauds against the Labour Party Supporters that used the Third Way Policy Propaganda Frauds to get Moderate Conservative Votes. Mr John Smith was the Labour Leader and only one who had Ministerial Experience. He did not agree the Leadership Frauds. A Heart Attack Killed him. Later events raise Murder Suspicions?
  - 1.4. Mr Peter Mandelson was a Network Agent and one of the masterminds of the Third Way Frauds. The 1997 General Election got a Landslide Majority for the Labour Party, a Novice Cabinet, the Premier Office for MP Mr Blair and Cabinet Office for Network MP Mr Mandelson. In 1998, a Financial Disclosure Failure Fraud Scandal got a Cabinet Office Termination for MP Mr Mandelson, He continued as a Network Agent?
  - 1.5. In 2004, the preparations for the 2005 European Referenda got Election Fraud Conspiracy Proof against the European Leaders. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The European Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Drug Crime Framing Frauds + Imprisonment Frauds against 2 Managers of the Lawful Business. The Sabotage Frauds used Judge Trials of the Netherlands because Jury Trials of the UK were an Exposure Risk. The Dutch Trial needed an Extradition Fraud against the UK Citizen. The UK and Netherlands did not have an Extradition Treaty or time to make one. It used Armed Dutch Police on UK Soil to supervise UK Customs and Kent Police in a Kidnap Extradition Fraud against the UK Citizen. The EU Leaders and the Dutch Investigators did not know that a Drug Crime Complaint by the UK Citizen discovered he would have nothing to do with drugs for profit, when threatened with violence by Drug Dealers or under Police Supervision, and it got Incredible Target Status for the UK Citizen in Drug Crime Investigations. They did not know that Cabinet Officers and the Judiciary provided Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. They did not know they provided Protection Frauds for a Drug Crime Business managed by Top Police, Top Customs and Top Judges. They did not know the Drug Crime Business had used the UK Citizen's Address as the Decoy Address on the Carrier Movement Records of more than 70 Drug Shipments. UK Customs knew that All States had used Kidnap Extradition Frauds. It was the first Joint Kidnap Operation by EU States. They did not believe that is what it was. They knew a Drug Crime Complaint got Incredible Target Status for the UK Citizen. They believed he had discovered the Decoy

Address Frauds, made a Crime Complaint and was servicing a Decoy Address Investigation. They had a Drug Consignment in transit that used the Decoy Address. They made a Decoy Address Investigation Sabotage Plan. It used TV News Coverage for a Big Drugs Bust and International Co-operation and then took control of the Decoy Address Investigation. The UK Citizen was in a UK Prison with Jury Trial Rights and an Investigation Record that was Innocence Proof for him and Guilt Proof against the Framing Fraud Managers. The Kidnap Extradition Fraud had failed. The EU Leaders changed the Election Fraud Concealment Plan. It got Immunity Frauds for the Top Drug Dealers, Election Fraud Services for the EU Leaders, an Extradition Treaty for the UK and Netherlands, Hearsay Reports from the Civil Servants that the Home Secretary, Mr Blunkett, who was blind, signed the Extradition Treaty and the next document he signed was the 1<sup>st</sup> Extradition Arrest Warrant for the Extradition Fraud against the UK Citizen, a Network Business Profit Share for Prime Minister Mr Blair, Cabinet Control for the Protection Fraud Network, revived active service for the Coronation Oath Enforcement Authority and a Corruption Remedy Process for the People. It continues in 2026. Investigation is needed to discover what influence the Extradition Treaty + 1<sup>st</sup> Extradition Warrant had on the Blind Home Secretary when he wrote in his memoirs that he did not read everything he signed?

- 1.6. The Remedy Process Research Investigations got Corruption Proof against Fraud Profiteers and the State, Remedy Denial Fraud Proof against the Law Courts, Dismissal Decisions against the Judiciary, Dismissal Failure Protection Fraud Proof against the Cabinet and the Default Dismissal Penalty against Prime Minister Mr Blair. He signed the 10 Month's Retirement Notice to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for Corruption Proof against him. The Notice Period enabled use of the Leaders Contest for a Corruption Investigation of the Labour Governing Majority. It discovered more than half were Network Agents or Network Puppets. Leaders Contest Deals got Support Votes for Candidate MP Mr Brown and Cabinet Office for Top Network Agent MP Mr Mandelson and Other Network Agents?
- 1.7. Network Agent Mr Mandelson used Cabinet Office to make Business Expansion Plans for the Protection Fraud Network?
- 1.8. One Expansion Plan was for the Blackmail Business. It used Minimal Sentence Protection Frauds for Mr Epstein in exchange for Blackmail Services for the Protection Fraud Network. Takeover Target Manager Lists from Top World Financiers got Prices Negotiations and Blackmail Service Deals. Epstein Introduction Offers by Network Agent Mr Mandelson got Introduction Acceptances by the Target Managers, Invitation Offers from Mr Epstein, Invitation Acceptances by the Target Managers got the Hosting Events + Blackmail Evidence + Service Completion + Deal Profits?
- 1.9. Another Expansion Plan was the Court Fraud Business. The preparations for the Business Expansion Plan needed a Big Business to manage Research Cases to discover what was needed for Court Frauds on an Industrial Scale. In or about 1990, the sale of Town Centre Estates by the New Towns Commission to Land Securities got the Big Business. Talented Mr Jan Say had a Corby Town Centre Café, made Big Profits and paid All Taxes. The Local Managers made a Rent Increase Plan for the Corby Estate. It needed Possession Frauds against Mr Say, use of his Tax Accounts for a New Lease with a Higher Rent, and use of that for Rent Increases for All Tenants. Talented Mr Say defeated the Possession Fraud. Land Securities decided to use him for Court Fraud Research. They started every type of Land Fraud Test Case but did not complete any because they needed him in place for the Next Test Case. It got a complete set of Court Fraud Research Records for Talented Mr Say. He knew they were Fraud Records. Years later he discovered they were Research Records.
- 1.10. The Business Expansion Plan needed Priming Cases to identify and reward Corrupt Professionals and identify and penalise Honest Professionals, and Rapid Closure. The Town Priming Cases were by Land Securities against Small Business. Defence Management by Talented Mr Say denied Rapid Completion of the Business Priming Case and then completion of the Possession Fraud against Talented Mr Say and many others. He kept the Fraud Proof. In 2026 he lives. The Countryside Business Priming Cases were for Big Estate Owners against Farm Tenants. The Willaston Farm Case had Case Management by Farmer Mr Ellis and his brother, Equity Lawyer Mr Ellis. The Settlement Offer + Settlement Publicity got Case Closure Refusals by most of the Victim Farmers in England and Wales until they knew the outcome of the Willaston Farm Case. It denied Rapid Closure. The Plan Managers knew the Equity Lawyer would get Fraud Conspiracy Proof against the Insurers, Insurer Approved Professionals, Landlord, Landlord Professionals, Arbitrator and Law Courts. The 2009 Expense Account Scandal made it as High-Risk Case for the Network. On 12<sup>th</sup> June 2009 a Road Traffick Accident got Body Scan Proof that Farmer Mr Ellis had Oesophageal Cancer, and a Kill Order buy the Cabinet for Cancer Concealment Fraud + Treatment Denial Fraud. The Secret Service gave the Medical Record Murder Proof to the Crown for the Corruption Remedy Process. Mr Ellis died on 1<sup>st</sup> February 2013?
