 - 5.4. The Liability Trial Priority is Case Management Equality for the Case Parties. It requires:
 - 5.4.1. Use of anything that raises Management Incapacity Suspicions for or against the Case Parties for a Management Capacity Investigation, and in the event of an Incapacity Finding, an Incapacity Remedy.
 - 5.4.2. Separation of:
 - 5.4.2.1. Rights Definition Jurisdiction from Rights Enforcement Jurisdiction
