Reasons: The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was creation of Profession Authorities to manage Governance Frauds against Health Professions who provided Without Drugs Servicers. The General Osteopathic Council was one. In 2000, Governance Fraud Complaints in more than 200 Constituencies got a Corruption Debate in the UK Parliament, an Investigation Commitment from the Governing Majority, a Pending Investigation Adjournment, a Protection Fraud Sale from Prime Minister Mr Blair to the Pharmaceutical Industry and Governance Protection Frauds for all Profession Authorities ever since. A Market Fraud used the Patient Confidentiality Reason for a Patient Satisfaction Internet Publicity Prohibition Fraud against Registered Osteopaths and No Reason for a Confidentiality Waiver Denial Fraud against the Patient. Market Frauds Complaints by Osteopath Ms Davies motivated a Ruin fraud Conspiracy against her that used Profession Unfitness De-Registration Frauds + Court Frauds + Police Frauds that were Budget Frauds by West Mercia Police + Remedy Denial Frauds by the Police Governance Committee of Herefordshire, Shropshire and Worcestershire. It motivated a Pending Remedies Council Tax Payment Refusal by Citizen Ms Davies. It discovered that the Worcester Law Courts had No Record of Council Tax Enforcement Cases and the use of Council Tax Liability Order Forgeries by Worcester City Council. Enforcement Fraud by the Council got Liability Proof Production Demands by Citizen Ms Davies and either Enforcement Refusal by Bailiffs or Enforcement Instruction Withdrawals by the Council. Many other cases got Endemic Corruption Proof against the Judiciary.

It is necessary to explain the World War III Plan of China and Russia. In 2019, they wanted a Middle Eastern War to start the World War, the Ukraine Invasion to get a Blitzkrieg Success, exhaust the NATO Arms Stocks, Cyber Attacks to cut off the Replacement Supply and then Dictated Peace Terms. It failed. War Provocations got War Engagement Refusals by USA President Mr Trump. The Covid Emergency intervened. The week it ended got the Ukraine Invasion was a Blitzkrieg Failure and Arms Exhaustion Failure. Russia and China bought the Hamas Raid on Israel. They expected 250 Hostages would get a Crippled Response. It did not. It got Hostage Sacrifices + Hostage Production Demands + Massive Bombardment by Israel against the Gaza Strip, including Hostage Prisons. The intent was to deter anyone else from getting involved.

In 2023, it provided excellent conditions for King Charles to use the Endemic Corruption Proof against the UK Judiciary to negotiate the Democratic States World War III Peace Plan. Citizen Mr Cameron was the Negotiation Agent. He was given a peerage and the office of Foreign Secretary. He and Prime Minister Mr Sunak attended the December G7 Summit and got the Agreement Signatures. The Plan Agreement required Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Remedy Enforcement against Fraud Profiteer and

Penal Enforcement against Corrupt Leaders. The Delivery Agreement got Delivery Commitments some of which were dependent on Plan Successes. In January 2025, US President Elect Mr Trump acted as peace Plan Representative for the Signatory States when he assisted the UK Opposition Leaders using the Child Prostitution Scandal to extort Remedy Delivery Commitment from the UK Cabinet. It required 20,000 Political Prisoner Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. They were Commitment Frauds. Their Absolute Priority was Epstein Fine Concealment Frauds. They made Peter Mandelson the Concealment Manager and UK Ambassador to the USA. An Exposure Risk Briefing by him got Deal Negotiations and a Protection Fraud Network Crime Profit Share + Treason Bribery for US President Mr Trump on conditions that included Defence Sabotage Frauds by him against Ukraine, Western Europe and NATO.

It got Renegade President Status for him, denied use of him as a Peace Plan Agent and created the need to find another USA Peace Plan Agent. Anything he did that serviced the Peace Plan he did for himself, not the Peace Plan.

The Sabotage Frauds had the Reverse Effect of uniting Ukraine and Western Europe. Sovereignty Claims against Canada and Greenland were Sabotage Frauds that had the Reverse Effect of isolating the USA and uniting the other NATO Members. The Defence Sabotage Failures got Treason Bribe Payment Refusals by Russia and Angry Responses from the Renegade President. The Peace Plan found one Plan Service Managers in the USA.

It is necessary to explain how UK Politicians became involved in the Epstein Scandal. The UK Protection Fraud Network had a Costs Control Policy. It used Paedophile Entrapment and Paedophile Framing Frauds to get Blackmail Victims. It used Appointment Frauds for Blackmail Victims to get Puppet Officers and a Reliable Supply of Fraud Services at No Profit Share Cost. The Puppet Officers needed Constant Reassurance. They reassurance Proof they were given was Protection Frauds for Notorious Celebrity Paedophiles. MP Mr Peter Mandelson was a Network Agent. He helped get the 1997 UK Election Landslide Majority for Prime Minister Mr Blair, who was Totally Corrupt. He sold Policy Waiver Frauds. He gave Cabinet Office to MP Mr Mandelson, who dare not disclose he was a Network Agent because a Profit Share Demand by Prime Minister Mr Blair would get a Profit Share Reduction for the Top Agents. In 1998, a Network Revenue Disclosure Failure got a Forced Cabinet Office Dismissal against him. He continued as a Top Network Agent. In 2004, the preparations for the European Referenda got Election Fraud Proof against the European Leaders including Prime Minister Mr Blair. The Election Fraud Concealment Plan got exposure of the Protection Fraud Network and a Profit Share for Prime Minister Mr Blair. In 2006, Corruption Proof enabled the Coronation Oath Enforcement Authority to manage the Forced Dismissal against him. They required that he sign a 10 Months; Retirement Notice so they could use the Leadership Contest for an Integrity Investigation of the Governing Majority. It discovered more than half were Network Agents or Network Puppets. Prime Minister Mr Blair was one of the Top Network Agents who made Leadership Deals that got Support Votes for Candidate Mr Brown and Cabinet Office for Network Agents. The Top Agents wanted Business Expansion Plans without an increase in the Profit Share Claimants. In 1997, it got the Premier Office for MP Mr Brown and Cabinet Office for Top Network Agent MP Mr Mandelson. He used Cabinet Office for Business Expansion Plans. The Sex Crime Conviction of Mr Epstein was a Business Expansion Opportunity. Negotiations got Minimum Sentence Protection Frauds from the USA Authorities for Mr Epstein and Sex Crime Services from Mr Epstein and Sex Crime Blackmail Profits for the Protection Fraud Network. Takeover Target Manager Lists from Top World Financiers got Agreed Prices, introductions from Mr Mandelson, Invitations from Mr Epstein, disclosure of the Blackmail Evidence to the Blackmail Victims, an exchange of the Blackmail Evidence for the Agreed Price, Election Campaign Contributions on Protection fraud Conditions from the Top Financiers. The Epstein Scandal was Sex Crimes + Protection Frauds + Sex Crime Blackmail by UK Top Politicians for Top World Financiers who used Election Campaign Contributions to buy Protection Frauds.

In 2025 and 2026 the Peace Plan Managers got Epstein File Minimal Forced Exposure and Epstein File Maximum Concealment Frauds got the UK Mandelson Scandal and added to the Fraud Conspiracy Proof against the Protection Fraud Network and Renegade President. The Tariff Frauds got an Invalid Tariff Finding from the USA Supreme Court. The Forced Exposure, Continuing Concealment Frauds and Invalidity Finding were Peace Plan Successes that got Angry Responses from the Renegade President. He felt the need for Power Boasts. One was an Oil Tanker Seizure that was a Sanction Enforcement against Russia. Another used the Kidnapping Operation against the Venezuelan Presidency Usurper to get USA Puppet Status for the Elected President. It was not enough. He and Israeli President Mr Netanyahu needed a World War Victory to deter Treason Impeachments. They used Imminent Danger Pretence Frauds for War Frauds against Iran that got Forced Support from USA Allies. It had the Reverse Effect of uniting part of the USA Establishment, all USA Allies and Victim States in War Criticisms against the Renegade President. The only difference is the clarity with which the words 'War Fraud' + 'Treason Impeachment'.

The Peace Plan needs use of the USA Tariff Taxation Fraud and the UK Council Tax Liability Order Forgeries to set Indemnity Precedents for Liable Authorities against the Fraud Managers and Fraud Beneficiaries
