1. Investigation NX18MZP is of an Alleged Stop Failure + Alleged Driver Identification Failure
2. Citizen Mr Coyle parked the vehicle on the drive of 199 Winchmore Hill Road and left the keys in the house.
3. The Alibi Proof is that he was in Northern Ireland at the time of the Alleged Offence in Hertfordshire
4. The Case Possibilities are: Clone Vehicle + Unknown Driver - OR - Clone Key + Van Theft + Van Return + Unknown Driver - OR - Genuine Key Theft + Van Theft + Van Return + Key Return + Unknown Driver - OR - Allegation Fabrication by Hertfordshire Police that is a Fraudulent Breach of the Pending Remedies Enforcement Stay Protection from the Parliament Session Court for Citizen Mr Coyle against the State and Cabinet
5. The Alibi Notice did not get an Elimination Notice + Help Request. It raised Framing Fraud Suspicions
6. The Framing Fraud Investigation by the Equity Lawyer got Framing Fraud Conspiracy Proof for Citizen Mr Coyle and all who had access to the Genuine Key against Hertfordshire Police
7. The Coronation Oath Enforcement Authority has Corruption Remedy Test Manager Stus for the World War III Peace Plan States. They require Sovereign States to destroy the Protection Fraud Networks that manage Endemic and recover control of State Budgets. They recognise the Jurisdiction Separations of the Coronation Oath Enforcement Authority. The Citizen has Investigation Jurisdiction. It is the power to give a Confidentiality Waiver + Privilege Waiver + Case Priority Waiver from the Case Owner to the People. It enables use of the truth, whole truth and nothing but the truth about the Case Facts for Integrity Tests of the Authorities that get Proof Sets that meet the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers, or Guilt Proof against Corrupt Officers and Credibility Irrelevant Proof for the Victim. The Equity Lawyer has Test Manager Status. It is the competence and commitment to provide the Judgment Services needed for Integrity Tests that get Corruption Remedy Standard Proof Sets.
8. The Framing Fraud Investigation used Case Email Communication between the Case Officer and Equity Lawyer. It got a Case Meeting Agreement at Chelmsford Police Station on Sunday 15th March 2026.
9. It got Arrest Warrant Forgery Proof against Worcester Magistrates Court + Arrest Fraud Conspiracy Proof + Unlawful Arrest Investigation Denial Fraud Conspiracy Proof + Practice Code Fraud Conspiracy Proof + Bail Breach Framing Fraud Conspiracy Proof for Equity Lawyer Mr Ellis against Worcester Judges + Hertfordshire Police + Essex Unlawful Arrest Investigation Police for Equity Lawyer Mr Ellis against Essex Police + Hertfordshire Police.
10. The Arrest + Custody Process got Computer Records + Audio Records + Video Records are Practice Code Fraud Conspiracy Proof against the Hertfordshire Officers and Essex Officers. The Mandelson Corruption Investigation was the Top Credibility Test of the UK Authorities. The Audio Records include the Evidence Offer from the Equity Lawyer to the Peter Mandelson Case Investigations Officers that got an Evidence Rejection Rant by PC 411117 Mr Henry. He had 100% Interest in the Arrest Fraud + Zero Interest in the Motoring Framing Fraud NX18MZP + Zero Interest in the Top Credibility Test Case of the UK Authorities. The Annexe: The Mandelson Connection

The Protection Fraud Network used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. Top State Officers who were Network Agents had a Costs Control Policy. It needed a Minimum Profit Share for Top Politicians and Top Judges. It used Paedophile Entrapment and Paedophile Framing Frauds to get Blackmail Victims. It used Appointment Frauds for Blackmail Victims to Key Offices to get Reliable Fraud Services at No Profit Share Cost. MP Mr Peter Mandelson was a Network Agent. He helped to get the 1997 General Election Landslide Majority. It got a Novice Cabinet, the Premier Office for MP Mr Tony Blair and Cabinet Office for MP Mr Peter Mandelson. The Network had Business Expansion Plans that needed Cabinet Control and a Puppet Prime Minister as a Profit Share Control. Mr Blair was Totally Corrupt + Very Greedy + Too Powerful. In 1998, a Network Revenue Disclosure Failure got a Disgrace Dismissal against MP Mr Mandelson. He became a Top Network Fixer. In 2004, preparations for the European Referenda exposed the Protection Fraud Network and got a Profit Share for Prime Minister Mr Blair and Cabinet Control for the Network. Profit Share Controls limited use of it for the Expansion Plan. what they could do with it. In 2006, Corruption Proof got a Forced Dismissal of MP Mr Blair. He managed the Leadership Deal that got Support Votes for MP Mr Brown and Cabinet Office for Top Network Agents including MP Mr Mandelson. It got a Puppet Prime Minister + Cabinet Control + Business Expansion Plans. One used Minimum Sentence Protection Frauds for Mr Epstein in exchange for Support Services for the Sex Crime Blackmail Business with Mr Mandelson the Top Manager. It got Top Level Corruption Proof. The Coronation Oath Enforcement Authority used it start a Remedy Process. In 2023, the USA Pharmaceutical Industry used Network Agents Mr Mandelson and MP Nadine Dorries for the Crown Court Trial Fraud Bribery. The Worcester Judges needed to stop and Audio Record of the Fraud Testimony of Equity Lawyer Mr Ellis. They used Court Officers and West Mercia Police for Exclusion Frauds. The Court Officers needed an Immunity Deal to give Fraud Order Evidence against the Crown Court Judges. The Epstein Scandal got Mandelson Scandal + Public Misconduct Arrest. The Equity Lawyer used the Stop Failure NX18MZP for a Sensitivity Test. It got Bench Warrant Fraud Orders from Prime Minister Sir Keir Starmer.
