1. Sign the Formal Notice and ask the others to do so and Scan + Email the Signed Document to the Equity Lawyer
2. Give Email Notice of the Framing Fraud Crime Complaint + Formal Notice to the All Journalists who have expressed interest in the Theodorou Cases with a Copy Email to the Equity Lawyer
3. Give Telephone Notice to the Journalists who have had contact with her in 2026
4. Use the Email Notice and Telephone Notice to ask the Journalists:
 - 4.1. Do they admit, deny or require proof that
 - 4.1.1. The Protection Fraud Network needed Cabinet Control, with No Profit Share for a Puppet Prime Minister, to manage Business Expansion Plans?
 - 4.1.2. The 1997 General Election got a Landslide Majority, the Premier Office for Prime Minister Mr Blair and Cabinet Office for Network Agent Mr Mandelson, but did not get Cabinet Control needed for the Business Expansion Plans because a Profit Share for Prime Minister Mr Blair would have reduced the Profit Share for the Top Network Managers?
 - 4.1.3. In 2004, Corruption Exposure got a Profit Share for Prime Minister Mr Blair but Profit Share Refusal by Top Network Managers denied Cabinet Control?
 - 4.1.4. In 2007, Leadership Deals got Support Votes + Puppet Prime Minister Status for MP Mr Brown and Cabinet Office for Top Network Agent MP Mr Peter Mandelson and Cabinet Control?
 - 4.1.5. Mr Mandelson used Cabinet Control for Business Expansions Plans, one was Land Frauds for Big Owners against Small Businesses, and another was Sex Crime Blackmail, and when he lost office managed the Family Sabotage + Child Trafficking Business Expansion Plan?
 - 4.2. Will they admit they have a duty to bring the Framing Fraud Evidence to the attention of the Mandelson Case Investigators and get Mass Publicity for doing so?
