1. Formal Notice that
  - 1.1. The Framing Fraud Complaint Statement dated 18<sup>th</sup> March 2026 of Citizen Mr Coyle and Equity Lawyer Mr Ellis against Hertfordshire Police creates for Positive Action that services the King's Peace
  - 1.2. Positive Action that serves the purpose is to act as Notice Agent to the Party Leaders of the World War III Peace Plan Proposals of Equity Lawyer Mr Ellis
2. The World War III Peace Plan Proposals of Equity Lawyer Mr Ellis are

    - 2.5.2. The Impeachment Settlement be a Power Transfer for a USA Senate Coalition Committee against the Trump Team

      - 2.5.3.1. An Immediate Truce for the USA and Iran + Normal Business Activity

        - 2.5.3.3.3. An Invitation for Israel to become a Signatory to the World War III Peace Plan and make Delivery Commitments that start with an Immediate Termination of the Wester Heights Dispossessions and Immediate Return of Western Heights Land to Dispossession Victims
