Peace Plan Cases Notice

The Peace Plan Cases Notice is designed to service the Progress Report from King Charkes to the Signatory States. They need to know what impact Peace Plan Progress Reports have on Case Management by Fraud Managers and Fraud Beneficiaries. The Cases Explanations were Progress Reports. This is the first time the phrase 'Peace Plan Progress Report' has been used. The Signatory States are very familiar with the words in italics. They need to know the Case Managers have the words in italics and the words in normal type that follow

*In January 2025, US President Elect Mr Trump acted the Plan States Representative when he assisted the UK Opposition Leaders extort the Remedy Delivery Commitments from the UK Cabinet. They were Dismissal Executions on Monday 14<sup>th</sup> July 2025 against the Judiciary by Parliament and then Victim Identification and Case Remedies. It needed a Trial Listing of a Framing Fraud on Thursday 17<sup>th</sup> July 2025 as a Demonstration Case. In the event of a Dismissal Success it would be used for Fraud Findings and Remedy Precedents that get Mass Publicity. In the event of a Dismissal Failure, it would be used for a Case Collapse that got a Network Collapse. The Demonstration Case was the Framing Fraud 2023 0058 against Citizen Mr Nkrumah. The Event Video on 1<sup>st</sup> December 2021 was Innocence Proof for him and Guilt Proof against the Fraud Conspirators. Video Compilation Frauds + Confidence Collapses by the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Investigators got Production Failures and Case Delays. The Case History was a Case Collapse Guarantee.*

*The Delivery Commitments by the UK Commitment Frauds. They had no intention of Remedy Delivery. The Trial Listing for a Delivery Commitment Pretence Fraud. They needed to stop the Case Collapse getting a Network Collapse. It needed a New Framing Fraud and an Arrest Fraud that stopped him leaving the court building a free man.*

*The Absolute Priority of the UK Cabinet was Epstein File Concealment. The Epstein Scandal was Sex Crimes + Protection Frauds + Sex Blackmail Frauds Business managed by Top UK Politicians for Top Financiers who were Election Campaign Contributors. They made Lord Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. He was the Obvious Choice. He was a Career Network Agent. The Network Loan Scandal and Passport Scandal got Cabinet Office Dismissal in 1998 and 2001. In 2006, Corruption Findings got a Dismissal Decision against Prime Minister Mr Blair. He was allowed to sign a 10 Month's Retirement Notice so that Notice Period and Leadership Contest could be used for an Integrity Investigation of the Governing Majority. It discovered more than half were Network Agents or Network Puppets. Prime Minister Mr Blair made a Leadership Deal that got Support Votes but No Profit Share for Candidate MP Mr Brown, Cabinet Office for Top Network Agents and Cabinet Control for the Network with No Profit Loss for Top Network Agents. Mr Mandelson was not an MP. Top Network Agent Status + Top Connections were enough to manage Business Expansion Plans before he got the peerage and Cabinet Office. One was Land Frauds for Big Owners against Small Businesses. Another was the Sex Blackmail Fraud Business. When he lost office, he managed the Business Expansion Plan for Child Trafficking and Land Frauds for Network Agents against the State. In 2025, the Corruption Exposure Risk Briefing by Ambassador Lord Mandelson got Trade Negotiations, Big Bribes for USA President Mr Trump, Protection Frauds for the Network and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. The Defence Sabotage Frauds failed to break Western Europe and NATO. The Judge Dismissal Failure + New Framing Fraud against Citizen Mr Nkrumah got Corruption Exposure against the UK Cabinet, the Forced Resignation of the Deputy Prime Minister and Ambassador Dismissal. It got Epstein File 2% Disclosure, the Mandelson Scandal and the Public Office Misconduct Investigation. President Mr Trump was desperate for Big Success used the Middle Eastern War Frauds and got a Big Failure. The Peace Plan States needed the Mandelson Evidence to bring him under control and get a Rapid Truce.*

The Mandelson Case is the Top Credibility Test of UK Authorities. Mandelson Case Evidence Offers got Evidence Rejection Frauds + Reference Refusal Frauds by All Tested Authorities. Mandelson has Criminal Liability for the Peace Plan Case Frauds. He gets Perverse Satisfaction from Trust Breaches. The Worcester Judges are nothing to him. The choice for the Peace Plan Case Managers is Just Remedies or Doomed Enforcement Frauds.
