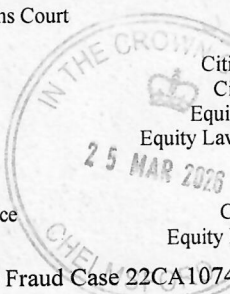

Reasons:

1. The Corruption Remedy Test Case uses Routine Bribery and Special Bribery. Routine Bribery has for decades bought Routine Protection Frauds for the Crime Business managed Crime Mangers for Crime Profiteers.
 - 1.1. The Test Case Businesses are the Drug Crime Business and the Health Frauds Business.
 - 1.2. Top Police, Top Customs and Top Judges manage the Drug Crimes Business and pay Protection Fraud Fees to the Protection Fraud Network. They use Police Officers as Distribution Managers and Drug Wholesalers for Bribe Money Laundering for Local Police + Local Child Protection Officers + Local Mental Health Officers + Local Judges. The Protection Frauds include Child Prostitution.
 - 1.3. Child Prostitution Protection Fraud Proof against Drug Wholesaler Mr Benjamin Koomson + State School Officers + Local Authority Child protection Officers + Essex Police + Metropolitan Police + Court Officers + Local Judges + Top Judges made Essex Police and Essex Law Courts an Obvious Target for the Routine Corruption Test Case.
 - 1.4. The Pharmaceutical Industry use State Officers, Profession Authority Officers, Law Court Judges and Corrupt Parliamentarians to manage Health Crime Business. Special Bribery bought Market Frauds for Drug Treatment against Non- Drug Treatment. Routine Bribery buys the Routine Management and Special Bribery buys Special Management. Special Bribery bought creation of Profession Authorities to manage Profession Governance Frauds against Non- Drug Health Professionals. One is the General Osteopathic Council. Routine Bribery bought the Routine Corruption. In 2000, Governance Fraud Complaints in more than 200 Constituencies got a Corruption Debate + Investigation Commitment + Pending Investigation Adjournment + Special Bribery bought Protection Fraud Bribe for Prime Minister Mr Blair + Investigation Denial Fraud + Special Bribery that became Routine Bribery bought Protection Frauds for the General Osteopathic Council ever since. It got Obvious Target Status for the General Osteopathic Council in any Corruption Remedy Process managed by the Top-Level Corruption Controller. It is the Coronation Oath Enforcement Authority.
 - 1.5. In 2004, the Preparations for the European Referenda got Election Fraud Proof against the EU Leaders. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds before the European Referenda in 2005. They made an Election Fraud Concealment Plan. Everything that could go wrong for them did go wrong. It got Criminal Conspiracy against them. Prime Minister Mr Blair was one of them. Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process for the UK and get a World War III Peace Agreement for Democratic States. The Plan Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Case Manager Status for the Coronation Oath Enforcement Authority. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement got Delivery Commitments some of which are conditional on Plan Successes. The Publicity Agreement got Plan Secrecy and Plan Success Publicity, without disclosure that is what they it is, until there is enough for Plan Publicity.
2. In 2023, King Charles used Endemic Corruption Proof against the Judiciary to get the Peace Plan Agreements and the Trial Fraud Proof against the Worcester Law Courts as Special Bribe Proof against Lord Mandelson and the Pharmaceutical Industry. It got Remedy Enforcement against the Pharmaceutical Industry to get the Damage Payments from the Contaminated Blood Scandal. In 2025, the Corruption Deal got Big Bribes for USA President Mr Trump Epstein File Concealment Frauds for the UK Cabinet and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. Fraud Failures got Self Defence Efforts that include the Iran War Frauds.
3. In 2026, the Mandelson Scandal got the Public Office Misuse Crime Investigation. The Mandelson Evidence Offer Test discovered use of Hertford Stop Failure Framing Fraud NX18MZP + Worcester Warrant Fraud 22CA1074323 + Essex Enforcement Frauds + Evidence Rejection Fraud + Evidence Reference Denial Fraud
