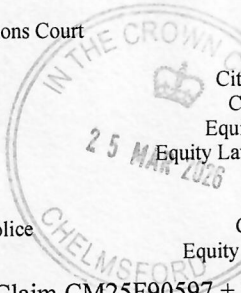

1. The World Leaders are interested in Harassment Claim CM25F90597 and Connected Cases. The Democratic Leaders who represent World War III Peace Plan States are interested because the UK has Corruption Remedy Test Case Status, the Coronation Oath Enforcement Authority has Test Manager Status and Harassment Claim CM25F90597, and Connected Cases, are Test Cases. The Other World Leaders know that Test Case got Confidence Collapses that are a Total Collapse Risk for the Protection Fraud Network. Harassment Claim CM25F90597 has Special Relevance.
2. Science Teacher Mr Benjamin Koomson is a Drug Wholesaler for the Protection Fraud Network. He operates from Dagenham. He provides the Bribe Money Laundering for Local Officers and Local Judges in East London and Essex. He prostituted the Chronically Immature Mother and in the autumn of 2014 used her to prostitute the 14 Year's Old Daughter. Underage Sex Questions by the Decent Father motivated Rape Complaint Fraud Blackmail Frauds by the Chronically Immature Mother and the Blackmail Complaint Statement dated 14th October 2024 by the Decent Father. Rape Complaint Fraud Victim Citizen Mr Antonakis Katsiaounis used it for an Additional Evidence Notice + Evidence Production Demand in Rape Complaint Fraud Investigation 01YE1544123. It got Case References from the Case Investigator up the Command Chain to Commissioner Rank Police. The Motive was that no one dare interfere with Child Prostitution Protection Frauds provided for a Network Drug Wholesaler who provided Local Bribe Money Laundering and could identify Top Money Launderers who could identify the Top Crime Profiteers. Commissioner Rank Police needed an Exposure Risk Control. The only thing they could do was make Case References that got Child Prostitution Protection Fraud Proof against Home Secretary Mss Cooper and Prime Minister Sir Keir Starmer.
3. In November 2024, the USA Elections got President Elect Status for Mr Trump. On the evidence available, he did not know the UK Cabinet was a Test Case Target or did know but did not understand the process. In January 2025, he acted a Peace Plan States Representative when he assisted UK Opposition Leaders used the Child Prostitution Protection Fraud Scandal to extort Corruption Remedy Commitments from the UK Cabinet. They were Dismissal Executions against the UK Judiciary on Monday 14th July 2025 by Parliament and then Victim Identification and Case Remedies. In the event of a Dismissal Success, they start on Thursday 17th July 2025 with use of the Essex Crown Court Trial Listing of Framing Fraud 2023 0058 for a Contempt Fraud Finding + Remedy Orders + Mass Publicity for the Citizen Father against the State and Law Courts. In the event of a Dismissal Failure, they started on Thursday 17th July 2025 with a Case Collapse that got a Total Collapse of the Protection Fraud Network.
4. The Delivery Commitments were Commitment Frauds. The Absolute Priority of the UK Cabinet was Epstein File Concealment Frauds. The Epstein Scandal was Sex Crimes + Protection Frauds + Sex Blackmail Frauds by Top UK Politicians for Top World Financiers who financed Election Campaigns. They made Lord Mandelson the Concealment Manager and made him the office of UK Ambassador to the USA. The Corruption Exposure Risk Briefing by Ambassador Lord Mandelson to USA President Mr Trump got Trade Negotiations. They got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the Protection Fraud Network and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO.
5. Delivery Denial Frauds needed to stop a Framing Fraud Collapse on 17th July 2025 getting a Network Collapse. It needed a New Framing Fraud for an Arrest Fraud that stopped the Decent Father leaving the court building a free man. The Harassment Claim Fraud CM2590597 + Family Contact Restraint Application Fraud by the Chronically Immature Mother + Restraint Frauds by the Family Court + Restraint Breach Complaints frauds 01KW1226225 + 01KW1237025 were the Set Up Condiutios for the Arrest Fraud + Imprisonment Fraud.
6. The Delivery Failures got Corruption Findings against the UK Cabinet + Dismissal Penalty against Prime Minister Sir Keir Starmer + September 2025 Corruption Publicity + Forced Resignation from the Deputy Leader + Forced Dismissal of Ambassador Lord Mandelson + Imprisonment Fraud Confidence Collapse by Judges + Imprisonment Fraud Bail Release for the Decent Father + Restraint Breach Framing Fraud Confidence Collapses and Unused Evidence Notices for All Prosecution Evidence by Crown Prosecutors + Child Care Service Requests by the Chronically Immature Mother + Bench Warrant Fraud 22CA1074323 of Essex Judges
