All Cases Best Advice + Polite Request is that filing and service of the State Visit of UK to USA + Private Chat Advice dated 1st April 2026 from the Equity Lawyer to King Charles gets Filing Acknowledgements + Service

Acknowledgements + Case References up the Command Chain for the REASONS:

1. The Common Law gets Relevant Evidence Status for the Private Chat Advice by All Authorities in All Cases
2. The Common Law needs use of Genuine Cases to get Relevant Evidence Status for Case Records that service the World War III Peace Plan and Just World Order.
3. The Jurisdiction Hierarchy is:
 - 3.1. The Common Law governs the Coronation Oath Enforcement Authority
 - 3.2. The Coronation Oath Enforcement Authority governs the Parliament Session Powers of the Crown
 - 3.3. Parliament governs the Law Courts
 - 3.4. The Law Courts govern the State and Profession Authorities
 - 3.5. The State and Profession Authorities govern the Individual
4. The Common Law requires the use of Valid Process in the Case Circumstances that identifies and eliminates the Greater Wrong at every stage of a Case Process until what remains is a set of one or more options that have Equal Risk and uses that for the Rights Declaration and Rights Enforcement.
5. The Valid Process identifies the Case Option that is a Damage Risk to the Biggest Potential Victim Class and works downwards via the Case Options that are Damage Risks to Progressively Smaller Potential Victim Classes until it discovers the Case Options that have the Smallest Potential Victim Class or No Potential Victim Class and uses that for the Rights Declaration and Rights Enforcement.
6. The Biggest Victim Class is to the People who worship the Good Will God, the Next Biggest Victim Class everyone affected by International War, the Next Biggest Victim Class is everyone affected by Civil War, the Next Victim Class is everyone affected by a Local Riot, the Next Victim Class is everyone affected by a Case Parties Brawl, and then continue with Valid Process until it gets a Rights Declaration and Rights Enforcement.
7. The World War III Peace Settlement had Fundamental Flaws. The Human Rights Declaration omits Case Priority Rights for the Victim and Citizen, and Top Corruption Controls for the People that are Credibly Independent of the State, Law Courts, Cabinet and Parliament. The omissions vested Case Priority Powers and Top Corruption Controls in the State. The Declaration Signatories gave and got Mutual Approval of Case Priority Powers and Top Corruption Controls for the State and used them to develop Dictator Powers for the State. They used Priority Rights for the Individual to manage Oppression Frauds against All Victim Classes up to the Biggest Victim Class
8. The Roman British Gnostic Christians developed the Decision Discipline to manage their relationship with God. They used it to develop the Common Law. They promoted the Common Law but not the Gnostic Christian. The result is everyone has heard of the Common Law but not them.
9. The Fundamental Flaws in the World War II Peace Settlement motivated the UK Gnostic Christians make the Equity Governance Recovery Plan. It used a Corruption Remedy Process for the UK to get the World War III Peace Plan that requires Democratic States to manage a Just World Order. The Risk Controls required the Citizen and Equity Lawyer to get Trigger Conditions for the Crown. Queen Elizabeth agreed it. She, Charles and Ann spent decades managing Routine Crown Responsibilities and identifying who among the Ever-Changing Set of World Leaders could be relied on to service the World War III Peace Plan in case someone got Trigger Conditions.
10. In 2004, the preparations for the European Referenda got Trigger Conditions and Immediate Service of the Crown.
11. Equity Lawyer Mr Ellis got the Proof Sets that in 2019 were used to get the Forced Resignation from Prime Minister Mrs May and Forced General Election. It motivated the Poison Kill Decision against the Equity Lawyer by Prime Minister Mr Johnson when he won the 2019 General Election. The Poison Damage included Progressive Low Blood Pressure. The choice for Regulated Doctors was Notice Nothing + Do Nothing, manage Mental Health Frauds to deprive the Victim of the Legal Capacity for Remedy Action, or Career Suicide by a True Diagnosis + Remedy Prescription. In 2022, Queen Elizabeth died. In 2023, the Equity Lawyer got completion of Endemic Corruption Proof Sets against the Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. On 6th January 2026 a Low Blood Pressure Total Collapse was on a Dialysis Treatment Day onto an Outpatients Dialysis Bed. Immediate Treatment avoided a Hospital Death. An Inpatient Admission got a Normal Blood Pressure Recovery + Hospital Release on Day 4. The National Transplant List Confirmation Letter dated Monday 23rd March 2026 from the Royal London Hospital to Equity Lawyer Mr Ellis, NHS Patient 6328556020, raises a Reasonable Presumption the UK Cabinet have stopped serving the Poison Kill Decision.
