All Cases – State Visit of UK to USA + Private Chat Advice for King Charles 1st April 2026

One Error Control requires the Adverse Criticism Risk to be taken by the Equity Lawyer and not by the Crown. Another Error Risk Control requires the Quiet Chat Advice of the Equity Lawyer to be in an Official Record. The Case Details on the Document Heading get Undeniable Official Record Status for the Quiet Chat Advice. Another Error Control is a Trial Order by the Crown for the Parliament Sessions Court of a Corruption Case of the People against the State or Unfitness Cases of the People against Officers or Authorities. It gets Trial Hearing Rights and Appeal Rights for the UK State with Representation Rights for the UK Cabinet. Another Error Risk Control is Adjudication Decision by the Trial Court, that get Decision Acceptance by the UK State, or a Decision Appeal by the UK State, and Appeal Adjudication by the Appeal Court. A Remedy Priority Finding by the Trial Court required Quiet Chat Advice Disclosure by the UK Cabinet and the Default Penalty of Quiet Chat Disclosure by the Crown. It got Decision Acceptance by UK Cabinet for the State or an Appeal Decision against the UK State. All of it is an Adverse Criticism Risk Control for the Crown. Do you want to know how that helps?

Charles Your First Presidency got Grateful Thanks from the Equity Lawyer for two major things. One was Forced Disclosure of the Tax Haven Estate Records. The other was the 2019 War Engagement Refusals. The Missile Strike by Iran got one. The Unexplained Emergency Evacuation of USA Troops from Syria to Iraq was another. The Decision Reason given by the Equity Lawyer was the need to avoid USA Casualties by Terrorist Missiles financed by UK Drug Crime Profits with UK Protection Frauds. The Quiet Chat Advice is to use the War Engagement Refusal in 2019, for Rapid War End and a Dignified War End in 2026. Do you want to know how that helps?

Charles The 2023 Peace Plan Agreement got Corruption Remedy Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority. It got Adverse Criticism Rights for the Peace Plan Signatories. The USA is one. It gets an Adverse Criticism Risk Obligation for the USA against the Equity Lawyer. Do you want to know how that helps?

Charles The Coronation Oath Enforcement Authority uses the Common Law. It requires the Evidence Balance to start with a Validity Presumption for the Citizen and Credibility Presumption for the State, both of which are subject to Rebuttal Proof Positive. Do you want to know how that helps?

Charles The Adverse Criticism Risk Obligation required the Equity Lawyer to use the Case Facts for Presumption Findings that require Rebuttal Proof Positive. A Presumption Findings Failure by the Equity Lawyer is an Incredibility Criticism Risk for the Equity Lawyer. Do you want to know how that helps?

Charles The Quiet Chat Advice is that you create Rebuttal Proof Positive against the Presumption Findings of the Equity Lawyer. He wants Presumption Rebuttal Proof Positive and Rapid Dignified War End. Do you want to know how that helps?

Charles The Presumption Findings are that a Corruption Exposure Risk Briefing by UK Ambassador Lord Mandelson got Trade Negotiations, a Treason Deal, Big Bribes for you, Epstein File Concealment Frauds for the Protection Fraud Network and UK Cabinet, and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO.
