1. The Honest Officer Recruiting Advice is very simple. It needs Just Management of Inferior Jurisdictions by Low Ranks to get Relevant Evidence that Superior Jurisdictions can use to manage World Peace. All Peace Plan Cases got Conflict Jurisdiction Disqualification Denial Fraud Proof + Conflict Jurisdiction Qualification Pretence Fraud Proof that Low Ranks can use for Conflict Disqualification Admissions + Remedy References to Higher Ranks.
2. When things go wrong, most people find it easier to have Problem Conversations and Remedy Conversations about 'them' than 'us.' The function of Jurisdiction Separation is to get Jurisdiction Enforcement by Jurisdiction Owners or Enforcement Failure Conversations that are more about 'them' than about 'us.' It is the same from bottom to top.
3. The Heads of the Peace Plan States need Jurisdiction Enforcement by Low Ranks that gets Remedy Delivery all the way up the ranks to Top Politicians who are Top Criminals and Remedy Delivery Targets. They are UK Protection Fraud Network Top Agents Mr Mandelson, UK Cabinet Officers Ms Yvette Cooper, Mr David Lammy and Sir Keir Starmer and USA President Mr Donald Trump.
4. The Chelmsford Family Cases CM25F90597 and 22CA1074323 + Enfield Case N00CL318 + Worcester Cases 22CA1074323 and 2026 0012 are excellent for the purpose. All of them got Criminal Conspiracy Proof that is Relevant Evidence for the Criminal Investigation of the Public Office Misuse Complaints + Treason Complaints against Mr Peter Mandelson. It is Relevant Evidence for the Public Office Misuse Complaints + Treason Complaints Cabinet Officers Ms Cooper, Mr Lammy and Sir Keir Starmer and USA President Mr Trump.
5. In 2023, King Charles used Endemic Corruption Proof against the UK Judiciary to negotiate the World War III Peace Plan for Democratic States. The Plan Agreement required Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement got Delivery Commitments, some were conditional on Plan Successes. The Publicity Agreement required Whole Plan Secrecy and Mass Publicity for Plan Successes without any disclosure that is what they are, and then Plan Publicity.
6. King Charles had lots of Old Corruption Proof. He needed that and New Corruption Proof for the Peace Plan Negotiations. The Old Corruption Proof included some against the Protection Fraud Network and Prime Minister Mr Blair who did not know about all businesses of the Protection Fraud Network until he had held the Prime Minister's Office for more than 7 years. He used Mr Peter Mandelson as a Market Fraud Sales Manager but did not know that Mr Mandelson was Business Expansion Manager for the Protection Fraud Network. £1,000,000 from Mr Bernie Ecclestone got the Tobacco Advertising Prohibition Waiver for Formula 1 Racing. It was a Marketing Tool. In 2,000, Profession Governance Fraud Complaints in more than 200 Parliamentary Constituencies got a Corruption Debate + Investigation Commitment + Pending Investigation Adjournment + Protection Fraud Bribery + Investigation Denial Frauds + Remedy Denial Protection Frauds by Parliament ever since. The Corruption Debate coincided with Baby Organ Scandal. The Genome Project got High Market Prices for Human Organs. Killer Doctors used Development Defect Proof for Genetic Defect Diagnosis for Abortion Advice Frauds to get the Abortion Material and if that failed Full Anaesthetic Caesarean Section Advice Frauds to get an Unconscious Period for the Mother and use of it for Baby Murders and Human Organ Thefts. The Baby Sunaina Chaudhari Case got a complete set of Development Defect Proof + Murder Proof. The Development Defect was the stomach in the Left Lung Cavity. Baby Sunaina survived the Natural Birth. It disproved the Genetic Defect Diagnosis. The Diaphragmatic Hernia Operation opened the chest, moved the stomach from the left lung cavity into the correct location below the diaphragm and sewed up. The Killer Doctors waited for the Health Baby Records and then continued the Murder Plan. Medical Records are the Murder Proof. State Records + Court Records are Protection Fraud Proof. Prime Minister Mr Blair sold Protection Frauds for the Profession Governance Frauds and Human Organ Theft Murders but did not know about the other Crime Businesses that were Network Customers.
7. Mr Mandelson got Cabinet Office in 1997, a Scandal Dismissal in 1998, Cabinet Office in 2001 and another Scandal Dismissal in 2001 Cabinet. In 2006, a Corruption Dismissal got a Dismissal Decision against Prime Minister Mr Blair. He was allowed to sign a 10 Month Retirement Notice. The Notice Period enabled use of the Leadership Contest for an Integrity Investigation of the Governing Majority. It discovered more than half were Network Agents or Network Puppets. A Leadership Deal got Support Votes from Prime Minister Mr Blair for

Candidate Mr Brown and Cabinet Office for Network Agents including Mr Mandelsons. No one wanted him as Constituency MP. In October 2008 he was given a peerage and Cabinet Office.

8. Mr Mandelson managed Business Expansion for the Protection Fraud Network. They were Performance Enhancing Drugs for Sports Professionals and Fitness Fanatics + Land Frauds for Big Owners against Small Businesses + Blackmail Fraud Business that used Support Services from Mr Epstein got by Minimum Sentence Protection Frauds from USA Authorities + Family Sabotage Frauds and Child Thefts that in 2014 the Network needed to avoid a Total Collapse + Land Frauds for the Network against the State.
9. The Performance Enhancing Drugs Expansion Plan needed Sabotage Frauds against Honest People who were an Exposure Risk. Citizen Mr Nkrumah was one. He and Mo Farro could beat each other at different distances. He had a BT Apprenticeship and was the Marketing Model for BT Apprenticeships. Stock Clearances Discount Sales by CD Shops got Trading Stock for Internet Sales + £5,000 Yearly Profits for Citizen Mr Nkrumah. One of the Business Priming Cases was a Copyright Theft Framing Fraud by Caucasian Officers against Citizen Mr Nkrumah. He thought Racial Prejudice was the Fraud Motive until 2025 revealed the Mandelson Scandal. The Community Status Proof for him is that he got the Young Black Vote in 2004 and 2008 London Mayor Elections for Mr Boris Johnson and the 2010 Parliamentary General Election for Mr David Cameron. The Land Frauds for the Network against the State needed a Big Business for a Priming Case. Housing Association Mergers got the London and Quadrant and a Big Business for the Priming Case. The Network imposed Service Conditions for Industrial Scale Frauds. They required Business Systems that serviced Evidence Exclusion Frauds. The Land Frauds included Housing Charity Asset Sales by Top Network Agents to the Housing Associations. Over the centuries many people founded Housing Charities for the Local Poor or Ethnic Groups or Religious Groups. The Land Fraud Plan for the Network against the State used Housing Stock Transfers from Local Authorities to the Housing Associations and Business Systems that destroyed the Title Evidence and replaced it with Forged Evidence before the Housing Charity Sale Frauds by the Network to Housing Associations. The Priming Case used many thousand Forged Tenancies. Forgery Complaints by Mr Nkrumah was an Exposure Risk. Protection Fraud Demands from Housing Officers and Cabinet Officers and Service Calls by the Judiciary got Framing Frauds + Profit Share Demands from Top Police. A Profit Share Refusal got a Pending Profit Share Service Refusal by Top Police. Good Case Management by Mr Nkrumah motivated Protection Frauds by Court Officers that got Service Refusals by Competent Police and Service Efforts by Idiot Police. The result was Paper Records + Electronic Records + Record Inconsistencies that were Forensic Test Material for Criminal Investigations. The Judiciary made an Investigation Sabotage Plan. It needed Paper Documents Theft + Electronic Devices Theft. Science Teacher Mr Koomson was the Network Drug Wholesaler and the Electronic Device Theft Agent. He prostituted the Chronically Immature Mother of the 3 Nkrumah Children and used her to prostitute the 14-Year-Old Daughter. The Blackmail Complaint Statement dated 14th October 2024 of Citizen Mr Nkrumah got Child Prostitution Protection Fraud Proof against All Relevant Authorities including the UK Cabinet. The Harassment CM25F90597 Restraint Frauds were Set Up Frauds for the Restraint Breach Framing Fraud
10. The Business Priming Case for Family Sabotage Frauds + Child Thefts was against Citizen Mrs Androulla Theodorou and her 6 Children. She got Corruption Proof Sets on average once a month for the 10 years from 2014 to 2024. King Charles used what there was in 2023. The Fraud Claim against Enfield Council got High Court Case Reference KB 2025 003110 + Seal Date 22nd August 2025 + Sealed Claim Service Denial Frauds + Transfer Order to Central London County Court + Case Number N00CL318 and a Case Transfer to Edmonton County Court and then Sealed Order Service on 9th March 2026
11. King Charles needed Recent Bribery Proof + Recent Court Fraud Proof that USA President Mr Biden could use to extort Damage Payments from the Pharmaceutical Industry for the Contaminated Blood Scandal. In 2023, the Worcester Cases got it. Bribery Management by Top Network Agents Mr Peter Mandelson and MP Ms Nadine Dorries got Profession Governance Fraud Enforcement by the Criminal Courts for the General Osteopathic Council and Pharmaceutical Industry against Citizen Ms Davies. The Case Details are in Many Documents. Trial Judges used Court Officers and West Mercia Police Officers as Fraud Agents with Crown Court Audio Records the Event Proof. Court Officers wanted Full Disclosure Immunity Deals. No Case Record Admissions by them for the Law Courts was Council Liability Forgery Proof for Citizen Ms Davies against the State. The Bench Warrant Forgery Appeal 22CA1074323 in Chelmsford Crown Court and the Bankruptcy Statutory Demand Revocation Refusal Fraud Appeal 2026 0012 in Worcester County Court to process the Fraud Conspiracy Proof against the State, Law Courts, Cabinet and Top Network Agent Mr Mandelson
